Dear Members of the City Council,

I am writing on behalf of the RESHAP (Rebuilding Existing Supportive Housing at Alameda Point) project team, Alameda Point Collaborative, Building Futures, Operation Dignity and MidPen Housing, to express our enthusiastic support for the addition of a library branch within the RESHAP community at Alameda Point. This initiative represents a remarkable opportunity not only for RESHAP, but also for fostering a vibrant new gathering space where our residents can engage with the broader Alameda Point and Alameda community.

The timing of this proposal is ideal, as infrastructure and site preparation work for the first RESHAP phase that could include this library branch commences this week. Integrating the library into the ongoing development will ensure it becomes an essential and well-utilized part of the community from the very beginning.

Current RESHAP residents have expressed a strong desire and need for accessible educational resources and community spaces to complement the current offerings. Since Fall 2023, City staff have collaborated with Alameda Point Collaborative (APC), MidPen Housing and the project architect DBA to explore the feasibility of a library branch adjacent to the RESHAP community. Community input gathered during APC and Building Futures resident outreach meetings held in April and May 2024 showed overwhelming support for the inclusion of a library branch. Residents identified a variety of programs and services that would draw them to the library, including public events, technology access, social services, study spaces, and a unique Tool Lending Library.

The preliminary plans for the 4,800-square-foot branch library include spaces dedicated to public events, quiet study rooms, tool lending, and a wide range of library materials. The library would be adjacent to the Barn, which will offer workforce development programs, job training, and educational programs operated by APC. These two spaces will be designed to provide efficient and complementary shared spaces that promise to enhance the lives of RESHAP residents and enrich the broader Alameda Point community. The proposed library branch's location on Pan Am Way adjacent to a bus stop and on the border of the Adaptive Reuse Area is a central and ideal location for this crucial amenity.

RESHAP aims to develop 7.9 acres of City-owned land into a trauma-informed campus with 332 units of affordable housing and numerous community initiatives. The addition of a branch library aligns perfectly with our goal to provide comprehensive support and resources to our residents.

To advance this project, we seek the City Council's direction to continue to partner with City staff, Friends of the Alameda Library and Library Board as they further develop the Alameda Point Branch Library design and identify funding sources.

We believe this branch library will greatly enhance the quality of life for RESHAP residents and serve as a valuable asset to the entire Alameda community. We look forward to your support and guidance in making this vision a reality.

RE:: Alameda Point Library – Agenda Item 7D

The League of Women Voters of Alameda (LWVA) urges the City Council to authorize the City to continue with the planning and development of the Alameda Point Library.

Since Fall 2023, City of Alameda (City) staff have been in discussions with Alameda Point Collaborative (APC) and MidPen Housing (MidPen) about a branch library in the RESHAP (Rebuilding Existing Supportive Housing at Alameda Point) development, located on Pan Am Way near W. Midway Avenue. The proposed 4,800 sf library includes space for public events, quiet study rooms, tool lending, and library materials. Development of an Alameda Point Library is part of the City's Strategic Plan.

The planned site is adjacent to the 332 units of affordable housing offering residents direct access to high value library programs, meeting space and workforce development. The proposed Tool Lending Library would complement proposed workforce development providing equipment for crafting, cooking, car and home repair and gardening. The space is easily accessible by other residential developments at Alameda Point and on an AC transit bus line.

The League supports a library system that meets the diverse needs of all Alamedans and increased funding for the expanded

programs and services. Despite predictions to the contrary the Alameda Library is heavily used by all ages and populations. The AP Library will reach new audiences and will be an attractive feature for businesses and residents who rent and purchase homes in the area.

The LWVA urges the Council to support this critical component in the development of Alameda Point.
