The complaint alleges that the defendants violated the Americans with Disabilities Act (ADA) and the Unruh Civil Rights Act and related statutes. Council authorized the City Attorney to enter into a settlement with the plaintiffs to fully resolve this case with respect to the City and have the City pay \$31,183 to the plaintiffs and to complete various remediation to the parking lot at Corica Park.
