# Dockless Bike Share Program

City Council May 1, 2018





#### Recommendation

Approve the continuation of the dockless bike share program with refinements and with a single bike share company; and

Authorize the Acting City Manager to approve in substantial form and release a request for proposals for dockless bike share and to negotiate and enter into an agreement and all necessary documents with the successful vendor.

#### Bike Share in Alameda

- Launched six month pilot on Oct. 5, 2017 with LimeBike
- Agreement:
  - No cost to City
  - 300 bikes
  - Parking allowed in public right-of-way and City parks
  - Defined where and how bikes must be parked





### LimeBike Program in Alameda

#### Agreement (cont'd)

- Safe & well-maintained bikes
- Educate users on riding rules
- 24-hour customer service number
- Minimum response times for correcting improperly parked or placed bicycles
- Monthly Reports with usage data

#### Finding 1: Well-Utilized + Broadly Supported


- 41,585 rides
- Highest one month = 10,000 in Oct. 2017
- Average = 297 rides/day
- 11,449 unique riders; 78% reside in Alameda; 6,400 have taken 2 or more rides



#### Finding 1: Well-Utilized + Broadly Supported

- Bikes used for work and school commutes and transit connections:
  - Weekday Peaks = 8-9am and 3-6pm
  - Top locations for bike pick up/drop off: Main Street and Harbor Bay Ferry Terminals
  - 21% of trips started or ended at transit
  - 39% of trips started and 27% ended, at major commercial area



#### Community Survey Top "Like" Responses:


- It helps reduce car traffic

#### Finding 2: Mis-Parked Bikes Are Top Issue

 Community Survey: 51% say "Bicycles are often parked poorly, blocking sidewalks, curb ramps or bus stops"





#### Finding 2: Mis-Parked Bikes Are Top Issue

- How Addressed During Pilot:
  - Education
  - Reporting in App
  - Collaboration with Private Property
    Owners
  - Staffing





#### Finding 2: Mis-Parked Bikes Are Top Issue

- Proposed for Moving Forward:
  - Set reasonable limits on, and organize, bike parking
  - Closely monitor and impose penalties, as needed





#### Finding 3: Youth Not Using Helmets

- State law requires all under 18 to wear helmet
- Community Survey: 29% say "Too many bike share users ride without helmets"





#### Finding 3: Youth Not Using Helmets

- How Addressed During Pilot:
  - Helmet Distribution
  - In app reminders
  - Increased minimum age to ride
  - Loopholes closed





#### Finding 3: Youth Not Using Helmets

- Proposed for Moving Forward:
  - Free helmets and safety education funded by operator

- Clear user info







# Finding 4: Administrative Oversight and Collaboration should be Enhanced

- Program administration requires staff time
- Enhanced monitoring needed





# Finding 4: Administrative Oversight and Collaboration should be Enhanced

- Proposed for Moving Forward:
  - Closely monitor and impose penalties, as needed
  - Impose some fees
  - Require more complete data
  - Regular operator check-ins





#### Transportation Commission Action (3/28/18)

Recommended Council approve staff recommendation, with following considerations:

- Allow 2-3 one-year extensions to agreement term.
- Ensure the security of personal data collected by operator.
- Consider using a performance bond for collecting fees.





#### Recommendation Details

- 1. Continue dockless bike share program
- 2. Make key refinements to program
- 3. Allow one operator
- 4. Two year contract





#### Recommendation Details

- 5. Use RFP process to select operator
- 6. Authorize staff to issue RFP and execute agreement with top ranked operator
- 7. Provide one-year update to Council





#### Recommendation Details

- 8. Pursue additional complementary strategies:
  - Install more bike racks
  - Continue and expand bike safety education
  - Monitor state of bike sharing
