Dear Mayor Spencer and City Council members,

I am writing to support a decision by the Alameda City Council to file a complaint with the California Fair Political Practices Commission regarding anonymous attack mailers sent during the Nov. 8 election season.

I was personally disheartened to see negative, inaccurate mailers attacking Council Member Daysog, particularly with regards to his vote on the Assisted Living Facility on Harbor Bay Isle. Council Member Daysog voted No on that project out of concern for senior residents and fact based concerns regarding airport noise. The mailer said the opposite. I was disappointed and dismayed by them, although they did follow the FPPC rules of identification.

However the anonymous mailers, also attacking Council member Daysog are actually illegal.

It will be difficult enough to counter the terrible messages from the President elect Donald Trump. Hope lies in local action and local communities maintaining standards of fact and decency where we have direct control.

I support a yes vote on filing a complaint with the FPPC.
