Dear Social Services Human Relations Board:

Crown Harbor is a small gated Alameda California community of 76 townhomes nestled along Ballena Bay, Crab Cove, and Crown Beach. Crown Harbor is a quiet, well-kept community on the San Francisco Bay, close to downtown Alameda's Historic Webster Street shopping, restaurants, post office, twice-weekly Farmers' Market, and much-anticipated seasonal events such as Concerts at Crab Cove, 4th of July Parade, and Neptune Beach Community Celebration.

Alameda Point Collaborative (APC) is a supportive housing community that uses all its resources to help families and individuals break the cycle of homelessness and poverty. They are the largest supportive housing provider for homeless families in Alameda County, and their wide range of services give residents the tools they need for long-term success. APC plans to develop the Alameda Medical Respite and Wellness Center on the Federal property adjacent to Crown Harbor. Doug Biggs, APC Executive Director, is presenting to the board on April 26, 2018.

Though Crown Harbor residents are not unsympathetic to the plight of the homeless, we (along with other neighboring communities) have some concerns about APC's proposed site.

- **Increase in Crime**

The concern for crime is backed up by experiences of Crown Harbor residents who visit or work in San Francisco.

The increase in crime is often not the result of the homeless but a criminal element that invades the area to prey on the homeless. As is the case in San Francisco, the concern is that the Alameda Police Department will be inundated with calls that they cannot respond to.

- **Noise Pollution**

As was demonstrated when Alameda developed Jean Sweeny Park, Persons with serious health, drug, or mental issues (as is associated with many homeless) sometimes create noise of shouting, fighting, and screaming.

- **Proximity to Schools**

A facility on McKay Avenue would be near Montessori, Paden Elementary, and Encinal High schools. Mixing children with persons with serious health, drug, or mental issues is ill-advised.

- **Improved Support for Veterans**

Many of Alameda County's homeless are veterans who have served our country. Alameda Point is slated to have a Veterans Hospital. In appreciation of their service, closer proximity of the facility to the Veterans Hospital would offer symbiotic benefits. Would it possible for the City to do a swap of the McKay Avenue site with a site near the Veterans Hospital?

- **Maintenance of McKay Avenue Infrastructure and Facility**

McKay Avenue, its sidewalks, and its trees are in poor condition – not up to City code. Lacking the funds, APC thinks the long-term maintenance and disposition of the infrastructure is a topic for all of the property owners on that avenue to work on. Can this issue be resolved before APC's application is approved?

- **Lack of an Open Process**

The Department of Health and Human Services has conditionally approved the project, and the Environmental Analysis (EA) is already in progress yet opportunities for public comment have not been available. When the EA comes back with a Finding of No Significant Impact, there will be no need for a full Environmental Impact Report, and thus, no opportunity for public input. Public review serves as a check on accuracy in analysis. Public comments inform agencies about public opinions and values. We are grateful that Alameda Social Services Human Relations Board is collecting public input.

- **Stakeholder Advisory Groups Have No Impact**

Although APC is establishing an advisory group, there is no guarantee that advisory group feedback will be considered in a deliberative manner and timeframe. There is nothing in writing, (e.g., City Council minutes, public hearing) that defines what is or is not allowed at the facility.

There is one concern that is specific to Crown Harbor.

- **Water Pollution**

The Federal property adjacent to Crown Harbor has an easement where drainage from that property flows into Crown Harbor drains, so anything that flows from the facility (e.g., medical waste) directly impacts Crown Harbor.

Along with some Crown Harbor residents, there are residents city-wide who are concerned about Crab Cove itself.

- **Ignoring the Will of the Voters**

Alameda County and Contra Costa County residents have the expectation that 7.5 acres of surplus Federal properties are designated for the East Bay Regional Parks District based on the passage of Measure WW in 2008 by 72% of the Contra Costa and Alameda County voters. To date, only 3.89 acres have been used for Crab Cove expansion. The parcel map attached to Measure WW clearly includes the land that the Federal government is handing over to APC.

- **Homeless Loitering or Encampment**

Though APC notes that the facility is not a homeless shelter but a respite center, the concern is that the McKay facility will attract the homeless, not from patients being treated by the medical facility, but those waiting to make use of the resource center. Homeless are already camping and sleeping at nearby Crab Cove. Discarded needles litter the path.

As a representative body for our community, we are pleading with you to help us address these concerns.



We have filed an Initiative Measure to be Submitted to the Voters rezoning the McKay Avenue remaining federal buildings parcel to Open Space consistent with the super majority vote of the Electorate in 2008. This should be considered with Item No. 3-A 2018-5502 Presentation Regarding Alameda Medical Respite and Wellness Center (McKay Avenue Project).

1. In 2008, East Bay Regional Parks District submitted **Measure WW** to the voters of Alameda and Contra Costa Counties.
2. This Measure was supported and or endorsed by the Alameda City Council, the SF Chapter of the Sierra Club, the League of Women Voters, Doug Siden, Ayn Weiskamp, and many others.
3. A number of projects were identified to be the beneficiaries of the funds raised by WW. They included **Project 18**.
4. During the campaign for Measure WW, the federal land on McKay Avenue, Alameda, the subject of Project 18, was a single parcel identified as Alameda County Assessor's Parcel No. 74-1305-026, 7.57 acres.
5. After the passage of Measure WW, the federal government split the land the voters had pledged for expansion of Crab Cove, into two parcels, **Alameda County Assessor's Parcel Nos. 74-1305-026-1, approximately 3.899 acres and 74-1305-026-2, approximately 3.671 acres.**
6. A residential development was attempted by Tim Lewis Communities on the Alameda County Assessor's Parcel No. 74-1305-026-1.
7. The voters responded by filing, circulating and qualifying an initiative rezoning Alameda County Assessor's Parcel No. 74-1305-026-1, to Open Space. The City Council thereupon adopted the initiative and rezoned the parcel to Open Space to comply with the voters mandate.
8. The federal government is trying once again to subvert the will of the voters and taxpayers to obtain authorization for reuse of Alameda County Assessor's Parcel No. 74-1305-026-2, approximately 3.671 acres for other than Parks and Recreation.
9. The voters have responded with a Second Initiative to rezone this Second Parcel to Open Space. This Initiative has been filed with the elections official and is undergoing review at this time.
10. The proponent of the Presentation Regarding Alameda Medical Respite and Wellness Center Homeless, APC, has already received 10 acres for the homeless at Alameda Point, and currently shelter 500 homeless persons in 200 units. Alameda had 204 homeless at the last count. There is room for a Medical Respite and Wellness Center at this location which is within a short walking distance of and has a view of the SF Bay.
11. It would be appropriate to defer further review or recommendations for reuse of Alameda County Assessor's Parcel No. 74-1305-026-2, until after the election which is contemplated by the electors at this point.

1. Measure WW. Extend Existing East Bay Regional Park District Bond With No Increase In Tax Rate -- East Bay Regional Park District (2/3 Approval Required)

To continue restoring urban creeks, protect wildlife, purchase/save open space, wetlands/shoreline, acquire/develop/improve local and regional parks, trails and recreational facilities, shall East Bay Regional Park District be authorized to issue up to \$500 million in general obligation bonds, provided repayment projections, verified by independent auditors, demonstrate that property tax rates will not increase beyond present rates of \$10 per year, per \$100,000 of assessed valuation?

2. Arguments For Measure WW from Voter's Handbook

Vote Yes on Measure WW to protect and preserve our East Bay Regional Parks. The East Bay Regional Park District (EBRPD) is widely considered to be one of the most successful examples of integrated parklands in any urban area in America. With Alameda and Contra Costa Counties' populations growing rapidly, Measure WW is needed to preserve our vanishing open space, available parklands, and shoreline.

Measure WW extends the existing parks bond measure passed by voters in 1988. The 2008 bond extension will not increase your taxes. It has bipartisan support. The original 1988 ballot measure made possible our current system of parks, thousands of acres of protected open space, and hundreds of miles of trails throughout Alameda and Contra Costa Counties. All of the revenue from 2008's Measure WW is local and will stay in our two counties to protect and preserve our parks. 25% of the revenue will fund city parks and recreation departments. 75% will fund regional park acquisitions, open space preservation, new parks and trails for walking, hiking, and biking, environmental maintenance, the rehabilitation of aging park facilities, and wildlife habitat restoration.

Measure WW is also crucial for environmental sustainability. The vegetation in our Regional Parks absorbs the same amount of carbon dioxide that is produced by over 80,000 cars. Voting yes on WW will help us fight global climate change at the local level. Measure WW will also help protect and renew our urban creeks and ponds, which will enhance the quality of drinking water for our communities. A citizen's oversight committee will ensure that Measure WW's funding is spent as promised. Measure WW has something for everyone. 




Map No.2 of Salt Marsh and Tide Lands (Case 1 Dr.6-26)



To Whom It May Concern,

We are writing to request further analysis and express our concern regarding the Medical Respite and Wellness Center that is proposed on McKay Ave. As new residents to this area, we are all in favor of providing services to those in need. The proposed services are quite needed and worthy. However, we moved from our beloved Lake location in Oakland to escape the transient presence on our doorstep in favor of our current peaceful and clean location. I work in the mental health/service sector and have a 2 year old daughter who we want to expose to various ways of life and different realms of society. However, we also want to be careful about how much and how distressing this exposure may be. If this center is established here, we are concerned that this area may become a space for increased traffic in general, increased transient community loitering/littering and possible disturbance of peace. We are further concerned about the health, safety, and well-being of our daughter, and other children who walk on this street every day. Where we lived in Oakland was nearby a half-way home and other services that were providing good things to the transient community but we would frequently encounter intoxicated, high, and mentally unstable personalities on our street which added stress to our already busy lives. This is in addition to the increased noise pollution from emergency responders almost daily.

Will there be guaranteed security on McKay making sure people are being safe? Will there be increased security near our McKay St. Park Webster Garage entrance? Will there be additional loiterers near the Crab Cove Visitor Center? Will McKay Ave. become a much busier street? We walk down this street everyday to get to the park/visitor center.

We would like you to consider these questions and add that we are strongly against this plan. We are proposing that another space in Alameda be used for this site. For example, there are numerous property spaces on the old military base. Or somewhere more centrally located on the island that others nearer to the East side/Bay Island can also easily access? It may also be good to have this site near a medical facility or closer to the fire station.

I also grew up in Alameda on Gibbons near Edison School and went to Edison, Lincoln, and Alameda High. I am currently a Master's in Public Policy student at UC Berkeley with a focus on homelessness and I spent the prior 4 years working as a case manager with former foster youth, many of whom were homeless.

I am writing in sincere support of the McKay Avenue project. Not only will this project provide much needed housing and services to our city and region, but it will be a positive addition to our community and reduce blight in the area.

This is a concrete way for our community to contribute to the regional homelessness issue and address homelessness, which is at the top of the City Council's priority list.

I understand that many individuals have expressed concern about loitering or traffic in the area and as a young woman and a neighbor who frequently walks in this area, I want to express that I do not share these concerns at all. I also think that these concerns come from a place of fear and misunderstanding.

Homeless seniors face dying alone on the street and to attempt to squash a project to provide a space place for them to access services indoors in the name of not having to see people who are 'different' is not what Alameda should be about.
