Action: This is a lawsuit filed by plaintiffs Lula Burton and Robert Preston against defendants the City of Alameda and Wellington Tong for a trip and fall incident on August 7, 2020; Ms. Burton claimed she suffered injuries after tripping on a raised portion of the sidewalk at 1373 Versailles Avenue; Plaintiffs brought a complaint alleging 1) Negligence; 2) Premises Liability; 3) Dangerous Condition of Public Property; and 4) Loss of Consortium; to avoid the expense and uncertainty of litigation, the City Council ratified/authorized the City Attorney to settle the matter, with no admission of liability by the City in an amount not to exceed \$77,000.
