INCREASE TO SALARIES IN ACCORDANCE WITH CITY CHARTER

CITY COUNCIL SEPTEMBER 5, 2023

BACKGROUND

Timeline

- 2018: Mayor appoints subcommittee to review Charter
- 2019: Subcommittee makes recommendations including revisions to Mayor and Council compensation
- 2020: Council approves placing an amendment on the November 2022 Ballot
- 2022: Council approves language to place on the November 2022 Ballot for voter approval citing goal of encouraging greater/more diverse pool of candidates
- 2022: Voters approve council compensation measure with 53.97% of voters approving amendment

Current Language

 Mayor and Councilmembers' salary shall be set by resolution at an amount not-to-exceed 30% of the salary for "All Occupations, United States Bureau of Labor Statistics, Occupational Employment and Wage Statistics, San Francisco-Oakland-Hayward"

• Current Salary Limit: \$28,311

- 2022 Occupational Employment and Wage Statistics published in April 2023
- 2022 Annual Mean Wage for "All Occupations" in the San Francisco-Oakland-Hayward region: \$94,370

BACKGROUND

Staff selected five Alameda County Cities to survey base salary and total compensation.

- Base Salary vs. Total Compensation
 - Councilmembers have historically not utilized City benefits
 - No member of the Council in recent years has received the maximum total compensation above (\$37,622 – \$40,022)
 - Encourage a greater and more diverse group of people to run for office

RECOMMENDATION

• Set the Mayor's salary to the maximum allowed by the Charter, \$28,311 annually; and set the Councilmembers' salary at 67% of the Mayor's, \$18, 896 annually.

Basis for Recommendation:

- Provides a meaningful increase to base salary to encourage a greater and more diverse pool of candidates to run for all Offices
- Setting the Mayor's salary slightly over the median at the maximum now accounts for expected changes to the median prior to the next election
- No further action required of Council prior to the next election to remain within median of survey cities
- Ratio of Mayoral to Councilmember salary based on median ratio of surveyed cities
- Consistent methodology for job classes within the City

Cost

• Total Annual Cost: \$105,700

Increase to FY 24 Budget: \$97,200

ALTERNATIVE

• Set the Mayor's annual salary at the median of survey cities, \$25,503 annually; and set the Councilmembers' annual salary at the median of survey cities, \$15,876 annually.

• PROS:

- Lower annual cost than recommendation
- Provides an increase to base salary to encourage a greater and more diverse pool of candidates to run for all Offices

CONS

- Provides less than Alameda minimum wage to Councilmembers (based on 20 hours per week)
- Median likely to increase in the next two years

Cost

• Total Annual Cost: \$90,300

• Increase to FY 24 Budget: \$81,800

ALTERNATIVE

 Set both the Mayor and Councilmember salaries to the maximum allowed by the Charter, \$28,311 annually.

• PROS:

- Provides the greatest benefit to encourage a greater and more diverse pool of candidates to run for all Offices
- Setting the salary over the median now accounts for expected changes to the median prior to the next election

• CONS:

Most expensive option

Cost

• Total Annual Cost: \$143,600

Increase to FY 24 Budget: \$133,100

NEXT STEPS & RECOMMENDATION

- Adopt by resolution the staff recommendation, an alternative, or another salary decided by Council.
- Staff recommendation to increase the Mayor's salary to the maximum allowed by the City Charter, \$28,311 annually; and to increase the Councilmembers' salary to 67% of the Mayor's salary, \$18,968 annually beginning at the start of this fiscal year 2023-2024, July 1, 2023.
