Dear Alameda city council,

Forcing a ceasefire on both sides in Gaza is not a neutral position, it is what Hamas desperately wants now. Adopting a resolution like that is tantamount to siding with Hamas, the perpetrator of the October 7th massacre, who started the war. Hamas will use it to restore its power and cause another war in a few years.

The city of Alameda should concern itself with making life in the city better for its residents, not with foreign policy. It does not have the necessary context or expertise to do so. On the Israeli side, some towns have seen a constant barrage of rockets aimed at civilians, each one is a explicitly targeting civilians. No country or civilian population should be made to live in such conditions.

I urge you to avoid any calls for a ceasefire.

I hope this message finds you well and in good health. I am writing to you as a concerned citizen, and, more importantly, as a proud American Jew deeply invested in the values that underpin our democracy. My commitment to these principles stems from a firsthand understanding of the harsh realities of anti-Semitism, having fled as a refugee from the former Soviet Union.

The recent draft letter from Mayor Ashcraft to the senator has raised significant concerns within our community. As a staunch believer in the constitutional duty of state and local governments to safeguard public safety, I am troubled by the potential ramifications of the divisive tone in the letter. It is essential that our local leaders promote unity rather than contributing to the escalating tensions.

To provide context to my concerns, I have included an impactful speech by Majority Leader Chuck Schumer (https://www.youtube.com/watch?v=dleBosgap4U). This speech not only sheds light on the fears haunting the American Jewish community due to rising anti-Semitism but also offers a fair historical background of Jewish people in the United States, Europe, and the Middle East.

Turning to Mayor Ashcraft's letter, my worry is that it inadvertently adds to the division within our community, placing Jews, a marginalized and mostly unprotected group, under further scrutiny and risk. According to FBI statistics, there has been an alarming over 300% increase in antisemitic incidents since October 7, 2023. Furthermore, an unsettling 50% of hate crimes in the United States target American Jews.

I feel compelled to address the call for a ceasefire mentioned in Mayor Ashcraft's letter. While advocating for peace is noble, it is crucial to understand the intricacies of the situation. Hamas broke the ceasefire on October 6, 2023, and again on November 24, 2023, even as Israel awaited the release of additional hostages. Israel proposed another ceasefire in December of 2023, but Hamas refused to cooperate. Simply calling for a ceasefire without delving into the complexities may inadvertently support terrorism and undermine the security of both Jews and Palestinians.

Moreover, it is disheartening to witness the lack of awareness about the ongoing threats faced by Israelis, particularly in the wake of recent events. Rockets fired by Hamas at midnight on December 31, 2023/January 1st, 2024 at midnight, during New Year celebrations, highlight the gravity of the situation. Most Israelis now sleep in shelters since October 7, and children take turns physically going to school to ensure sufficient shelter space during bombings. Israeli parents grapple with the challenge of protecting their families, with older children and teenagers fearing to stay home alone.

The media often fails to portray these daily struggles, contributing to widespread misinformation. It is crucial to recognize that Israel has invested significantly in protecting its citizens through the construction of bomb shelters and the Iron Dome. In contrast, Gaza lacks shelters, and Hamas misuses funds intended for humanitarian aid and infrastructure development for destructive purposes.

It's essential to address the misrepresentation of Israel's actions in preventing humanitarian aid from entering Gaza. Contrary to media portrayals, Hamas is responsible for stealing humanitarian aid, including crucial supplies like food and medications. Tragically, Gazans are exploited as human shields in various aspects—physically, morally, and psychologically—manipulating global sentiments against Israel. This distortion is not only unfair but also morally unjust. It's imperative to shed light on these nuanced details to ensure a more accurate understanding of the situation.

If we genuinely want to contribute to the well-being of both Israel and Gaza, it is imperative to call on the American Government to condemn Hamas and support efforts to dismantle it. Then, rebuilding Gaza into a prosperous and peaceful region should be a collective goal, benefitting local citizens and welcoming tourists from around the world.

While international affairs merit attention, I implore you, as a representative of our local community, to concentrate efforts on addressing the rising antisemitism within Alameda. The fear and anxiety among our Jewish residents are palpable, necessitating immediate and targeted actions to ensure their safety.

In closing, I trust in your moral compass and expertise to address these pressing issues at the local level, thereby fostering a community that upholds the values of inclusivity and tolerance. Let us work together to combat hate and promote a harmonious environment for all residents.

Dear Mayor Ezzy Ashcraft and Councilmembers Vella, Spencer, Daysog, and Jensen,

I write you today as a concerned constituent and resident of Alameda over the referral for an item to call for a ceasefire in Gaza. I have read the Mayor's proposed letter and while I appreciate the effort to propose a balanced perspective, I still worry it sends a message that will be ineffective globally and still have a profound negative effect in your community.

I have spoken before council before on issues like policing in support of the Black Lives Matter movement, but I write today rather than speaking for concern of putting my face before the community on this issue. I am Jewish, and while I have always believed in the importance of using my white-passing skin to speak up in defense of other minorities, today it is my people at risk, and I fear publicly standing before council and making myself a target for hate. I do not say this lightly as two short months ago I gave a speech in Germany where I spoke of the personal effects of antisemitism, pogroms, and the Holocaust on my life and the history of my family. I was commended by the German audience for my bravery, but I returned to my own country and found fear amplified. Mixed in with legitimate criticism of Israel, its actions and its policies has been a freshed voice of antisemitism. I shuddered thinking of how just a few years ago a literal torch-wielding mob in Charlottesville chanted "Jews will not replace us!" while our then-president called them "very fine people." These same attitudes have seen this conflict as an opportunity to once again amplify antisemitism, commingled with criticism of Israel, to make it clear that Jews should feel unwelcome in this world and in our communities.

I hope you can appreciate that I had no fear standing before a German audience speaking of the personal effects and history of antisemitism and the Holocaust, because I trust in the cultural contrition and acceptance of the German people. I spoke to an audience of science education professionals in Jena, Germany, where historical markers along the road through the city identify the trail where my people were marched to their deaths. Yet while I trust the children of those who attempted the extermination of my own people to be understanding and empathetic, I write to you rather than speaking up publicly because I no longer feel safe as a Jew in my own community and country in the here and now.

I will agree with anyone the situation between Israel and Gaza is tragic and nuanced. I have long been critical of Israeli policy towards Gaza, I have done what I can to speak up in American Jewish communities and supported individual Palestinians through charity. I have criticized the corruption of Israeli government officials and the brinksmanship that has pushed us to the current situation. But on October 7th, Hamas led an unforgivable attack. More Jews—not just Israelis but global visitors—were killed in a single day than any day since the Holocaust. And not just killed, but brutally tortured, abused, raped,

mutilated and kidnapped all while Hamas gleefully filmed and broadcast this footage to the world. Perhaps you have already read the New York Times investigation published last week into the sexual violence committed by Hamas on that day and to hostages since—if not I would implore you to do so.

I write to you because I beg of you to not support a call for unilateral ceasefire. While I believe in peace as a goal in this world and mourn the deaths of innocents anywhere, we must also recognize the horrific cruelties executed against Jews on October 7. We must recognize that hostages are still being held and tortured by Hamas and their agents. We must recognize that the death toll was amplified in this conflict by Hamas' own sacrifice of civilians that they refused to let evacuate or placed in front of their weaponized positions. We must recognize that the last ceasefire was broken by Hamas' own terror attacks in Jerusalem and their inability or unwillingness to continue releasing Jewish hostages in exchange for Palestinian prisoners under the terms of the ceasefire. We must recognize that Hamas' leadership has unapologetically vowed they will abide by no ceasefire and will continue their daily barrages of rockets to Israel and have promised to repeat the attacks of October 7th until the Jewish people are eliminated. We must recognize any such ceasefire would be one-sided and asks for Jews to stand by idly and accept the kidnap, rape, torture and murder of our people—of our children—rather than stand in self-defense and attempt to rescue them. Jews have not been in a position of self-defense since we were colonized by the Roman Empire 2000 years ago, and for this inability to defend ourselves we suffered cruelty after cruelty culminating in the genocide of nearly half of our population just 80 years ago, from which our numbers are only just now recovering.

I feel for the children of Gaza too. Just as I see my own child in the reports of child hostage and victims of Hamas, I see how my Muslim and Arab friends see their own families in the Palestinians. But we must recognize it is the cruelty of Hamas that prompted this and Palestinians can never be free while they are themselves held prisoner by the leadership of Hamas, who protect themselves in opulence in Qatar and Turkey while they sacrifice their own people to increase their wealth and clout.

Not long ago Oakland adopted a resolution calling for a ceasefire, and after some debate also refused to condemn the actions of Hamas or call for the release of hostages. Not long after the hanukkiah menorah at Lake Merritt was vandalized, one of the most public displays of antisemitism, but far from the only one as anti-Jewish graffiti has lined streets and storefronts in Oakland, San Francisco and elsewhere following anti-Israel demonstrations. Regardless of the legitimate concern for the Palestinian people, antisemites have used this as an opportunity to shield themselves and their hate, making it public how they also want American Jews to feel unsafe and unwelcome in our communities. I am deeply concerned your letter on behalf of Alameda will also increase the public hate against my family and Alameda Alameda families like mine. I felt this fear putting out Hanukkah decorations on my lawn this year and remain haunted by it, concerned the mezuzah on my door will invite vandalism, robbery or attack—but I cannot and should not have to hide my faith and heritage out of fear.

Neither Israel nor Palestine can know peace while Hamas is in power, just as the United States could not know peace in the time of the Confederacy. Hamas is not an organization prepared for or interested in good governance, and the Palestinian people deserve better as well. They too deserve a society where women and minorities will have equal rights. Where people can be free to practice their own faith and express their true selves and their true loves. Hamas believes in none of the values of diversity and inclusion. The road to peace will be in the reconstruction of Palestine after this war, and that is where I believe we should apply our global pressure, into supporting generous rebuilding of Palestine and the support of education and resources to help Palestine flourish into the state its people deserve and not one held captive by cruel terrorists and profiteers.

This is where I urge you to use your political power. Not to encourage Israel to abandon the hostages still held captive and capitulate to the terror of Hamas, but to encourage a vision for a peaceful Israel and Palestine of the future where the states can functionally coexist.

I will close by saying I have long been a proud American. I long believed that the assimilation of my people into American culture was our best path forward for survival. I have believed that even growing up being shamed, mocked and excluded because of my beliefs and heritage. But lately I have though much about Germany at the dawn of the 20th century. In Berlin and Hamburg, rabbis proposed that the diaspora was the necessary fate of Judaism, that we were to be diffused into the world to serve other nations rather than be entitled our own, and that the romantic, intellectual culture of Germany made it as much our Promised Land as anywhere could be. These rabbis founded the Reform movement in Judaism that I grew up in. Within a few short decades, the intellectual liberalism of Germany was replaced with the cruel misguided populism of Naziism, and six million Jews would be enslaved, worked to death, and murdered. Both my and my wife's families emigrated from Mogilev, Belarus, where in 1941 Nazi military police rounded up the remaining Jews in the city and unceremoniously murdered them.

I fear these same rising tides of antisemitism, I fear this country I thought was the hope for our people will descend into the same hate. Every Jewish family has known the fear of finding swastikas spray painted in their neighborhoods or near our houses of worship for decades—and now we fear repeats of the mass shootings that have already happened at American synagogues. I fear how the combination of antisemitism with anti-Israel policy makes clear that those who hate Jews believe we do not belong anywhere on this Earth, deserving neither our own state, nor to be welcome among the other nations of the world. Those who see this as the opportunity for our extermination are eager for governments and public officials to give them the perceived license to act on their hatred.

I implore you, do not encourage Alameda to be such a home to hate, but to be a beacon of hope and a safe haven for refugees. If you must speak for ceasefire please do so as individual private citizens, not as the voice and leaders of our city.

Dear Alameda City Council,

I am a history professor whose area of specialization is fascism in the 1930s, as well as on postcolonial/decolonial issues and historical trauma in South Africa and Vietnam. I am also the daughter of Holocaust survivors. I know from my parents' experiences what it means when the city one has lived in one's whole life decides your existence is not worth protecting and starts passing laws or resolutions that target your racial, ethnic and religious identity. If you pass a highly charged resolution on foreign issues - such as Israel and Gaza - issues that fall outside your purview - you are actually engaging and fomenting state sponsored antisemitism. This is not the role of city governance. My parents understood from horrible personal experiences that governments should not target a minority community, which is why they became so involved in the civil rights movement.

Whatever your personal political beliefs, you are betraying your government responsibilities if you prioritize them in your work as a local city council member. Nothing you vote on in Alameda will actually have any administrative or legal impact on the conflict or on the US Federal government's policies. Rather, the primary impact of your political action is fomenting division within your own community, which as an elected official you have been entrusted with protecting. You are also de facto condoning the targeting of Jews by any one else in our community who would see the resolution as affirmation or permission. It is abundantly clear that increased level of antisemitic incidents are already dangerous. Since October 7, they have risen 400%. Antisemitic attacks were already rising at an alarming rate before this conflict began. Jews experience the most religiously targeted hate crimes of any other group, far outnumbering the second-largest category of religious hate, anti-Muslim crimes. Stores and businesses owned by Jews are being vandalized in our city. Synagogues have had to increase security and limit access to their buildings as advised by the FBI which tracks such threats. Students in schools and on campuses are increasingly isolated and scared. You should know that all Jews have experienced threats, loss of friendship and loss of business.

If you choose to pass a resolution on an overseas conflict, one that would clearly condemn Israel alone or would question its legitimacy as a nation, you are communicating to your Jewish constituents that they are not really part of your community. They have a "special status." You would be deliberately targeting the Jewish population, who are also your constituents and live in your city alongside many other ethnic, racial and religious groups. You would be doing so, knowing full well that the vast majority of Jews support Israel's right to exist and regard its security as intrinsically connected to our own safety as individuals and as a community that has suffered genocide. Jewish history is marked by centuries of discrimination and repeated attempts to annihilate it throughout the world. You would be turning a deaf ear to the fear and emotional distress that YOUR Jewish community is experiencing right now.

Adopting any resolutions on foreign policy, particularly when it impacts a protected class of citizens, is beyond the role of the Alameda City Council. The role of the City Council is to set "...goals and priorities for the City. The council approves the City budget, adopts ordinances to help the City serve its community members, and appoints members to various boards and

commissions."

The current crisis is incredibly complex with deep historical and geopolitical roots in the Middle East. Again, whatever your opinions/beliefs on such matters, passing a one-sided political resolution goes far beyond your role as City Council members and should be kept separate from Council business - otherwise you are indeed knowingly participating in state-sponsored discrimination and targeted antisemitism. Israel is an important and central part of Jewish religion and identity for the overwhelming majority of Jews - whether you approve or not. I cannot think of any other racial, religious or ethnic group that is not allowed to define what constitutes hatred of its own people. What other minority has the terms of its own discrimination dictated to them? Who decided Zionism is Racism? What other minority is repeatedly told what is and is not racist discrimination targeting them? I can't imagine doing that to any of my friends who identify as Black, LatinX or Asian... I can't imagine dismissing the rights and belief system of any religious, racial or ethnic community with whom I have so long worked alongside as an ally.

Once again, I urge you to respect your role as an elected official who represents your community, ALL of your community. Passing a resolution unilaterally condemning Israel and denying its right to exist will not further the cause of peace. It will not promote more dialogue and understanding of our shared humanity. It will sadly not protect innocent Palestinian civilians. It will only further foment further division, hate and antisemitism in our community.

Item 10-D on the January 2 City Council Agenda should NOT be considered, let alone passed.

I am writing as a concerned member of our community to urge you to support Mayor Ashcraft's letter calling for an immediate ceasefire in Gaza (agenda item 10D). The recent escalation of violence has resulted in tragic loss of life and widespread suffering for innocent Palestinian civilians, and it is imperative that our city council takes a stand for peace and humanitarian values.

Ceasefire is a safety issue. The ongoing war in Palestine makes many of our community members less safe, including Palestinians, Arabs, Muslims, and Jews. In Alameda, our unofficial motto is "Everyone belongs here," yet we are hearing that Palestinian, Arab and Muslim community members are afraid of being doxxed or losing their jobs for attending events or speaking out in solidarity with Palestinians. The images and reports of civilian casualties, including children, are deeply distressing. It is clear that a lasting solution can only be achieved through diplomatic efforts and a commitment to dialogue. Our Congresswoman Barbara Lee has signed on to the congressional ceasefire resolution and was courageous in her disavowal of the war in Iraq. Endorsing a ceasefire in Alameda not only follows her leadership, but adds constituent weight to her position and adds our city to the growing list of municipalities taking a moral stand.

Ceasefire is a local issue. <u>US Campaign for Palestinian Rights</u> estimates that Alameda taxpayers give \$1,115,883 to fund Israel's violence against Palestinian people. Those tax dollars could be coming back into our community for needed services. Additionally, Alameda is home to hundreds of union members and community members whose unions and community organizations have endorsed an immediate ceasefire.

I understand that international conflicts are complex, and our local government may have limited influence on global affairs. However, by taking a principled stand, Alameda can contribute to the collective voice advocating for peace and the protection of civilian lives.

I appreciate your attention to this matter and trust that you will consider the urgency of the situation. I look forward to hearing about any actions our city council may take to address this critical issue.

Dear City of Alameda Council Members,

As a person that visits the City of Alameda for shopping, recreation, and official business, I highly recommend that the Council **not pass** a Ceasefire Resolution concerning the war in Gaza. Or if you decide to pass such a resolution that it not one-sided and divisive, and place the blame for the current conflict where it belongs - on Hamas. My reasons are as follows:

- i) The City Council does not have unlimited time, resources, and stamina to deal with the multiple critical issues in Alameda [crime, homelessness, housing issues, infrastructure repair, all forms of hate (racism, anti-semitism, islamophobia), and public health, to name a few], so I believe concentrating your efforts on these regional issues would be a more beneficial use of your valuable than officially commenting on the Israel-Gaza conflict.
- ii) The **history** of Israel, Palestine, and the entire Middle East is complicated. So complicated that without appropriate and unbiased information, it is easy for people to become antisemitic, islamophobic, anti-Israel and/or anti-Arab.
- iii) If the Alameda City Council passes a ceasefire resolution, many people will assume (without ever reading it) that it agrees with unbalanced ones passed by other cities, which I believe will only inflame and re-traumatize our impacted communities.
- iv) In 2005, Israel withdrew all Israel citizens and military personal from Gaza, leaving the Palestinians in Gaza to determine their own destiny. Soon after, Hamas (which is an internationally recognized terrorist organization) gained control of Gaza, and several military conflicts between Israel and Gaza ensued. Since the Hamas took control, there have been many ceasefires (six I believe), all of which were broken by Hamas. So I believe another ceasefire would only defend Hamas and let it regain its strength to attack Israel again. Both Palestinians and Israelis (Jews and Arab citizens) deserve a chance to determine their destiny without the interference of Hamas.
- v) Alameda residents can directly contact their elected officials (President, Vice-President, and US Congress members) to express their opinions on international policy.
- vi) I agree with a statement of the Jewish Community Relations Council (JCRC) which I am paraphrasing here:

As a local resident, I am writing to urge you to vote in favor of item 10-B during the Alameda City Council's Jan. 2 meeting. Neither city residents nor locals who frequently visit Alameda want animal experiments conducted in their backyard. Patients need human-relevant research – not cruel, crude animal testing.

An ordinance that prohibits animal experiments on public land would show that Alameda supports ethical, science-driven research. An enormous body of scientific evidence raises serious concerns with the continued use of animals. And researchers are increasingly moving away from animals for testing drugs and developing treatments.

Today, 95 percent of drugs that pass animal tests fail in human trials. Instead, devices called tissue chips, which use cells from human organs and tissues, are proving to effectively mimic the responses found in the human body. Pharmaceutical companies are quickly expanding their use of these modern, human-derived methods.

In disease research, the use of animals is also failing to develop suitable treatments. In 2012, Dr. John Ioannidis of Stanford University wrote that it is "nearly impossible to rely on most animal data to predict whether or not an intervention will have a favourable clinical benefit-risk ratio in human subjects."

In addition, federal rules related to the welfare of animals in laboratories are weak and poorly enforced. Despite its name, the federal Animal Welfare Act allows all forms of animal experiments—including those that inflict pain. And the U.S. Department of Agriculture, which is supposed to enforce the law, has been repeatedly cited by its own inspector general for unnecessarily closing investigations and significantly reducing fines for violators.

The U.S. National Institutes of Health has its own rules related to the conduct of animal experiments, but they are mostly recommendations and never appear to result in fines or other punishments—even in cases of animal deaths or severe negligence. NIH's method of "enforcement" is written correspondence between a violating institution and the agency. NIH does not conduct animal welfare inspections.

Allowing animal experiments on public property would endorse a poorly regulated, scientifically antiquated system. In contrast, prohibiting such experiments on city land would be a win for patients and animals.

Please support item 10-B during your Jan. 2 meeting.

I hope this message finds you well. After thoroughly reviewing the proposed letter addressing the situation between Hamas and Israel, set to be sent to Senator(s) on behalf of the City of Alameda, I feel compelled to express my concerns regarding its content.

While I appreciate the initiative to condemn violence and seek a ceasefire, it appears that the letter may unintentionally overlook crucial aspects of the conflict. It is imperative to acknowledge that both the U.S. government and the Israeli government have been actively pursuing a ceasefire, but Hamas has consistently rejected these efforts. In addition, the existing ceasefire was broken by Hamas on October 7, and this pattern repeats with each attempt at peace.

In discussing the tragic consequences of wars, it is vital to recognize that Israel did not initiate the current conflict or any previous ones. Despite facing challenging circumstances, Israel is striving to protect uninvolved civilians in Gaza. Regrettably, when efforts are made to evacuate civilians from combat zones, Israel faces accusations of ethnic cleansing or genocide if uninvolved civilians are being killed in the combat zones.

I want to highlight some significant considerations often overlooked in the discourse. While calling for a ceasefire is a noble cause, we must also consider the potential aftermath. The international community has previously contributed substantial funds to aid the Gazan population, but concerns persist about how these funds are utilized by Hamas. Forcing a ceasefire on both sides in Gaza is not a neutral position, it is what Hamas desperately wants now. Adopting a resolution like that is tantamount to siding with Hamas, the perpetrator of the October 7th massacre, who started the war. Hamas will use it to restore its power and cause another war in a few years.

Here's what the mayor of Berkeley had to say about a Gaza resolution put before his city council:

"Berkeley Mayor Jesse Arreguin told me his city has no plans to consider a resolution on the conflict, no matter what activists demand. Personally, he would like to see all the hostages freed, a pause in fighting and a two-state solution pursued. But he said the city won't be "bullied" into weighing in. At a recent meeting, he said, "we had people literally going to the bathrooms, banging on the walls to try to make noise and disrupt our meeting. It was pretty rowdy."

"We're going to continue to do the people's business," he told me.

Council members will continue to speak out on their own, but Arreguin said the city won't use "taxpayer resources in a public meeting to do that when we have public safety issues, homelessness, a housing crisis."

"I don't think Berkeley passing a resolution is going to change the outcome of the conflict," Arreguin told me. "I don't think Benjamin Netanyahu or Hamas is going to change their thinking on the basis of what the city of Berkeley does."

Wait, is this the same Berkeley City Council that has made its thoughts known through resolutions on international issues for decades, from the Ukraine-Russia war to the Iraq War to apartheid in South Africa?

"I think a majority of Berkeley was opposed to Russia's war in Ukraine. We oppose the war in Iraq, we oppose apartheid in South Africa," Arreguin said. "But there are divisions within the community about what's happening in Israel and Gaza."

Arreguin said he is concerned about the rise in both Islamophobia and antisemitism.

"I think my responsibility as a mayor is to focus on ensuring the safety of the community,"

Arreguin said. "Unfortunately, resolutions like this are not are not productive and are going to create further division and create an environment where not everyone feels safe."

I hope this message finds you well. After thoroughly reviewing the proposed letter addressing the situation between Hamas and Israel, set to be sent to Senator(s) on behalf of the City of Alameda, I feel compelled to express my concerns regarding its content.

While I appreciate the initiative to condemn violence and seek a ceasefire, it appears that the letter may unintentionally overlook crucial aspects of the conflict. It is imperative to acknowledge that both the U.S. government and the Israeli government have been actively pursuing a ceasefire, but Hamas has consistently rejected these efforts. In addition, the existing ceasefire was broken by Hamas on October 7, and this pattern repeats with each attempt at peace.

In discussing the tragic consequences of wars, it is vital to recognize that Israel did not initiate the current conflict or any previous ones. Despite facing challenging circumstances, Israel is striving to protect uninvolved civilians in Gaza. Regrettably, when efforts are made to evacuate civilians from combat zones, Israel faces accusations of ethnic cleansing or genocide if uninvolved civilians are being killed in the combat zones.

I want to highlight some significant considerations often overlooked in the discourse. While calling for a ceasefire is a noble cause, we must also consider the potential aftermath. The international community has previously contributed substantial funds to aid the Gazan population, but concerns persist about how these funds are utilized by Hamas. There is a history of financial assistance being diverted to build tunnels

and procure weapons, with not even ONE shelter built for the Gazain civilians, which exacerbates the cycle of violence. It is essential to explore avenues beyond a mere ceasefire to genuinely support the people of Gaza and address the root causes of the ongoing conflict.

Moreover, other options should be taken into consideration when trying to help the Gazain population. The Egyptians, for example, who have a border with Gaza, can accept refugees for the time being, or the countries of the Arab League, which support the Palestinians in every conflict with Israel, could invite the Gazain population into their countries until the war ends. Let's work towards freeing Gaza from the grip of the terrorist organization of Hamas.

In light of these concerns, I respectfully request a reconsideration of sending the proposed letter. The listed bullet points underscore the need for a more nuanced and comprehensive approach that may better serve the cause of peace and the well-being of all those affected by the conflict.
