The police auditor report reveals that in 2022 Alameda Police pointed a weapon at 14 people but in 2023 Alameda police pointed a weapon at 40 people, Over this last year Alameda Police pointed a weapon 185% more often they the year before. Alameda police policy 300,4 Deadly Force Application includes 300.4.2 Display of a Firearm. At the community meaning on military equipment it was asked how many of these incidents involved an AK-15. The answer was not provided. The department should provide that answer and continue to provide it in each annual report.
