Board Member Kanji moved to accept the Consent Calendar. Board Member Battle seconded the motion, which passed with a 5-0 vote.

B. Seed & Tool Library (T. Amarasiriwardena)

Vice President Amarasiriwardena presented possible design concepts for the Seed & Tool Library and shared the current status of the project. Next steps include forming a subcommittee and a survey will be done.

The Friends are working on changing the name of the Café. They had a retreat last month which generated a renewed energy.

D. Patron Suggestions/Comments (Speak-Outs) and Library Director's Response

A patron complained about a staff member's shirt being offensive. Acting Director Romero responded that the library does have an informal dress code and plans to start enforcing it. The staff member was unaware that the text on their shirt was offensive.
