SUPPLEMENTAL INFORMATION

Alameda Housing Authority entered into a Subdivision Improvement Agreement for the completion improvements associated with Tract 8561, the first phase of the anticipated three phase development of the North Housing Site at 501 Mosely Avenue. The Subdivision Improvement Agreement is a recorded document and requires a City Council resolution to formally accept the completed improvements and remove the potential title cloud on the property. The initial staff report published for the September 16th City Council meeting did not include a resolution.

The Item 5-H recommendation is amended to be adopted by a resolution accepting the public improvements completed by the Housing Authority of the City of Alameda (Housing Authority) for Tract 8561, North Housing – Phase 1.
