Hello:

This week you will hear from staff on the mid-cycle budget review. There are a number of items that I'd like to express support for and some I'd like to raise concerns about.

Overall, I, and many others in Alameda, want to see budget investments in programs and positions that provide care and support to our community; not punishment or policing. Having a budget surplus is an opportunity to set priorities for Alameda that reflect our community's values. Here are some of those values well-expressed:

- Addition of a Community Development Program Manager for homelessness. We should absolutely be spending money to ensure all people in Alameda can be housed and safe.
- Additional funds for the CARE team. You should support AFD's request for additional positions and resources, ***but only if the focus is placed on training and support that removes APD's presence on CARE team calls.*** I strongly support the addition of funds to Alameda Family Services' contract as well.
- Addition of resources to Public Works to administer parking enforcement. It's a step in the right direction to see this responsibility now falling under Public Works instead of APD.

Here are a few places in the staff presentation that DO NOT express Alameda's community values:

- The request for a Deputy City Attorney/Prosecutor position in the Prosecution Unit of the city attorney's office. You should oppose the addition of this position. According to a recent [Mercury News](#) article, more than half of this unit's cases from 2021 have been DUIs, low level drug offenses, disturbing the peace charges and court order violations. Out of 111 resolved cases, 54 were dismissed and just 39 resulted in convictions. The fact that we, as a city, would reject a city librarian position yet approve \$191,000 for a role whose sole responsibility it is to criminalize poverty and struggle (and not all that effectively), is outrageous. There is ample evidence, some shared with you by other community members, about low-level prosecutions doing virtually no good and only causing harm. Say no to this!
- The addition of a Lieutenant position within APD and various of APD's contract requests. In particular, if we're moving towards Public Works enforcing parking, why would APD need money for contracts related to this enforcement? Also, there have been countless issues around APD's communication and PR apparatus. We should not be spending more money on APD comms contracts. APD does not need additional resources, as they have demonstrated time and again that they cannot be trusted to keep our community safe. The optics alone on giving APD more money when a crew of them just got away with murder is pretty disgusting.

Please consider the great opportunity you have during this mid-cycle budget review and make recommendations that will support care-giving, life-affirming service delivery in our city.

Dear Honorable Mayor and Council Members,

I appreciate the opportunity to provide input to the City's mid-cycle budget process, and I am writing to comment in advance of tonight's Budget Workshop for Fiscal Year 2022-23 Mid-Cycle Budget Update.

Alameda is in an enviable position going into this second year of the budget with a significant surplus. I believe that surplus should be focused on programs that care for our city's most vulnerable, particularly as citizens continue to struggle our way out of this pandemic. The funds should be spent exclusively on programs that make our community better, not those that focus on criminalization.

Specifically, I strongly support the following staff recommendations:

- Addition of a Community Development Program Manager for homelessness.
- Additional funds for the CARE team. I support AFD's request for additional positions and resources and request that a focus be placed on training and support that allows for the phase out of APD's attendance on CARE team calls. I also strongly support the addition of funds to Alameda Family Services' contract.
- I support the addition of resources to Public Works to administer parking enforcement, taking this off APD's plate.

I have the following concerns with staff's recommendations:

- I oppose the addition of the Deputy City Attorney/Prosecutor position in the Prosecution Unit. According to a recent [Mercury News article](#), more than half of this unit's cases from 2021 have been DUIs, low level drug offenses, disturbing the peace charges and court order violations. The city's priority for \$191,000 should not be on a role whose sole responsibility it is to criminalize poverty and struggle.
- I oppose the addition of a Lieutenant position and request that greater scrutiny

be applied to APD's contract requests. Traffic enforcement for example, does not need to be housed within APD, and the city should be exploring alternative service delivery models, similar to what was done with parking enforcement. Also, there have been countless issues around APD's communication and PR apparatus. We should not be spending more money on APD communications contracts.

In summary, I request that the Council direct staff to focus use of the surplus on community services and not criminalization. In particular, APD does not need additional resources, as they have demonstrated time and again that they cannot be trusted to keep our community safe.

As you are likely well aware, I am a staunch opponent of the Emergency Housing project proposed for my neighborhood in the Big Whites and other residences.

I believe my rationale is well-reasoned, however, there is at least one more reason that I believe the project is inappropriate--that is regarding potential fiscal mismanagement. I also believe there may be a potential issue of housing discrimination also described below.

I am very concerned that this "pet" project is being put forward by City special interests without regard to the above concerns as well as the others I have previously mentioned. The City has a responsibility to follow the law, and unless all these concerns are properly addressed, the citizens of Alameda cannot be assured that the City is actually following the law.

I am writing because I hope that you will refer this to the City Manager and City Attorney--if appropriate--to follow up on the issues I bring up here as I believe these issues should be investigated.

ISSUE 1. RE fiscal mismanagement

You are probably familiar with the Navy EDC and the constraints therein. It is my understanding that, according to the EDC, the neighborhood is supposed to be a revenue-producing area to generate income to be put back into repair and maintenance for Alameda Point. Therefore, it follows that any project that impacts that ability is in opposition to the EDC.

Regarding the Emergency Project, for the City to "Farm" this neighborhood for a City project that is not revenue-producing, thereby reducing the ability for Alameda Point to "pay for itself", it appears to me to be an obvious case of fiscal mismanagement, a violation of the EDC --and potentially a violation of the Alameda Municipal Code.

As a corollary, there is the issue of breach of fiduciary duty as the City has a duty to maintain and market in good faith each rental as well, in order to generate revenue for use in Alameda Point, just like they do with the commercial properties here. This brings up my next point:

An additional --and just as important--cause regarding fiscal mismanagement could be made due to withholding the properties off the market for so long as they otherwise they would be revenue-generating. (in contrast to "city-owned FACILITIES" which are

taxpayer funded, and are those that are appropriate to use for City projects).

Lisa Maxwell even admitted the City has intentionally withhold the homes from the market, and further admitted the homes are usually rented immediately once on the market.

Is the City using the Emergency funding source monies to replace the lost rental revenue so it goes directly back into the Alameda Point coffers? If so, the City has yet to show that is the case.

The fiscal impact the Project has had so far is very large- (and it hasnt even yet begun)-- using my estimates below (which may not be exact), the City has foregone about \$25,000 every month the six homes (from the May 3 presentation) are vacant. Money that is desperately needed to maintain and repair these homes.

In addition to the homes "tagged" for the Emergency Project, there are 3 other homes that are sitting vacant and are not being readied for occupancy.

There is another Big White and 2 Ranch homes that have been siting vacant at least since January which would bring in an additional \$10k/ month),

That makes the total for these vacant homes **about \$30,000 loss of revenue each month these are not rented.**

As follows:

2815 Newport (~\$4K+/mo @1 year)=\$50,000
2825 Pearl Harbor (~\$4K/mo @ 9 mos)=\$36,000
2845 Pearl Harbor (~\$4K/mo @11 mos)=\$44,000
2700 Lemoore (~\$2700/mo @9 mo)= ~\$25,000
2821 Barbers Point (~\$3K/mo @ 6 mos)=\$18,000
2601 Barbers Point Unit D (~\$2700/mo @ 6 mo)= ~\$16,000

BW on San Diego=(~\$4K/mo @ 4 mos) = \$16,000
2 Ranches =(~\$3K/mo @ 4 mos)= \$12K + \$12K = \$24,000

Therefore as of the end of May, by these estimates, the City has *intentionally* foregone about **\$225,000 in lost revenue (and ticking at \$30K per month for the 9 vacant homes).**

That makes no fiscal sense to me. In my opinion, there needs to be an investigation into the management of these assets. Someone needs to be held accountable.

ISSUE 2. Housing Discrimination.

The Navy EDC requires these houses be used for residential use to be available for all Alamedans and are likely subject to fair housing laws. It seems to me that by withholding these homes from the market for availability for ALL Alamedans, the City is potentially subject to a housing discrimination lawsuit. I believe this issue should also be looked into due to the potential risk of a major lawsuit.

Please follow up on these issues or otherwise direct me the appropriate department so I can proceed myself in order to get these questions answered.

Dear Mayor Ashcraft, Vice Mayor Vella, City Council Members and Staff,

I am writing to you tonight about your budget meeting on May 10th, 2022. In the proposed budget you have allocated NO funds to the repair of Emma Hood Pool. Members of the community and swim community turned out in numbers to ask you to please match the funds that the school district is allocating in their passage of Measure B next month.
