A. Introduction of New Library Director, Mike Eitner

Director Eitner started with the Library on April 30, 2024. He introduced himself to the Board and the Board welcomed him.

B. Introduction of Community Outreach Specialist, Connie Dixon, and Development Manager of Housing and Human Services (HHS), Marcie Johnson

Development Manager Johnson gave an overview of the HHS department which is under the City Manager's Office. Community Outreach Specialist Dixon introduced herself to the Board and shared the various services provided to community members and library patrons that are in need of certain resources. She also works with library patrons that have been suspended for violating the Library's Behavior Policy, to ensure they understand why they were suspended and when they are allowed to return. Development Manager Johnson told the Board they can advocate for the continuation of funding for the Community Outreach Specialist position.

C. Current and On-Going Library Activities

Supervisor Romero updated the Board on the current and ongoing library activities since the last board meeting.

D. California Freedom to Read Act (AB 1825 Muratsuchi)

Director Eitner provided background of Assembly Bill 1825. In July, there may be an update for the Board to determine if they want to take a position.
