I am writing to express my strong support for the single pool option in Alameda. I understand that this is a complex issue with many stakeholders. However, Alameda already has multiple small pools, including Encinal and Emma Hood. Alameda does not have a 50m pool. This is a generational opportunity for us to not just replicate existing community assets but expand them. A 50 meter pool would meet the needs of a broad cross section of the community. Nor does the 50 meter pool need to be at odds with family usage. There are plenty of examples of 50 meter pools that can be sectioned for family usage, activities, lap swimming, and other usage. In short, the 50 meter pool gives us everything we want (except warmer temperatures, which could be managed.). The smaller pool forecloses significant and valuable activities and deprives multiple stakeholders of opportunity.

Finally, it seems clear that there is enormous demand for more aquatics access and infrastructure in Alameda. I urge the city to consider how it might put another pool either at the Jean Sweeney site or elsewhere to adequately meet this demand and need.

Good evening Chair Alexander, Members of the Commission, and City Staff

My name is Liz Warmerdam and I have lived in Alameda for almost 3 decades. All 3 of my kids have gone to AUSD schools and I have worked in local government over the course of my 25 year career. My apologies for not being able to deliver these comments to you in person.

I am also writing to you as a Board Member of Alameda Backyard Growers (ABG). Briefly, ABG is a local non-profit that teaches and supports people growing their own food. We also pick excess fruit from neighbors' trees and deliver it to the Alameda Food Bank. Since 2011, we have picked over 65,000 lbs of fruit that otherwise would have gone into the landfill.

Since it's inception, ABG has been involved in the development of Jean Sweeney Open Space Park. You may not know this, but back in 2013, when it was first imagined, the park included a 2 acre community garden. ABG, together with Supervisor Wilma Chan, and countless volunteers, spent hundreds of hours to design the garden that would include garden plots for residents, an education space, a self-pick community fruit orchard, a pollinator garden, toolsheds and a composting area. In July of 2016, the City Council approved the JSOSP Plan and it included the community garden.

When the first phase of the park was developed, it did not include the community garden for financial reason. We were told at that time that it would be included in later phases of development. Fast forward to the present day, that next phase of the park has arrived!

When it looked like the community garden space was a good location for the proposed Aquatic Center, ABG was asked how we felt about changing the garden location to accommodate the new project. The ABG Board voted to support the relocation if the community garden could be included in the Aquatic Center Project.

Make no mistake, ABG and the entire Alameda urban farming community still expects the community garden to be built. More and more people in Alameda are concerned about food insecurity and turning to their backyards (if they have one) to grow their own food. We are constantly asked how people can get involved and unfortunately, we have no place to direct them.

We see it through our mailing lists, attendance at our workshops, and the small donations we receive from Alameda residents. Alamedans care about the environment and they want to make changes in their lives to be more climate resilient. That includes planting and pruning trees, growing their own food, creating pollinator gardens, etc. What better place to make that a reality than through a community garden, especially for the 55% of our residents who don't own their home and have no place to farm.

As you can imagine, we are extremely disappointed that there is no community garden in the concept plan you see tonight.

Madam Chair and members of the Commission, you can make sure the community garden gets built.

In your recommendation to the City Council, include an additional recommendation that directs staff to find the money and build what was promised: a Community Garden at JSOSP.
