There were no changes to the Draft Minutes of the November 13, 2024 Library Board Meeting. Board Member Strickler moved to accept the Consent Calendar. Vice President Kanji seconded the motion, which passed with a 5-0 vote.

# **REGULAR AGENDA ITEMS**

A. Current and On-Going Library Activities

A total of \$26,518 in processing fees have been removed from accounts between January and November 2024. Includded in the \$26,518 are \$5 processing fees, \$2 library card replacement fees, and \$10 collection fees. All three locations remained open during the tsunami warning. The city kept staff updated. Director Eitner was required to report to the City's EOC in case it became a bigger issue. The Behavior Policy is being presented for approval because guidelines are needed for how patrons are expected to behave in the Library. The policy also outlines the appeal process.

Board Member Strickler moved to approve the Behavior Policy. Board Member Battle seconded the motion, which passed with a 5-0 vote.
