Overview

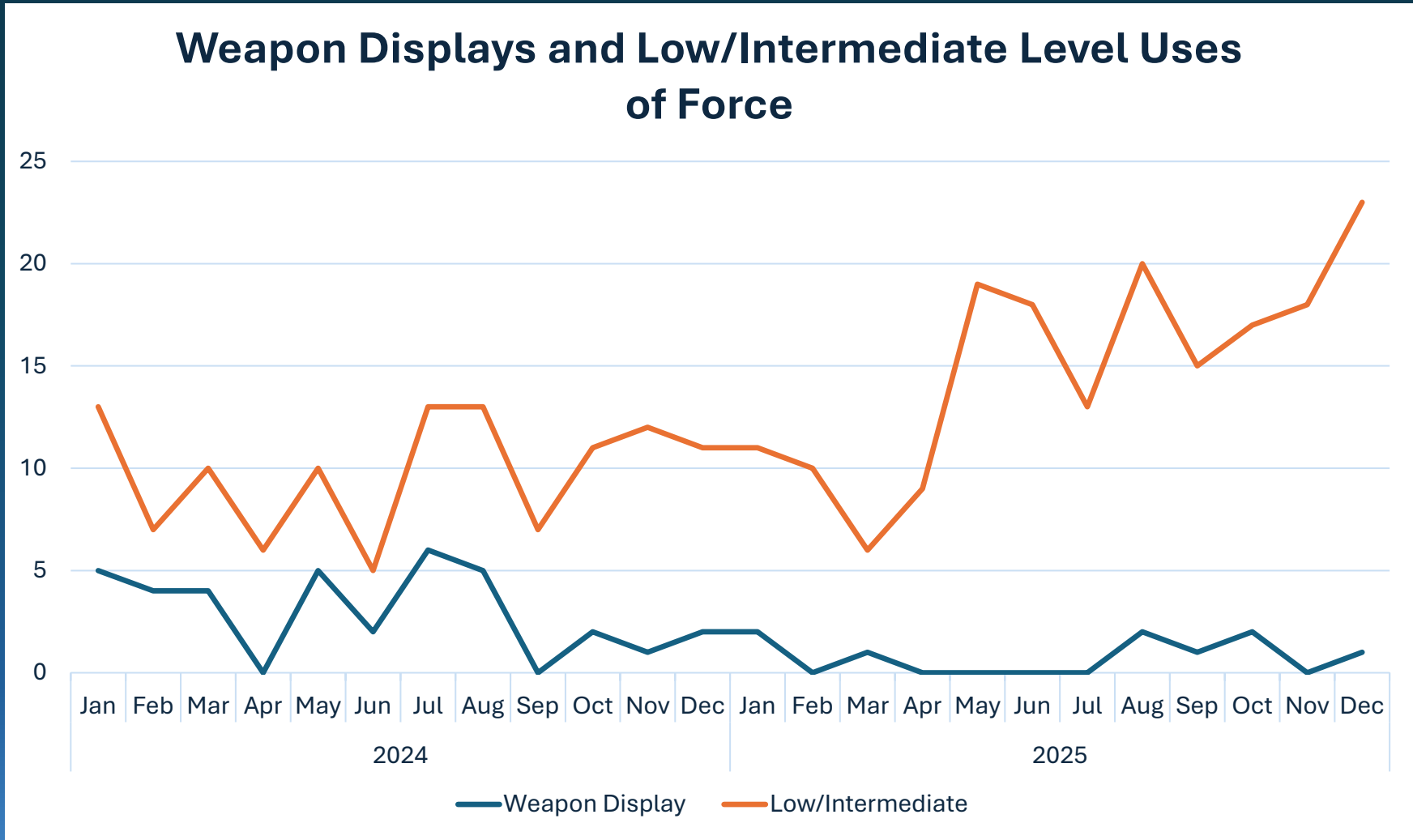
- Increases in internal affairs investigations, use of force, and arrests.
 - No data to indicate an increase in misconduct. Rather, there has been a continuing effort to increase reporting. Sustained percentage has decreased.
- In 2025, there was an 89% increase in traffic stops and a 49% increase in other stop types.
- For any race, traffic stop outcomes are a fairly even split between citations and warnings.
- Staffing numbers have remained steady over the past three years.
 - Professional staff positions are typically fully or almost fully staffed.
 - Sworn staff numbers fluctuate slightly but a 25% vacancy rate remains.

- Serious Alleged Violations
 - Use of Force – 18 cases
 - Bias-Based Policing – 15 cases
 - Truthfulness – 2 cases
- Examples of Sustained Violations (the allegation was substantiated)
 - Firearms safety
 - Conducting unsatisfactory investigations/work product
 - Conduct towards others
 - Wearing of safety restraints
 - Body-worn camera
- Most internally generated complaints were generated by a supervisor based on comments made by a member of the public during a police interaction.
- For 2024, all 35 cases have been closed. 34% (12/35) have at least one sustained allegation.
- For 2025, 48 of 59 cases are closed. 19% (9/48) have at least one sustained allegation.

Use of Force - Types

Descriptions

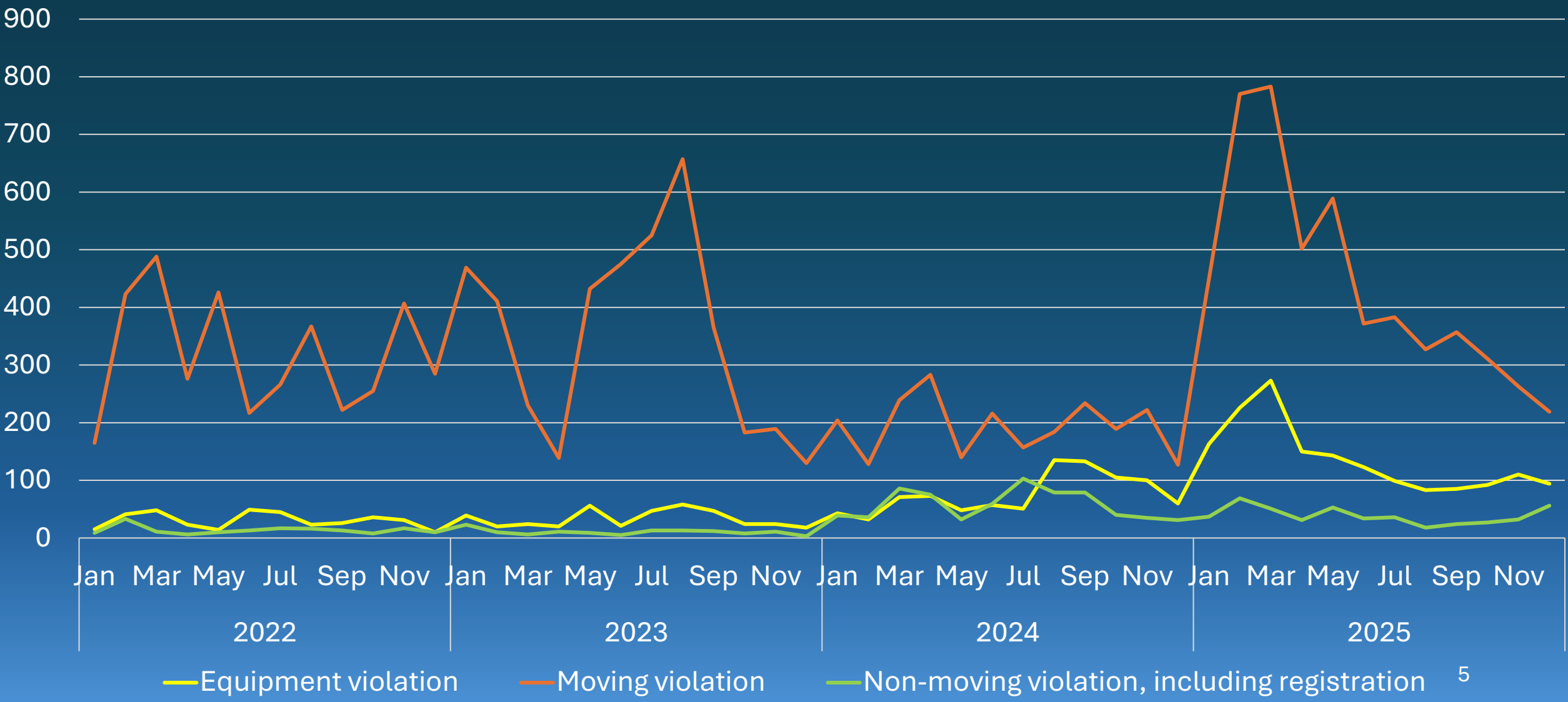
- **Weapon Display** – Occurs when an officer directs their firearm or Taser towards a subject. Weapon displays are warranted when an officer reasonable believes a threat exists based on the totality of circumstances presented at the time.
- **Control Hold** – Any Department approved method or hold, designed to control the movement of an individual by manually applying pressure to a particular part of their body. A control hold can be applied without implementing pain.
- **Takedown** – A method designed to physically take a subject to the ground with the intent of gaining control of the subject.
- **WRAP** – A WRAP is a device used to restrain individuals who present a safety risk to themselves or officers even after being handcuffed.

- **Pain Compliance Technique** - Involves either the manipulation of a person's joints or activating certain pressure points intended to create sufficient pain for the purpose of motivating a person to comply with verbal commands.

Moving Violation Traffic Stops by Race

- Using citation and warning data from 2025 traffic stops, only 36% of those stopped (2,298/6,451) provided an Alameda address. Therefore, it would be misleading to use Census data as a benchmark to make comparisons by race since over half of those stopped are not residents.
- A better but still imperfect benchmark is using the demographics of at-fault drivers involved in traffic collisions reported to police.

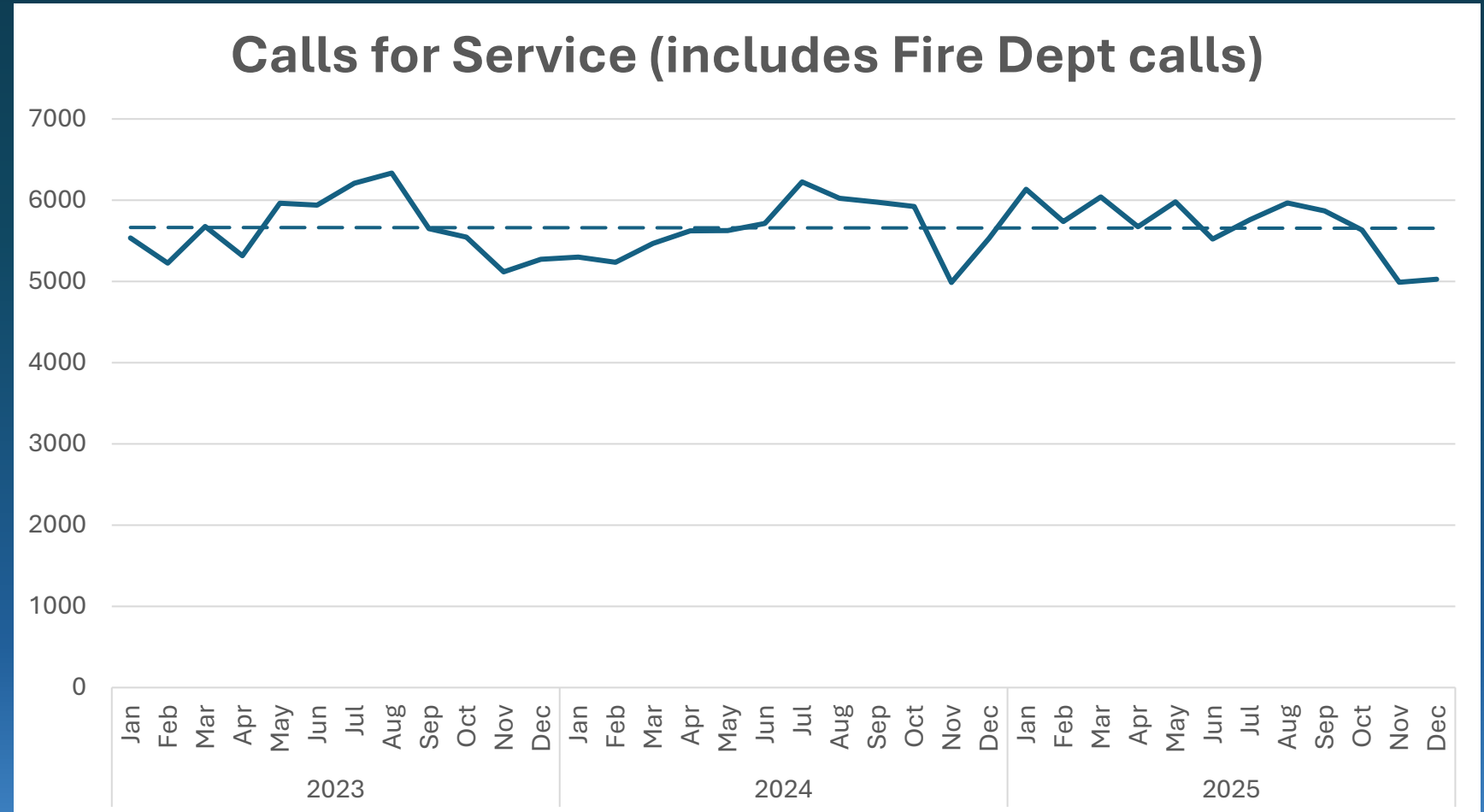

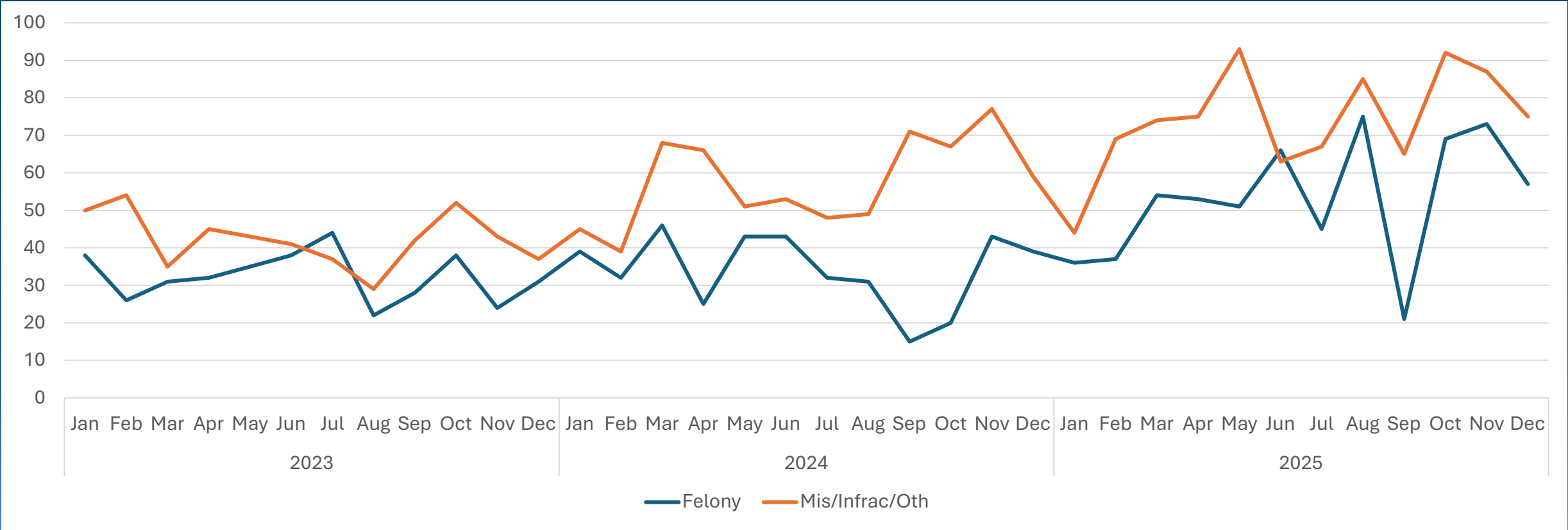
- There were approximately 700 more calls for service in 2025. The trendline over the past three years has been stable.

- On August 7, 2024, the APD pursuit policy was modified to allow officers to pursue suspects or vehicles wanted for felony crimes.
- The longest pursuit in 2025 was four minutes, the shortest was less than one minute.
- There were no collisions as a result of a pursuit.
- Identified areas of concern during pursuits:
 - Officer communication during pursuit
 - Clearing intersections
 - Vehicle speed during the pursuit

Collisions

- Employees were found to be at fault in 78% of collisions in 2025 compared to 71% of collisions in 2024.
 - Four collisions in 2025 involved an APD vehicle hitting a fixed object.
- One officer was involved in two collisions in 2025. They were found at fault in both collisions. They were provided remedial training.

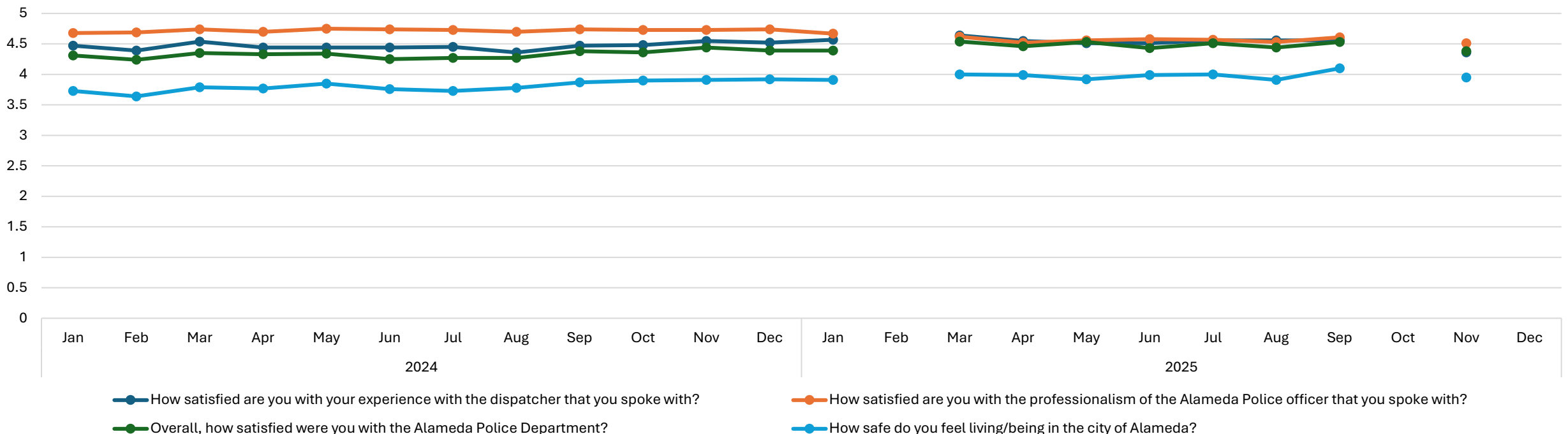

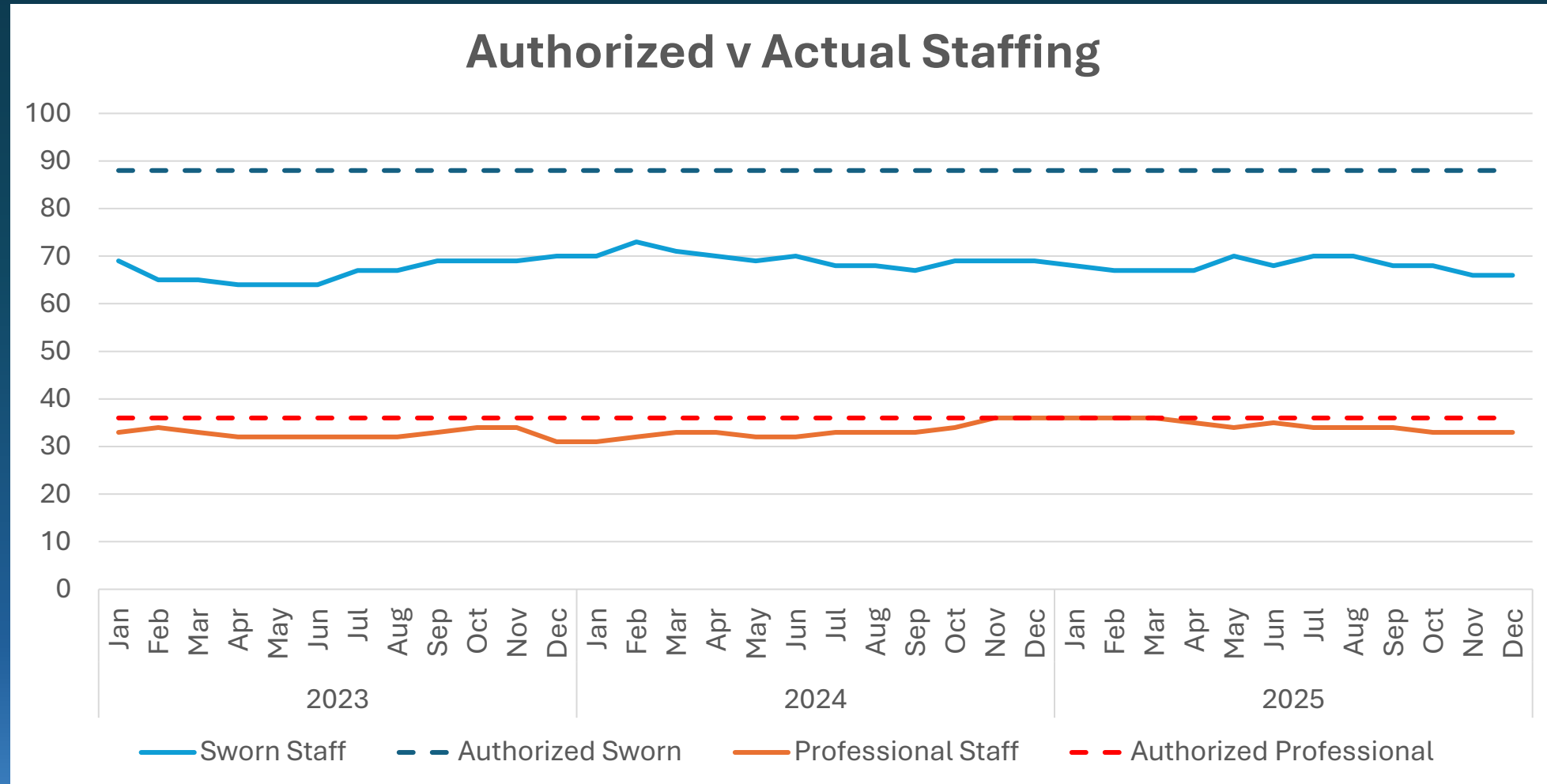

Staffing

- Staffing numbers have been stable the past three years.
- Sworn numbers are 25% below authorized staffing.
- Sworn staffing currently frozen at 72.



Claims and Lawsuits

- Claims can be filed when an incident occurs, and you believe the City might be responsible for loss or damage to you and your personal property.
- In 2025, 42% (13/31) of claims were for vehicle tows. In 2024, 42% (5/12) were for vehicle tows.
- In 2024, the city paid out three claims for a total of \$10,019.50. One claim was for a vehicle release and two were for accidents with APD vehicles.
- In 2025, the city paid out four claims for a total of \$49,913.42. Three of the claims were for accidents with APD vehicles.

Training

- Sworn Staff received 7,604 hours of training
 - Drone Training
 - Patrol Training (DUI Investigations, Ramey Warrants, Range, Investigations, OC Spray etc.)
 - Crisis Intervention
 - Emotional Intelligence
 - Canine
 - Radar
 - Traffic Collision Investigation
 - Defensive Tactics
- Professional Staff received 757 hours of training
 - Civilian Police Leadership
 - Evidence and Property
 - Courtroom Testimony
 - BWC Video Release and Redaction
 - Emotional Intelligence

CALEA Accreditation Progress

- Officially signed up April 15, 2025. APD has three years from the start date to gain accreditation.
- Need to be in compliance with 185 standards.
 - Policy and other written directive updates.
 - Updates to practice, additional training.
- Progress
 - 57 standards – updates to policy and proofs of compliance have been completed.
 - 16 standards – not applicable to our agency (ex court security, college campus).
- Obstacles
 - Platform APD uses to make policy modifications had a huge overhaul in late 2025. They provided no training or guidance on the changes. After repeated attempts to contact, we were finally provided a training.
