I object to Mayor Spencer calling for a special session just prior to this evening's city council meeting, with less than 7 days notice and after the agenda was published. I object to our Mayor nominating her choice to fill the vacant seat on the Social Services Human Relations Board.

This is unacceptable for a board appointment. The city received 10+ applications to be appointed to this board and to my knowledge none of them have been granted an interview.

This move to push a nomination through without due process is something that our Mayor vehemently spoke out against during the last election cycle. This appointment should be considered by all members of the city council who will be working directly with the board. Our city council does not need to allow this to happen and can ask that this be saved for the December 20th meeting when all council members will be present and able to contribute to the process. I ask our city council to NOT accept her nomination at this time, as this is completely in opposition to the Sunshine Ordinance.

It is imperative that we adhere to the Sunshine Ordinance and allow the due process we applicants deserve, that this community deserves to take place. This action to push up the nomination to this evening and rush the process without being transparent about the steps taken towards making this decision is the very action that Mayor Spencer took offense to and spoke out against in previous years.
