FIRST AMENDMENT TO SERVICE PROVIDER AGREEMENT

This First Amendment to the Service Provider Agreement ("Amendment") is entered into this _____ day of July 2026, by and between the CITY OF ALAMEDA, a municipal corporation ("City"), and TEAMCIVX, a California LLC, whose address is 21 Orinda Way, Suite C-191, Orinda, CA 94563 ("Provider"), in reference to the following facts and circumstances:

RECITALS

- A. On July 23, 2025, a Service Provider Agreement was entered into by and between the City and Provider (hereinafter "Agreement") in an amount not to exceed \$74,999 for public information and strategic support about City infrastructure funding needs and a potential ballot measure.
- B. Provider provided services as described in the Agreement Scope of Work and the City desires to amend the Agreement to increase the Compensation to ensure full funding is available through June 30, 2026 when the agreement will be terminated due to the completion of services being rendered.
- C. The City Council authorized the City Manager to execute this Amendment on _____.

NOW, THEREFORE, it is mutually agreed by and between the undersigned parties as follows:

1. **COMPENSATION TO PROVIDER** Paragraph 3, subparagraph (b) of the Agreement is modified to read as follows:

a. By the 7th day of each month, Provider shall submit to the City an invoice for the total amount of work done the previous month. Pricing and accounting of charges are to be according to the fee schedule as set forth in Exhibit B and incorporated herein by this reference. Extra work must be approved in writing by the City Manager or their designee prior to performance and shall be paid on a Time and Material basis as set forth in Exhibit B.

b. The total compensation for this 20-month Agreement shall not exceed \$91,935. Each month, work may begin only with the approval of the City Manager or their designee.

FY 2025-27 a total of \$7,500 shall be allocated for the months worked

Use of contingency shall be for items of work outside the original scope and requires prior written authorization by the City.

2. Except as expressly modified herein, all other terms and covenants set forth in the Agreement shall remain the same and shall be in full force and effect.

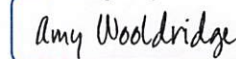
