

Background

- Bohol Circle Immigrant Park opened in Alameda, CA in January 2023 and is located at 2901 5th Street, the end of Fifth Street off Mitchell Avenue on the estuary.
- A sales center for Pulte Homes now sits at the entrance of the park and is scheduled to be removed later this year.
- On April 18th, 2023, the Alameda City Council will vote on what will replace the sales center and one of the leading options is to replace the 5,000 sq ft lot with a green space.
- The City Council is also considering alternatives (e.g., additional housing, a community center), however
 we believe the surrounding neighborhood is already dense and has 100+ unsold units for sale.

Why Should We Have a Green Space at the Entrance of the Park?

- Access: Bohol Circle Park terminates the 5th Street axis and serves as the visual and physical connection point with the promenade. Points of access to that promenade and bike trail are important—the public needs to know how to access them.
- Community: A green space will serve as a gathering space for the Alameda community at large.
- Education: A green space will provide opportunities for environmental education and outdoor learning experiences for children and adults.
- Environment: A green space will reduce air and water pollution and mitigate the effects of climate change, aligning with the goals of the City of Alameda Urban Forest Plan.
- Safety: Reduces additional traffic that non-green space alternatives would generate.
- Visual Aesthetics: While Bohol Circle Immigrant Park is already beautiful, it's primarily constructed of concrete and mulch. A green space would enhance the entrance to the park, which serves as a gateway to the estuary.
- Wellbeing: A green space will provide opportunities for outdoor recreation and physical activity, which
 is critical for physical and mental wellbeing.

Dear Madam/Sir,

We are the owners of Apartment 2886 Fifth Street (in Building 14 at Bay37-Landing). This is to provide our inputs, as Bay 37 residents, to the Project "PLN22-0401 - 2800 Fifth Street - Master Plan/Development - Applicant: Pulte Homes". The original plan was to replace the Sale Office of Pulte at the end of the Fifth Street with 5000 sq ft commercial space. After Pulte raised the concern that it will be difficult to find tenants for such commercial space, several alternative plans have been circulated for considerations. In an October 2022 survey of Bay 37 residents, we voted for a plan which proposes to replace the Sale Office with green space and additional parking (to help disabled/old/children visitors of the nearby puiblic park). Now we still think it is the best plan.

We are particularly against another plan that proposes to build two residential buildings and a recreation center in the place (the #1 plan among alternative plans included in the brochure "PLN22-0401 Pulte Bay37 Plans.pdf"). This plan will replace some of the green space in/around the Bohol Circle Immigrant Park with a concrete building (the "Recreation Center"), further reducing the green space in the Park which is deficient of green space in the first place (most of its ground is covered by concrete)! As local residents, we don't need more recreation facilities in this area (there are facilities in nearby Alameda Landing). Rather, we need more green space in this concrete forest.

I am writing to ask that you please support any of the options that include **more housing** at the Bay 37 neighborhood at the February 13th Planning Board meeting. These options are Alternative 1, 3, or 4.

I am a lifelong Bay Area resident, spending the past 19 years in Alameda County, the last 7 of those in Oakland, and moved to Bay 37 in November 2022.

There is a housing crisis in our state and I've seen so many of my friends and family move away because they could no longer afford living here. Yes, there is currently unsold inventory at Bay 37, but that will eventually sell and I believe we need to continue to **build more housing to stop displacement**. Density in this area is goodit's part of the reason my family decided to move to Alameda, and more specifically, this neighborhood. Bay 37 is walking distance to the Alameda Landing Shopping Center, which includes 2 walkable options for groceries, whereas my previous community was in a food desert.

There is a contingent of Bay 37 residents that supports Alternative 2. Alternative 2 only benefits a small number of residents in Bay 37. How many people will truly benefit from the extra green space with the existing Bohol Circle Immigrant Park right there? You can guarantee 2-5 families will utilize this space if housing is built. Having the option of welcoming more families to our community while helping abate the housing crisis seems like a home run to me.

Regarding Alternative 1, the option with the community center and 2 homes- If moving forward with that option, I would like to ask that the city and Bay 37 HOA

make it clear that the existing parking area meant for the Bohol Circle Immigrant Park is labeled as park, community center, and guest parking so that those who may need to utilize these resources can do so, instead of homeowners that are using these spots as their personal spots over multiple days. I would also like to push for a satellite Alameda library location for this spot, as was discussed as a possible option in a meeting where the various alternatives were presented to Bay 37 residents.

Thank you for all your responses to my last email. I listened to the zoom meeting on Monday and needed to step away, take a few pictures, and draw in the area to see how to better fit our needs list vs.the wants lists.

After reviewing all the various plans drawn, none of them refer to a big safety problem which should be corrected in this final stages of the area. The need list should include finishing the driving lanes toward the estuary and Bohol on Sentinel Dr all the way to the main walkway which can support emergency equipment. Moveable barriers place not the Pulte

/Alameda line.

Please refer to pictures attached of the corner of Sentinel Dr. The view looking toward SF is a construction canyon and the estuary end is blocked off with 2 parking slots with a curb, a young tree, bushes, grass. Note on red curb is "fire Lane' in a space that looks like a dead end alley.

Another thing discussed was a recreation building, however no one mentioned that a few well placed nicely built kiosks close to the standing white pergola could be a way to solve support for our new water features that are hopefully still planned -- water taxi and kayak rentals or info booth as well maintain view lines for residence.


Why we don't support a community center at this location

- Maintenance: A community center will require ongoing maintenance, upkeep, and parking enforcement, which will be costly
- Location: The proposed location of the community center is not ideal because the lack of parking makes it inaccessible to most residents of Alameda
- Safety concerns: A community center may attract criminal activity, particularly if it's understaffed and underutilized. The other 4 community centers in Alameda are not used to capacity
- A lost view: Bay37 promotional plans have always included an expansive 5th St view of the estuary. Narrowing the open space and its connection to the estuary is a lost opportunity for good urban design.



Why we don't support additional housing at this location

- Existing housing: There is an abundance of unsold inventory in the Bay37 community (100+ unsold units) that could be converted into low / moderate income housing
- Too Crowded: Cramming more homes to this small lot will make the area too dense / crowded and will not look nice as the entrance to the newly opened Bohol lmmigrant Park and may create confusion for people trying to access the bike trail and promenade
- Reduces Existing Limited Green Space: There is currently very limited green space in the entire neighborhood and a community center would reduce it further

At a meeting in November 2022, the Planning Board acknowledged that the Bay 37 community had not been informed of, or involved in the planning of the proposed construction. Subsequently, residents put together a survey to ask the community what they would like to see in their neighborhood. The overwhelming response was for additional green space. There are multiple reasons why green space is the best choice. This decision you make is a great opportunity for the City of Alameda to confirm its commitment to its citizens.

We have all come out of such a hard time that created isolation and mental health issues for many of us. Families are looking to make connections with each other, within beautiful outdoor space that creates safety. The 5th street entrance is a beautiful expansive vista to the estuary which is like taking a deep breath of fresh air and relaxing. It is also, currently, a very visible axis that promotes activities such as walking on the Bayshore Trail, kayaking, fishing and more.

As a child development professor, I have read myriad research on the positive impact green spaces promote for children's healthy physical, cognitive, and emotional development. I also have the pleasure of seeing this in action and watching how people use the Bohol Circle Immigrant Park. Children love the climbing structures, families play, parents spread their blankets to picnic on the only VERY small patch of grass, and just enjoy being together in nature. There are wonderful amenities at the park – but all within concrete. That's great for many activities, but there is still a lack of real green space.

Once the meeting date is confirmed, the City will be sending out notices to all the properties within 300 feet of the site, we will be posting signs near the site, and we will ask the Bay 37 homeowners association to help us distribute the information about the date of the hearing.

I am an Alameda resident and I would like to submit the following comment to the 4/18 City Council meeting, on agenda item 7A, regarding the amendment to planning approval for 2800 Fifth St.

City Council Members,

I'm a homeowner and resident at the Bay37 development at Alameda Landing waterfront, so I read with interest the last Planning Board meeting minutes, where the Board recommended changing the plan for a large commercial building on the site of the Pulte sales office to more housing and a small open space.

I am alarmed that, by removing the commercial building, the Board would change the Bay37 development from mixed-use to single-use. As Council members, I'm sure you don't need me to mention the many reasons why mixed-use developments are superior and more sustainable than single use, and why Bay37 was planned as such. San Francisco's financial district is learning the perils of single-use zoning at great expense currently.

I believe that the vacant lots at Alameda Landing shopping center were cited as evidence that a commercial building at Bay37 is unviable.

- First of all, we shouldn't be basing permanent decisions about land use on a post-pandemic economy that is an historic anomaly.
- And secondly, with all due respect, the reason that Alameda Landing mall has vacancies is because it's primarily a giant parking lot, and nobody wants to drink a coffee or eat a sandwich while staring at a sea of parked cars.

On the contrary, the Pulte sales office is an AMAZING location, with views of the water, yachts sailing past, and Jack London just a few hundred feet away. If a coffee shop (or similar) can't succeed there, especially when the water shuttle starts later this year, then we may as well all give up on the economy and go and live in caves! A single storey commercial building, smaller than originally planned, would benefit both the neighbors and the wider community, and encourage more foot traffic and less driving.

I also strongly support the idea of a community building belonging to the Parks dept, which was proposed but also inexplicably rejected.

I strongly encourage the Council to revisit the recommendation to build houses instead of a commercial and/or community building. Ultimately, do you want the legacy of this Council to be permanently changing a mixed-use development to be single-use?
