The following are action minutes in keeping with the Sunshine Ordinance 2-91.17.

1. ROLL CALL

Chair Alexander read the following statement: The City welcomes speakers providing public comment but please be advised this is a limited public forum. As such, speakers must stay on topic speaking to particular agenda item and if speaking during non-agenda public speaking comments, they must address the matters within the subject matter within the jurisdiction of the City. If speakers fail to follow these rules, they will be warned and if they continue to disregard the rules, their opportunity to speak will be ended.

2. NON-AGENDA PUBLIC COMMENT

3. STAFF COMMUNICATIONS

Recreation and Park Director Justin Long gave the Director Report. See Exhibit 1.

4. COMMISSIONER COMMUNICATION

- Commissioner Burney: Asked if the Franklin Park Tennis Courts will be open during thermal coat application to surface. Director Long replied that the courts will be shut down for a few days because the top coat needs time to cure. Commissioner Burney said that he recently played at the Franklin Park Tennis Courts and continues to be impressed with the condition of the parks. He gave appreciation to ARPD and Alameda citizens for maintaining and using the parks with care.
- Commissioner Radez: Noted that his family's days start at a park with their dog, continue with the Recreation Afterschool Program (RAP), finish on a basketball court, and weekends are spent at Rittler Park. He attended the "Together Bay Area" conference of regional environmental organizations and the "Local Hero Awards" produced by his organization, "Bay Nature", which recognizes remarkable environmental leaders. He stated that the experiences helped him make the connection between environmental work done on federal, state, and local levels. He referred to the Inflation Reduction Act, hearing Armando Quintero, California Department of Parks and Recreation Director, and Wade Crowfoot, California's Natural

Resources Secretary, speak about California's progress with the "30 x 30" goal, and the opening of Dos Rios Park, California's newest state park in the San Joaquin Valley. He spoke of funding for land back programs returning land to native tribes in the area and meeting with municipal leaders of park systems from Sonoma to Santa Cruz counties. He gave gratitude to fellow commissioners and ARPD for all the work and contributions.

- Commissioner Robbins: Thanked Director Long for working with Alameda High School in helping them get tennis courts to use due to the Emma Hood Swim Center closure. Stated that the Alameda Pickleball Group is impressed with Director Long's leadership and appreciate him being amenable to their needs. Commissioner Robbins attended an event at the Albert H. DeWitt O' Club and noticed the nice condition of the building interior and surrounding landscape. He played tennis at Washington Park and enjoyed the cleanliness of the park. Commented on the great improvement to Chochenyo Park pathways and looks forward to the completion of the Shoreline Trail pathways on Bay Farm. Encouraged the general public to attend the Sandcastle & Sand Sculpture Contest on June 1, 2024, and the Multimedia Art Exhibit at Mastick Senior Center. He noted that the Summer Internship Programs are a great opportunity for youth.
- Vice Chair Swartz: Asked how long it will take before Emma Hood Swim Center at Alameda High School (AHS) reopens. Director Long replied that the Alameda Unified School District (AUSD) plans on construction taking a year, and the anticipated start date is June 10, 2024. Currently, AUSD does not have Division of the State Architect (DSA) approval to start construction. Vice Chair Swartz stopped by the Mastick Arts & Crafts Boutique on April 27, 2024. He commented that the new McKinley Playground looks great and is excited to kick off the design process for the Alameda Aquatic Center. He noticed the Aquatic Center Community Workshops signage at the Main Library and appreciated ARPD Staff for the publicity efforts. He shared that he enrolled his son in the ARPD Swim Program for the summer and going forward, would like to see consistent information between online registration and the Activity Guide. He concurred with Commissioner Robbins that the Summer Internship Programs, specifically the Aquatics Intern Program, are great opportunities for youth.
- Chair Alexander: Attended the Mastick Arts & Crafts Boutique on April 27, 2024, made a few purchases, enjoyed talking with the members, and seeing the impressive ceramics made in the Mastick Skill Center. She commended Recreation Supervisors I, Stacy Thomas and Christina Bailey, and all of their staff for the Spring Shindig held on April 20, 2024. Chair Alexander was at the "Friends of the Park" booth in her 1980's outfit, had a fabulous time with Director Long and was pleased to hear that over 1,000 people attended. She watched girls' softball games at Krusi Park and noticed that many people play Pickleball under the lights at Leydecker Courts. She reiterated information on the Play for the Parks Golf Tournament on Monday, May 20, 2024. She stated that is a wonderful event and those who do not play golf can support the parks by attending the dinner at the Harrison Recreation Center.

5. MINUTES

Commissioner Radez moved to accept the minutes of the April 11, 2024 Regular Meeting as presented.

M/S Commissioner Radez / Commissioner Burney. All who were present at the April 11, 2024 meeting were in favor with three ayes via roll call vote.

6. REGULAR AGENDA ITEMS

6-A Update on Community Engagement Plan for Future Public Art Site Selection

Jackie Kelliaa, Development Manager for Economic Development Division with the City of Alameda, introduced Jack Denham Conroy, CivicSpark Fellow, who is working with the City of Alameda on all the public art projects. The presentation included an overview of his main capstone project for this year which is to develop and implement a community engagement strategy for selecting locations for future physical public art, what has been completed so far, where the selection process is headed, a general timeline, preliminary site selection, community engagement, and final site selection. Lois Butler, Economic Development Division Manager for Base Reuse and Economic Development with the City of Alameda, was present to answer questions.

Public Comments

- None.

Commissioner Comments

- Commissioner Burney: Asked how outreach is being conducted, was concerned about the public's feedback being represented, and inquired how public comment is being weighed. CivicSpark Fellow Denham Conroy replied that the first event had a pop-up table and prize wheel at Radium Runway during the San Francisco Opera, and there will be two more events for face to face interaction with the public, as well as a survey and general update sent through the City Manager's office to reach approximately 30,000 recipients. There is a running spreadsheet to rank public feedback.
- Commissioner Radez: Thanked CivicSpark Fellow Denham Conroy for the work and asked what feedback would be most helpful from the Recreation and Park Commission in terms of identifying suitable park sites and natural features. CivicSpark Fellow Denham Conroy replied that park sites have been identified for the current process, but additional park sites are welcome for the next round of study. Economic Development Division Manager Butler added that it would be helpful to receive feedback on any of the park locations where the Recreation and Park Commission would not like to see physical art or sculptures.
- Commissioner Robbins: Thanked CivicSpark Fellow Denham Conroy for the presentation. Noticed the public art site list did not include Main Street Linear Park. Said that the location is underutilized and thought that it would be a beautiful statement area to showcase sculptures from several different artists as you drive along the park. Suggested that the park to be taken into consideration for future public art sites. Economic Development Division Manager Butler remarked that she will take Commissioner Robbins recommendation on sculptures being showcased at Main Street Linear Park to the Public Art Commission. He asked how many parks will be selected for the public art plan. CivicSpark Fellow Denham Conroy replied that 2-5 is the projected number. Commissioner Robbins echoed Vice Chair Swartz regarding Towata Park being a good location for public art.
- Vice Chair Swartz: Provided feedback regarding public art park sites and felt the list included diverse, geographic locations. He shared that Towata Park would be a good site, it has some foot traffic, and public artwork may encourage more people to visit the space. Stated that

Portola Triangle is another area to draw attention to and agreed with Commissioner Robbins that Main Street Linear Park is an ideal location.

- Chair Alexander: Asked how outreach information regarding the general update and survey will be available. Economic Development Division Manager Butler answered that information will be sent from the City's general email list. Director Long stated that ARPD can work with Economic Development Division Manager Butler and post information on ARPD social media. He said that Sarah Henry, Communications & Legislative Affairs Officer for the City of Alameda, will be involved in putting it on the City's website. Chair Alexander asked Director Long about public art at Towata Park. She stated that there had been previous community discussion to revamp the park site and suggested that potential public art at that site reflect the history of the Towata Family. Chair Alexander thanked the presenters for coming.

Parks:

Parks “works in progress” ...

- Shoreline Pathway Phase 2 is in progress. The segment of the waterfront trail starting at the Bay Farm Ferry Terminal leading up to Creedon Circle is closed from Monday, May 6 - Friday, May 17, while the City widens and repaves the trail, creating a smooth walking and riding surface. Many young people use these routes as they travel to and from school. Marked detours are in place (Adelphian Way to Creedon Circle) and a detour map is available on our website.
- Resurfacing of the Krusi Tennis Courts and repaving of surrounding pathways are expected to take place from Monday, May 13 – Friday, June 21.
