Background

October 2015

- City Council directed staff to explore a Sales Tax or Utility User Tax (UUT) Measure for Nov 2016 based on unfunded needs and the UUT revenue outlook
- *Ginsburg v. City of Alameda* - filed

December 2015

- Polling of likely Alameda voters to determine if willing to tax themselves for City services and if so, which ones.

March/April 2016

- Polling Results Shared
- 1st Citizen Advisory Committee
- Analysis of *Ginsburg v. City of Alameda* - complete

What is the UMA?

Modernizes our existing Utilities Users Tax (UUT) and confirms Alameda Municipal Power (AMP's) historical financial support of city services such as police, fire and emergency response, street and sidewalk repairs, park maintenance and library services

- No increase to current tax rates;
- No increase to electric bills (adjusted for inflation);
- Modernizes our existing laws and practices; and
- Allows us to maintain core city services.

DRAFT Ballot Question

To maintain funding for essential city services, such as police, fire protection, libraries and parks, without raising tax rates or electric charges, shall the City of Alameda amend its Charter to reaffirm the annual transfer of approximately \$3.7 million from Alameda Municipal Power to the City, adjust future transfer amounts for inflation, and modernize the Utility Users Tax ordinance to reflect new and evolving technologies so that all taxpayers are treated equally regardless of technology?



What is the UUT?

- The Utility Users Tax (UUT) is an existing 7.5% tax on the consumption of:
 - Electricity
 - Gas
 - Cable TV
 - Telecommunications Services





History of the UUT

- In 1970, the City Council enacted a Utility Users Tax (UUT) to help fund general city services.
- In 1995, the City Council increased the UUT to 7.5%
- Prop 218 stipulated that any tax must be ratified by the voters
- As a result, in November 1998, the City placed the UUT on the ballot and it was passed by the voters.






History of the UUT

- The UUT was put in place to ensure the City of Alameda had steady revenue to support essential public services, including:
 - Medical emergency response
 - Police Patrol and Investigations
 - Fire Protection
 - Street and Road Repair
 - Libraries
 - Maintenance of Parks and Recreation Facilities






History of UUT Revenues

What Will the Modernization Do?

- Alameda's existing UUT ordinance was written long before anyone could have envisioned how technology would change.
- This update will ensure the tax is equally applied and better define which services are covered.
- This modernization will shore up funds that the City has historically received but is declining due to antiquated language and changing technologies.



What Will the Modernization Do?

- This measure will return the UUT revenue into the General Fund back to the FY 2007/08 level.
 - Expect to raise approximately \$1.5 million
- 10 agencies in Alameda County have a Utility Users Tax. Of these, 8 have updated and modernized their UUT through a vote.
- Alameda is one of the last two agencies that has not updated its UUT



Why is Modernization Important?

- The UUT provides the City of Alameda with key financial support to fund essential services, which maintain Alameda's quality of life, including:

 - Streets and pothole repair

Alameda Municipal Power (AMP)

Alameda Municipal Power (AMP) – Historical Support of City

Annual Transfer - \$2.8 million

- Transfer since 1914
- Written into the Charter in 1937
- Amount varies - Peaked in 1995 at \$3.6 million

Street Lights - \$900,000

- Maintenance, Replacement, and Electricity

Other Support - \$1.4 million

- Payment in lieu of taxes (PILOT)
- Return on Investment (ROI)



Alameda Municipal Power (AMP)

October 2015 - *Ginsburg vs. City of Alameda*

- Lawsuit alleges AMP's support of the General Fund is in violation of Proposition 26 (approved Nov 2010).
“Charge for a government service cannot be more than the reasonable cost to provide that service – otherwise it’s a tax”
- Common practice among municipal utilities (other cities watching closely)

- AMP's annual transfer provides the City of Alameda with key financial support to fund essential services, which maintain Alameda's quality of life, including:
 - Emergency medical response
 - Fire response to emergencies
 - Police response to violent crimes and property crimes

What Will the Modernization Do?
