Good afternoon Mayor Ashcraft and esteemed Council Members

I wanted to voice support in principle for Astra in their request for a long term lease of building 360. As a long time small business owner, I can attest to the stability such leases, if affordable, can bring to a company and the enduring benefits to the surrounding community.

However, there are two issues of concern that I think are worthy of discussion.

1. If Astra is granted this long term lease, will it take the pressure off of Sustainable Technologies? In the article here <https://therealdeal.com/sanfrancisco/2022/03/01/rocket-scientists-hit-speed-bump-in-plan-for-alameda-expansion/> it would appear that Astra wants to dislocate another long time Alameda small business that has been a part of the community for over twenty years. It does not seem unreasonable to ask Astra to coexist and share with their smaller neighbors.
2. I would like to understand at what threshold the PSA requirement outlined in clause 26.4 page 35 of the draft lease with Astra kicks in. What constitutes a “covered construction project”? It seems unduly onerous to require a tenant to look after a building while at the same time tying their hands to act timely on basics like electrical, plumbing, painting, and concrete work that can be performed by many local licensed contractors in and around Alameda. Encouraging use of local licensed contractors would seem to make sense if the goal is to keep properties in good shape while putting money back into the local community. Furthermore, many businesses have staff tasked with building maintenance to ensure ongoing safe and uninterrupted business operations. Would this clause essentially kill those skilled jobs? It’s a vague clause that could set a bad precedent for businesses of any size. Unless it’s heavy construction in the millions of dollars, the requirement seems a bit over reaching.

On behalf of the Governor's Office of Business and Economic Development (GO-Biz), I write to share additional insight into the role Astra Space, Inc. Dear Madam Mayor and City Council:

Langan Engineering and Environmental Services, Inc. (Langan) is providing this letter to the City of Alameda to document our technical observations and opinions<sup>1</sup> on the environmental mitigation and monitoring measures completed and continuing by Astra Space Operations, Inc. (Astra) for their commercial use of Building 360 located at Alameda Point. Langan has been retained by Astra since June 2018 to support their mitigation and reuse of Building 360. Astra is leasing additional buildings in the vicinity.

Langan has been providing integrated engineering and environmental consulting services for over 50 years and specifically in the Bay Area (as both Langan and Treadwell & Rollo, Inc.) for over 30 years. The Langan team includes state registered professional engineers and geologists and certified hydrogeologists with expertise in soil vapor mitigation and groundwater cleanup. Langan has been providing environmental engineering support to the Alameda Point Site A redevelopment project since 2014. Personally, I have over 30 years of experience in environmental consulting and have been leading military base redevelopment teams for over 20 years building on previous experience as a consultant.

In 2018, Astra started the environmental assessment and mitigation required to lease a portion of the approximately 180,000 square-foot Building 360 from the City of Alameda. In 2021, Astra expanded environmental efforts in order to lease the entirety of the building. Building 360 is located in a portion of Alameda Point that has not yet transferred to the City and remains U.S. Department of the Navy (Navy) property. Building 360 formerly served as an aircraft engine facility, and historical activities within the building have reportedly included painting, blasting,

degreasing, solvent cleaning, and plating of aircraft parts<sup>2</sup>. Building 360 is located over a portion of a groundwater plume that contains volatile organic compounds (VOCs) which may volatilize into soil gas and can intrude into building spaces. The Navy is in the process of cleaning up the groundwater to remove VOCs.

Prior to leasing the building, Astra installed a vapor mitigation system (VMS) to comply with applicable land use restrictions. The VMS consists of an engineered slab sealant designed to be impervious to VOCs in soil gas/vapors potentially beneath the building slab, that required sealing cracks that may be present in the concrete floor prior to application. The VMS design for Building 360 was presented in the *Building 360 Vapor Intrusion Mitigation Design Plan*<sup>3</sup> which was submitted to, commented on, and approved by the Federal Facility Agreement (FFA) signatories. The FFA signatories include the Navy, U.S. Environmental Protection Agency (EPA), California Department of Toxic Substances Control (DTSC), and San Francisco Bay Regional Water Quality Control Board. The plan also presented the required sub-slab soil gas and indoor air sampling plan and operation and maintenance (O&M) plan required to support VMS system operation and continued building occupancy.

Astra initially occupied the southern portion of Building 360 through installation of the VMS and erection of a barrier wall to create a work space mitigated against vapor intrusion. Astra partnered with the City and FFA signatories to develop a health protective and approvable VMS design. The project team considered regulatory agency comments and resolved issues through virtual and on-site meetings prior to completing the VMS installation and pre-occupancy monitoring. On June 7, 2019, the southern portion of Building 360 was approved by the FFA signatories for occupancy. VMS monitoring for the southern portion of the building includes quarterly ambient and indoor air, sub-slab and soil gas sampling for VOCs and methane and continuous indoor air monitoring for trichloroethene (TCE).

Astra expanded into the northern portion of Building 360 upon receipt of FFA signatory approval on March 11, 2022. Astra followed a similar approach to developing an expanded VMS design and installation methods presented in a *Building 360 Amended Vapor Intrusion Mitigation Design Plan*<sup>4</sup> submitted to the FFA signatories. In addition, prior to beginning shell condition improvement work within the northern portion of Building 360, a review of existing indoor air data was conducted. Although existing indoor air concentrations were protective of temporary worker health, Astra implemented an interim mitigation and monitoring program during shell condition improvements and installation of the VMS. This program included continuous air monitoring for total VOCs, TCE, and methane and reporting a weekly summary of air monitoring results and response actions, if applicable, to the FFA signatories. It is our opinion that Astra's

continued monitoring of the indoor air during shell improvements and VMS installation to protect the health of contractors and visitors exceed typical requirements.

Throughout this process, Astra has also continued regular monitoring of the occupied southern portion of Building 360 and expanded the monitoring to the northern portion of Building 360 for employee and visitor health protection. Astra's efforts have succeeded in improving the Building 360 interior and exterior conditions transforming Building 360 from an unused, dilapidated shell to a vibrant work space with the health of building occupants considered during each step of the process, including continued monitoring of the indoor air. The specific actions that Astra Space has conducted and will continue to perform include:

- Hazardous materials abatement (asbestos and lead-based paint) and demolition
- Containerization and sampling of generated wastes, including voluntary containerization and sampling of concrete dust generated during building slab preparation activities
- Air monitoring for protection of construction workers and building occupants
  - Continuous air monitoring for total VOCs, TCE, and methane during shell condition improvements to protect workers
  - Daily air monitoring for TCE within the occupied space
    - In Langan's professional experience this monitoring frequency is highly atypical and conservatively protects the health of sensitive or vulnerable populations
    - Quarterly air and soil gas monitoring for VOCs since May 2019 to confirm continued protection of building occupants including up to 42 air and eight soil gas locations
- Increased worker protection during potential dust generating activities, including donning of Tyvek suits and half-face respirators
- Vapor intrusion mitigation including
  - Installation of a vapor barrier coating (Retro-Coat) designed to inhibit vapor migration into the building and protect building occupants and the voluntary addition of a second membrane (Drago Wrap) at pits or vaults prior to infill
  - Sealing of crawl space access from within Building 360
- Coordination with DTSC, USEPA, RWQCB, City of Alameda, and the Navy during each step of building rehabilitation and occupancy, including compliance with the City's Site Management Plan (SMP).

By completing these building improvements and mitigation measures, it is our opinion that Astra has improved and continues to improve the building interiors to protect human health with air monitoring as a confirmation measure, as such we strongly suggest you vote YES to item 7-F on the September 20<sup>th</sup> 2022, City Council Meeting Agenda. 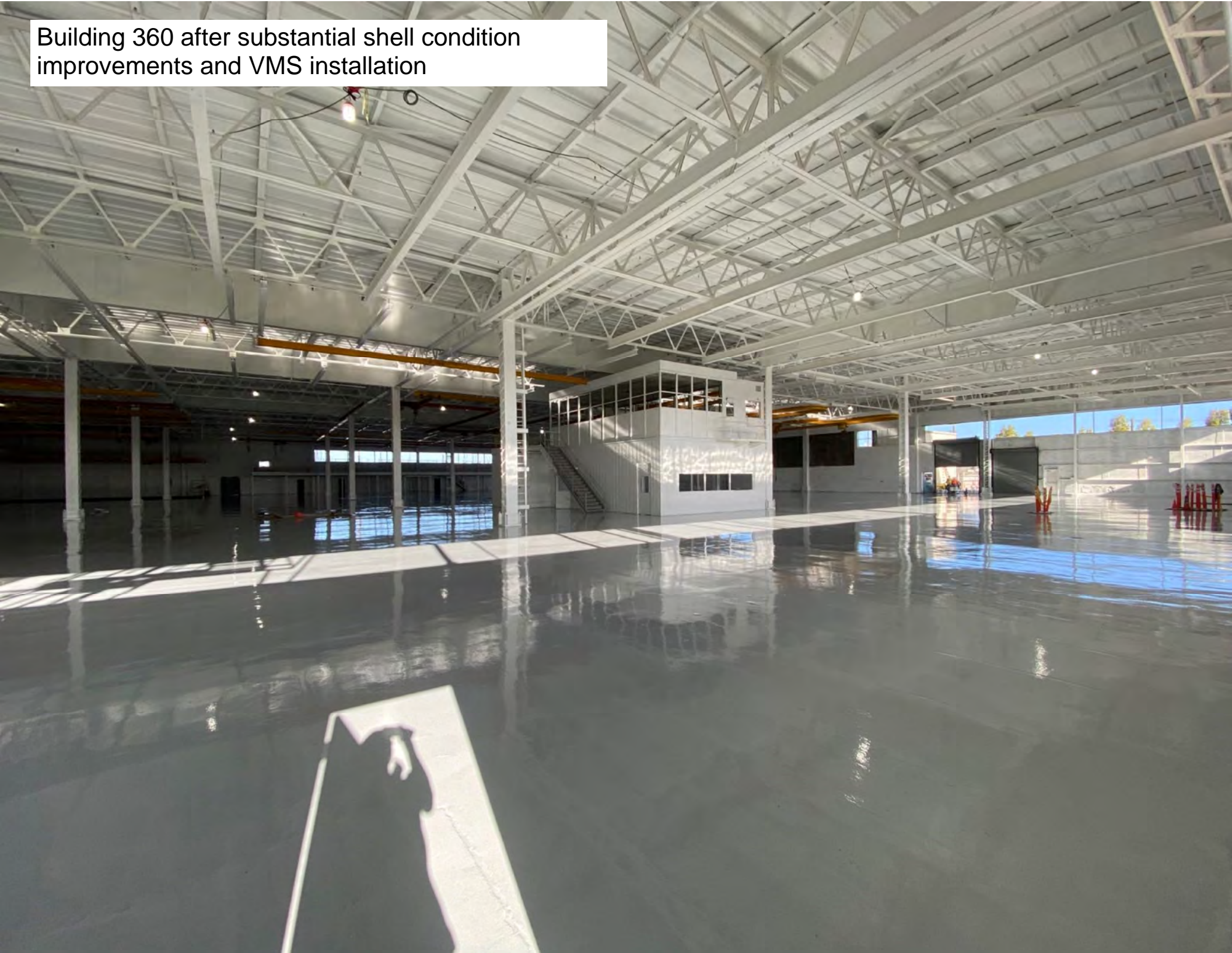

On behalf of the Bay Area Council and our over 300 members, I write to urge you to approve Astra Space Operations, Inc.'s ("Astra") long-term lease at Alameda Point. The Bay Area Council is an employer sponsored public policy and advocacy organization dedicated to solving our region's most challenging issues and improving the quality of life for everyone who calls this region home.

As you are likely aware, the Bay Area Council's Economic Institute conducted an analysis of Astra's economic impact. The company now employs approximately 300 individuals, up from approximately 100 in 2020, making the city home to one of the fastest growing companies involved in the space economy. In addition to the economic activity taking place within Astra's walls—i.e., wages paid to employees, materials and services purchased, and sales made to customers—the company also produces positive economic effects for the city broadly. With the expectation of employment growth and product diversification, Astra's current investments at Alameda Point need to be preserved through long-term lease security.

On behalf of the Alameda Chamber and Economic Alliance, we would like to go on record as being in support of the company Astra Space Operations, Inc. regarding Item 7-F: Astra's lease for the property located at 1900 Skyhawk Street (B360). Which is being presented during the City Council meeting on September 20, 2022.

We are the President and CEO, Madlen Saddik, and the Board of Directors Chair, Kelly Lux, of the Alameda Chamber & Economic Alliance is a voice for the business community of Alameda. As representatives of the Alameda business community, we are very supportive of providing the security a long-term lease provides any growing and successful organization at Alameda Point. Astra's continued operation in Alameda is necessary for city-wide continued growth and ability to provide and create jobs in this city.

The needs and wants of the public are a driving force for Astra, and the Alameda Chamber implores City Council to support keeping Astra in Alameda by approving this lease. The Chamber believes it will significantly benefit our entire community. In a January 2022 published report, the Bay Area Council identified Astra's current contribution to the city as \$58M annually, or 1% of the city's total GDP. In addition to invaluable GDP contribution, Astra has grown its employee base to well over 400, with 300% growth observed in the last year alone; approximately 20% of those employees are Alameda residents. Per the same report, for every 50 workers employed at Astra that are Alameda residents, an additional 8.1 jobs are supported in the city annually.

Astra has expanded its presence at Alameda Point from 17,000 sq. ft to over 225,000 sq. ft since it took tenancy at Alameda Point in 2017, which is a massive display of growth and a clear indicator of success and stability in Alameda. Astra has become a crucial part of the community, from donations to Alameda Education Foundation, participation in the Alameda Fire Department's annual toy drive, organizing community clean-up efforts, and engaging with local education associates to support STEM development. The Mayor has enhanced such community support. He helped welcome guests at Astra's inaugural Spacetech day, which reached more than 1,300 influencers, investors, media personnel, partners and customers of Astra, which displays Astra's commitment to Alameda.

Astra is an asset to the city and Alameda Point. It fits in with the city's vision for Base Reuse, creating a flourishing community where Alamedans can live, work and play, and supports the city's goal of bringing 9,000 jobs to Alameda Point.

It should also be noted that in July of this year, the Chamber supported Astra's position to expand their presence at Alameda Point to Buildings 11 and 19, which Astra had to withdraw from their proposals due to a conflict in timing between potential leasing of the buildings and contractual obligations to maintain project timelines. As a result, Astra has since executed a lease at another building in Sunnyvale, CA. This is a considerable loss to Alameda, our businesses and our community. We strongly recommend Alameda's City Council recognize the importance of expediting essential decisions, such as this lease, to ensure businesses can continue to succeed and thrive in our community.

For the reasons stated above, the Alameda Chamber and Economic Alliance would like to implore Alameda's City Council to vote YES on item 7F, to keep Astra in Alameda and no longer delay this vital issue.


