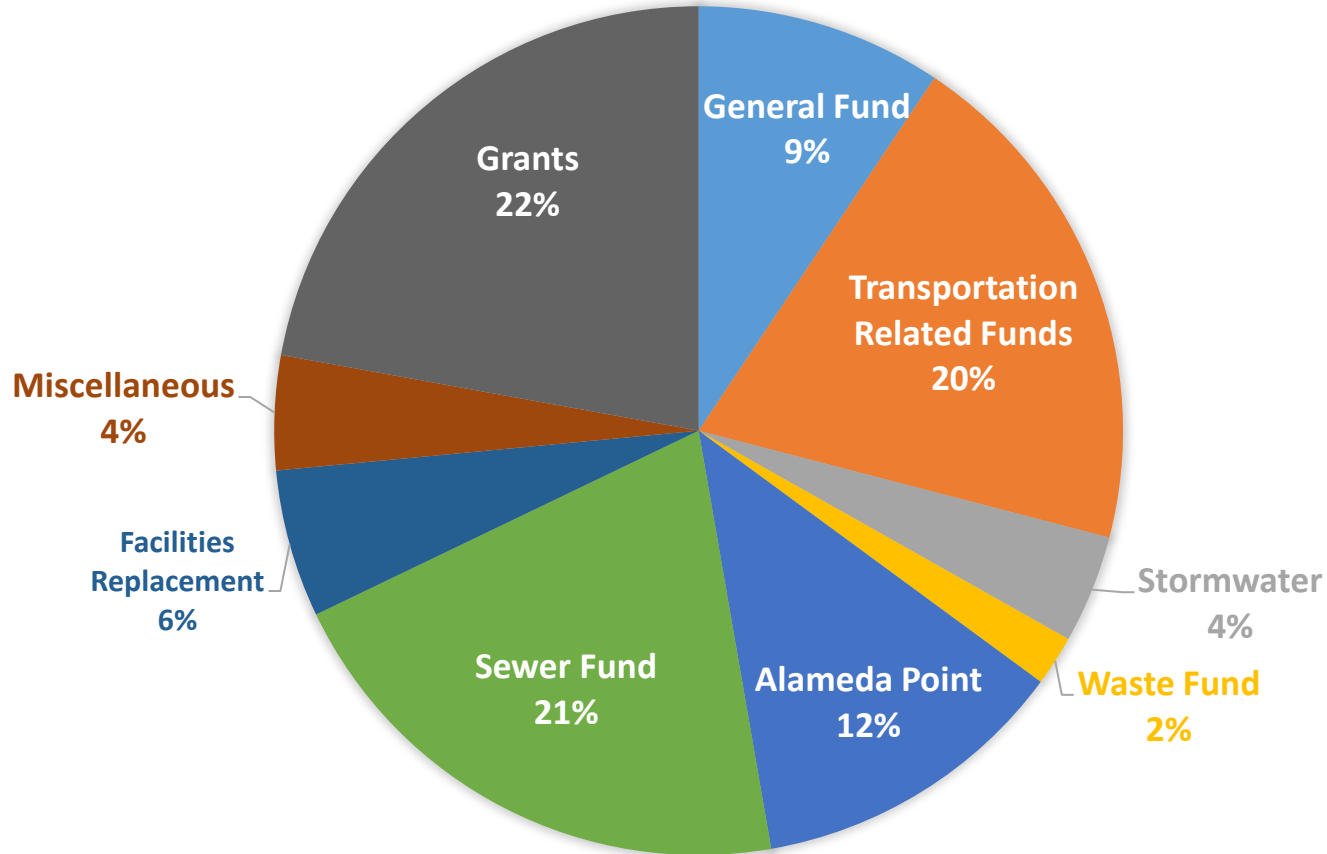
# FY 2023-25 Capital Budget Accomplishments

Alameda Point	Finished Adaptive Reuse Backbone Infrastructure & Replaced the roof at Building 24
Pavement, Lighting and Urban Forest	Rehabilitated 6.9 miles of City streets, removed over 14,000 sidewalk trip hazards, upgraded signals along the Cross Alameda Trail to add bike phase
Sanitary Sewer	Rehabilitated 6 miles of sewer main
Stormwater, Lagoons and Shoreline	Established automated water movement through Harbor Bay Lagoons; made emergency repairs to the Bay Farm shoreline
Buildings & Facilities	Fleet Services roof replacement; O'Club restroom renovation; Tilman roof replacement, heater installation and electrical upgrades; Mastick Front Entry Improvements; Veterans Memorial Building floor refurbishment, heater replacements and bathroom renovations.
Parks	Replacement of Krusi Park tennis court; upgrade of Washington field lighting with LED; installation of drinking fountains and bike racks at various parks; installation of park signs and new lawn area at Bohol Immigrant circle park; path repair at Shoreline, Chochenyo, and Krusi.
Transportation System Enhancements	Mecartney Rapid Flashing Beacons, Lincoln/Walnut improvements
Adaptation and Resiliency	City Council approved a 10% design concept to protect the northern shoreline of Bay Farm Island and the City's northern shoreline near the Posey/Webster Tubes from sea level rise and flooding.

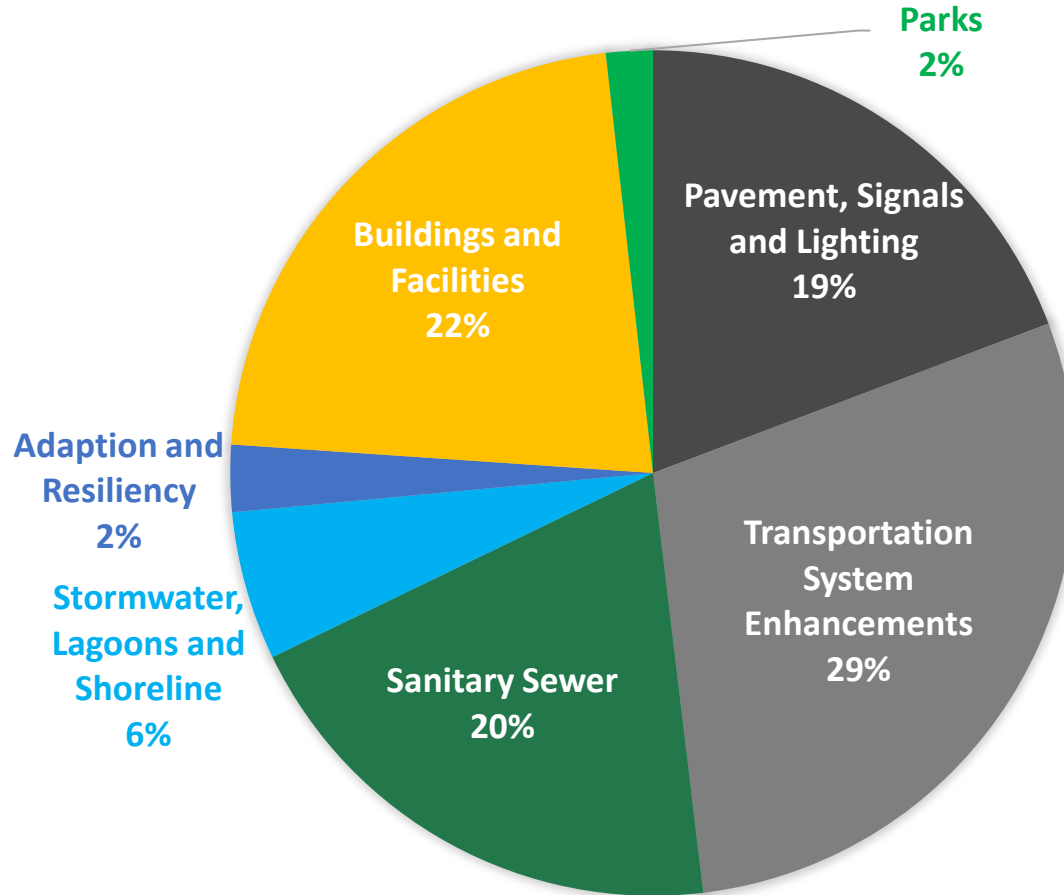
# Project Funding Considerations

1. General Fund is impacted by current economic conditions so projects are prioritized by:
  - Enhancing public safety
  - Alignment with the City Council Strategic Plan
  - Maximizing opportunities to leverage grant funding
2. Available restricted fund balances, including projected revenue and operational costs
3. Master plans and other policy documents
4. Facility condition assessments
5. Staffing resources to execute projects
