That means from a sphere of influence and economic capture our outlying cities are bleeding Alameda and Oakland dry of our populations hard earned money and putting it in their towns pockets.
- 5) The surveys sent out were not done correctly! I had to physically write in to a comments box "I would like to see a 50M pool option" and on the next survey we were given the option. By that time it was too late! Alameda as a whole was under the impression the only option was a 30M pool and so the new surveys went massively unanswered. Good evening Madam Mayor, Council members and City Staff,

I am writing on behalf of Alameda Backyard Growers (ABG), to ensure the community garden gets built as part of the Aquatic Center project.

Since its inception, ABG has been involved in the development of Jean Sweeney Open Space Park. Back in 2013, when it was first imagined, the Park included a 2-acre community garden. ABG, together with Supervisor Wilma Chan, and countless volunteers, spent hundreds of hours to design the garden that would include garden plots for residents, an education space, a self-pick community fruit orchard, a pollinator garden, toolsheds and a composting area. In July of 2016, the City Council approved the JSOSP Plan and it included the community garden.

When it looked like the community garden space was a good location for the proposed Aquatic Center, ABG was asked how we felt about changing the garden location to accommodate the new project. The ABG Board voted to support the relocation, if the community garden could be included in the Aquatic Center Project.

#### Dear city council,

I am writing to you today as a former competitive swimmer. I grew up in Southern California, where there was plenty of pool space and nice swim facilities. Swimming gave me a life-long love of fitness and being active. Swimming helped me get into a great university and continue my sport in college. Swimming kept me out of trouble in high school- when my friends were going to parties and drinking, I was usually in the pool. Swimming gave me a great community of similarly motivated friends. Swimming had a great impact on my life and it would be great if the youth swimmers in Alameda had those same chances, supported by a community that took their sport seriously.

It's amazing that a new community swim complex will be built in Alameda to help fill the need for community space and more swim team space. There are already a couple 30m pools on the island that can be used for water polo. The 50m pool is the only option that makes sense for the new community swim center, and it can benefit the entire community.

I have competed in pools all over the country and they all have one thing in common-they are all 50m pools. An Olympic sized pool is a requirement for hosting a swim meet on the United States Swimming level. Here are some of the reasons the 50m pool is the best option.

- 1. A 50m pool would allow the Gators program to expand and reach more Alameda kids. When I was looking for my kids to join Gators so they could become strong swimmers, it took 2-3 years for them to be able to start due to capacity constraints. A 50m pool would allow the most swim space overall and the Gators program would be available to more kids. NOTE: my kids are not currently Gators swimmers.
- 2. Allowing swimmers to train in a 50m pool for the 50m summer swim season is essential. Swimming a race in a 50m pool is much different than swimming a race in a 25 yard pool. During the summer, competitive swimmers should be training in a 50m pool if they hope to be able to keep up with the competition.
- 3. Having a 50m pool complex would allow local and regional swim meets to be held in Alameda. This would bring more people into Alameda for swim meets, which would support the local economy and specifically the west end local economy. Alameda could be seen as a swimming community.
- 4. Masters swimmers, triathletes, open water and recreational swimmers can all benefit from training in a 50m pool as it builds stamina and endurance with the longer lap length.
- 5. Community members will also benefit from a bigger pool. When the pool is set up for 25 yard lanes, there will be more space for youth swim lessons, recreational swimming, water aerobics and other aquatic programs. Multiple programs can happen at one time, making this the best option for use of the new pool space.
- 6. Swimming 30m laps is not a thing. The 50m pool option is the only option that's flexible

enough to allow swimming different lengths of the pool- 25 yards or 50m.

This is an opportunity for the city of Alameda, the city surrounded by water, to have its own Olympic sized pool and become a legitimate swimming community. Community members and business owners will benefit from the 50m pool option and it's an opportunity to add something new to Alameda. If the 30m option is chosen, it will be just another pool similar to what we already have on the island and all of these potential benefits will be lost. Hello Mayor Ashcraft and City Council Members,

My name is Darrah Jones. In addition to my full time job as a mental health therapist, I lifeguard and teach swim lessons for ARPD. I was also raised in Alameda and learned to swim at Emma, Encinal, Lincoln, and Franklin pools. I now swim, teach, coach, and guard at Encinal in my spare time. I'm at the pool every day, I interact with and listen to members of our community who actually utilize the pool, and I have the pulse of what Alameda citizens actually want.

Our city should not move forward with the 30 m pool and activity pool/baby pool option, *Which, by the way, children grow out of a need for once they are about* 6. Seriously, head over to Encinal any time. You'll notice the comp pool in use all day every day, and the baby pool completely empty. It's like that with the exception of lesson days, leaving the pool entirely useless in the hours outside of lessons. In contrast, people are going to Encinal to use the comp pool all day long. Once families children turn 6 they have no more need for a baby/activity/fun pool -- whatever you want to call it.

Come 2027 when this facility opens its doors, we will have 3 aquatic centers with the same design in a 2 mile radius. It makes zero sense. You have been told this is what the community wants, but does the community really want it three times over? Are 2 pools with this exact design not enough? What about something different for our island? Also, as stated above, I am at the pool every single day talking to people about this. I have yet to talk to one person who doesn't want the 50 m pool option. Then again, everyone who actually goes to the pool knows that we already have

Encinal and that Emma Hood will soon reopen. So none of them see any sense in building yet another of the same. People are ready for something different and new.

Our community has not been properly educated on this issue before surveyed. There are limitless benefits and opportunities 50 m pools have to offer. As one of the actual teachers in the water, teaching Alamedan children and adults alike, I want to stress how possible it is to offer swim lessons in a 50 m pool. Not only is it safe and perfectly suitable for lessons, you can place a divider in the pool and run concurrent programming while lessons are going on, serving more members in our community at the same time.

Here are some but not all of the programs and services you can offer Alameda with a 50 m pool. Swim lessons, lap swim, family swim, Baby and me classes, water aerobics, aquatic physical therapy, scuba certification courses, lifeguard certification courses, swim meets and competitions (*HUGE money makers*), swim team practices, water polo, kayak certification, community pool parties and gatherings, again, family swim, lessons, and water aerobics can all be offered with a 50 m pool at the same time. I want to emphasize that 50 m pools can accommodate up to 3 concurring programs all at once.

Our community has been misled to think that a 50 m pool does not offer lucrative programming and service opportunities to our island. 50 m pools are the true inclusive option for our community. With opportunities to serve all ages and aquatic needs of our island and its people. We're Alameda. We're an island. Everyone in Alameda should have access to swimming, and to learning how to swim. As an aquatics town, it would be absolutely bonkers to miss our opportunity for a 50 m pool.

If we miss out on this opportunity, it will be looked back upon as the biggest mistake in Alameda parks history. When we look around in 2027 and ask ourselves why we have 3 of the exact same facilities within 2 miles of one another, we will wonder why we didn't choose differently when we had the chance. A 50 m pool is the best option for our community. Please consider voting for the 50 m pool. It will be the most lucrative option, and all ages and people of our community will benefit for decades to come.

I grew up in Davis, CA, where the youth aquatics community has been strong for more than 40 years. One thing we didn't have, and sorely felt the lack of, was a 50 meter pool. ## Dear Mayor & City Council,

Thank you for bringing us closer to realizing the Alameda Aquatic Center. I eagerly look forward to the day when this vision becomes a reality. My name is Drew Swartz. I am the Vice Chair of the Alameda Recreation and Park Commission, a former competitive swimmer, a current Alameda Aquatics swimmer, and the father of a 3-year-old.

I am writing to express my **support for the 50 meter design** for the Alameda Aquatic Center. Swimming has been a lifelong passion of mine. I began competitive swimming at the age of 12, swam through high school and college, and continue to swim with Alameda Aquatic Masters. My journey in the water extends beyond just competing—I started lifeguarding at 15, began teaching swim lessons at 17, and have coached swimmers at the youth, masters, and collegiate levels.

Access to a **50 meter pool is crucial for swimmer development**, as it is the standard for major competitions, like the Olympics, and summer USA Swimming club meets. Long course (50 meter) training builds the endurance, speed, and technique needed for these events and helps swimmers develop race strategies for the longer distances between turns. It also benefits triathletes by enhancing their stamina and efficiency needed for the openwater portion of their races. Without regular long course training, swimmers may struggle to meet the demands of these competitions, limiting their potential.

There are **4 key reasons why a 50 meter pool design** at Jean Sweeney Park is the best long-term choice for the Alameda Aquatic Center, ensuring our growing community's aquatic needs are met, not just now but in the future.

#### 1. Consider All Our Aquatic Facilities as a Unified System

We must view our aquatic facilities as a unified system. With a 30 meter pool and activity pool already being built at Alameda High School, it seems illogical to create another similar facility at Jean Sweeney. Encinal High School also already has an activity pool for swim lessons and other youth programming. A **50 meter pool would complement the facilities at Encinal and Alameda High**, allowing for diverse programming across all three sites. With ARPD already utilizing Encinal and Alameda High pools, especially during peak summer demand, a 50 meter pool offers new possibilities rather than duplicating existing options. Furthermore, **no public 50 meter facility exists in western Alameda County**, highlighting the regional need for such a space. (See attachment for comparison of future Alameda High School design currently under construction to design of 30 meter and activity

# 2. Provides More Flexibility and Parallel Programming

A 50 meter pool offers more flexibility than a 30 meter pool with an activity pool. It can have a deeper end for competitive swimming and water polo, and a shallower end for swim lessons and recreational programs. Removable swim platforms, already used by ARPD, can create shallow areas for lessons, potentially generating more revenue than projected in the cost recovery model. Cities like San Ramon, Pleasanton & Walnut Creek run **diverse programs in their 50 meter pools**, proving Alameda can do the same. An activity pool, limited by depth and temperature, make them **unsuitable for athletic training**. A 50 meter pool provides the ability to be adaptable, ensuring the city has the facilities to meet the seasonal and changing needs of the community.

#### 3. Allows for Economic Impact from Hosting Regional Events

A 50 meter facility would enable Alameda to host regional swim meets and water polo tournaments, generating significant economic activity. While the 30 meter design limits competitive opportunities, a 50 meter pool would not only serve local athletes but attract participants and spectators from across the region. For example, Sacramento Masters recently hosted a Masters Swimming Champiothey with 780 swimmers, 64% who traveled over 60 minutes to participate and 41% of which stayed at least 1 night in a hotel, boosting the local economy. It also gives the school district the required pool space to host high school championship swim meets and water polo tournaments such as WACC & CIF championships.

#### 4. Addresses the Shortage of Lane Space


Alameda's current **pool space is insufficient** to meet the growing demand for youth swimming and water polo. The Alameda Gators, the local youth swim program, must hold some practices at Mills College and Chabot College. Meanwhile the Neptunes, the youth water polo club, has practices as late as 9:30pm due to limited pool availability. As Assistant City Manager Wooldridge pointed out at the October 2022 City Council meeting, only **50% of interested youth can currently participate** in our year-round aquatic programs. A 50 meter pool would alleviate these constraints, expanding opportunities for both youth and adult programs and bringing Alameda's aquatic team offerings in line with comparable cities.

In short, a 50-meter pool at Jean Sweeney would offer **greater flexibility**, **economic potential**, **and opportunities** for Alameda's aquatic programs to thrive. ARPD programs can already be accommodated at Encinal and Alameda High School swim facilities and most, if not all, of these programs can still be accommodated in a 50 meter pool. I encourage the city to prioritize the long-term needs of our community and approve the 50 meter design.


I recognize the strong public support for the 30 meter pool with an activity pool, as reflected in survey results, but the 50 meter option has been unfairly portrayed as serving only competitive athletes (which is reiterated by some of the public comments sent to the commission). The community has not been fully informed about the benefits of the 50 meter design or the programming that will be supported by the new Alameda High School activity pool. Concerns raised at community meetings were not addressed in public communications or follow-up surveys, leading to a skewed perception. As I have outlined, a 50 meter facility, combined with the pools at Alameda and Encinal High Schools, can meet both recreational and ARPD programming needs while also allowing youth aquatic programs to thrive and grow. In fact, before construction even begins on the city aquatic center, the Alameda High School activity pool will be open, offering swim lessons, family swim and senior programs.

Thank you for your consideration on this very important decision that **will impact our** aquatic programs for decades to come.

# Dear City Council Members and ARPD Commission Members,

I am writing to express my strong support for the construction of the new aquatic center in our city, equipped with *multiple pools*, including a 50-meter competition pool <u>and</u> a dedicated activity/warm-up pool. As our community continues to grow, so does the need for versatile and inclusive recreational facilities that promote health, fitness, and community engagement. By virtue of the name *aquatic center*, Alameda should be building a facility that offers *multiple* pools that offer a variety of waters sports and recreational amenities.

I'm here to advocate for the planning and development of a state-of-the-art aquatic center that not only meets the current needs of our community but also anticipates and supports our future growth and aspirations. As our city continues to expand, it is crucial that we invest in facilities that will serve our residents for years to come, enhancing the quality of life, promoting public health, and fostering community spirit.

# Rationale for an Aquatic Center and Future-Proofing our Aquatic Facilities:

- Population Growth and Demand: Our city's population is rapidly growing, and with it, the demand for public amenities. An aquatic center designed to accommodate future needs will prevent overcrowding and ensure that all residents have access to high-quality recreational and competitive swimming facilities. By planning ahead, we can avoid the costly and disruptive need for expansions or renovations in the near future.
- 2. Supporting Competitive Swimming and Community Events: A 50-meter competition pool would accommodate our growing community of competitive swimmers, including local swim teams, high school teams, and future athletes. Currently, our athletes travel to other cities for proper training, and an in-city facility would allow them to practice locally, reduce travel time, and foster a sense of pride in our community.
  - A 50-meter competition-ready aquatic center would allow our city to host local, regional, and even national swim meets, diving competitions, and water polo tournaments. This would not only provide our athletes with a high-quality venue but also generate significant economic benefits from visitors and event participants. A forward-thinking design can position our city as a regional hub for aquatic sports.
- Learn-to-Swim Programs: Drowning prevention is a critical concern, particularly for children. An aquatic center would allow us to offer comprehensive swim lessons, water safety classes, and lifeguard training programs, making our community safer and more prepared.
- 4. **Inclusivity, Accessibility and Diverse Aquatic Programming:** A well-planned aquatic center should include a variety of pools and features that can support a broad range of activities, such as swim lessons, water aerobics, lap swimming, competitive training, and leisure swimming. Thoughtful design, including a 50-

meter competition pool, an activity/ warm-up pool, and spaces for adaptive and therapeutic use, will make the center versatile and inclusive for people of all ages and abilities including those with disabilities, injuries, or chronic pain, who require warmer water for therapy and rehabilitation.

5. Environmental and Financial Sustainability: By incorporating sustainable design features such as energy-efficient heating, advanced filtration systems, and solar power, the aquatic center can minimize its environmental footprint and reduce operational costs. Investing in green technologies and durable materials will ensure that the center remains an asset to our city for decades, rather than a financial burden. This is an opportunity for the City of Alameda to work in tandem with Alameda Municipal Power to ensure that the aquatic center represents a step forward in Alameda's energy-saving and environmental initiatives.

The construction of an aquatic center with a 50-meter competition pool and a warm-up pool would be a significant investment in the health, safety, and economic vitality of our community. I strongly urge the council to prioritize an extended budget for this project and allocate the necessary resources to make it a reality. By doing so, we would be investing in a facility that would serve the community for decades to come, promoting wellness, supporting our athletes, and creating a facility that meets our immediate needs while also anticipating future growth.

Having both the competition and activity pool means that the city would have to increase the originally proposed \$45 million budget to accommodate a multi-pool option. This is Alameda's **only** opportunity to plan for diverse aquatic needs for the next 50 years. My concern with the 2 current proposals is that both fall short of satisfying the community's needs. With the current options we are settling on a pool that either recreates the *exact facilities* we have today (30-meter + activity pool at Emma Hood and Encinal) or builds a single 50-meter pool that eliminates the *multi-use* function of a *true* aquatic center.

As a lifelong resident, I urge the City of Alameda to consider the examples set by other Bay Area communities such as as Moraga, Walnut Creek, Vallejo, Brentwood, Palo Alto, Sunnyvale, Concord, San Ramon, and Mountain View, which have invested in comprehensive and competitive aquatic facilities. Alameda has a unique opportunity to create a multi-use aquatic center that meets the needs of our community.

If an increased budget is currently unfeasible, I would appreciate hearing the City's plan to allocate space and resources for a phased approach. For example, Phase 1 could involve constructing a 50-meter pool, followed by an activity pool in Phase 2. This strategy would allow Alameda to build a top-tier aquatic facility over time

Thank you for considering this proposal. I look forward to your positive response and am happy to assist in any way possible to bring this vision to life.
