The Alameda Architectural Preservation Society (AAPS) would like to thank the City Council and staff for incorporating many of the recommendations in our September 18, 2023 letter into the revised Strategic Plan to be considered for approval at the council's November 7 meeting.

However, the provisions in the following two September 18 recommendations have not yet been included:

- 1. Add the following project under the "House All Alamedans and Homelessness" strategic priority: Explore policies and implementing actions which will facilitate a higher proportion of affordable housing, especially low and very low income housing in future development while maintaining and preserving historic resources.
- 2. Add the following project to the "Enhance Community Safety and Services" strategic priority: Establish standards for new development on streets in older neighborhoods in order to minimize congestion, maintain safety and ensure adequate ingress, egress and parking for adjacent properties.

We request the Council to include these provisions in the Plan.

Dear Mayor Ashcraft, Vice Mayor Daysog and Council Members Vella, Spencer & Jensen:

We strongly object to the placement of the "Recommendation to Adopt the City of Alameda 2023-2026 Strategic Plan" on the Nov. 7, 2023, consent calendar as item 5-D and ask that it be placed on the regular action agenda.

A "workshop" on a draft Strategic Plan was placed on the regular action agenda on Sept. 19. Suggestions for amendments to the Plan were presented at that meeting by both Council Members and public commenters. In several instances the City Manager responded to these suggestions by giving assurances that she would develop language for amendments to address these issues. However, no specific language was drafted at the meeting, nor was any vote taken by the City Council to approve the same.

The revised Strategic Plan attached as an Exhibit to Item 5-D does contain amendments that address the issues raised on Sept. 19. However, if 5-D remains on the consent calendar neither City Council nor the public will have a reasonable opportunity to comment on the sufficiency of the amendments to meet their concerns.

We recognize that any Council Member may pull section 5-D from the consent calendar, but this still relegates this very important Plan that will be guiding the City Council for several years to significantly less comment time for Council Member input. Your Rules of Order allow only placement of "routine" items on the consent calendar. There is nothing "routine" about developing final language for our Strategic Plan.
