

## EARLY MORNING STREET SWEEPER OPERATOR

### DEFINITION

Under general supervision, operates street sweeping equipment on assigned early morning routes to clean City streets, parking lots, gutters, and medians; performs maintenance and adjustments on equipment operated. Performs other Public Works maintenance work as required.

### DISTINGUISHING FEATURES

This is a specialized street maintenance classification in the Maintenance Worker series. Positions in this class perform highly responsible maintenance work and are responsible for the independent performance of particularly difficult or specialized maintenance work. Work in the class is distinguished from that of lower classes by the greater independence with which an incumbent is expected to operate and by the more technical aspects or overall complexity of the work. Incumbents are able to perform the full range of duties assigned with only occasional instructions or assistance as unusual or unique situations arise and are fully aware of operating policies and procedures. Work may be performed under supervision, independently or with the assistance of helpers.

### EXAMPLES OF DUTIES

The following list of duties is intended only to describe the various types of work that may be performed and the level of technical complexity of the assignment(s) and is not intended to be an all-inclusive list of duties. The omission of a specific duty statement does not exclude it from the position if the work is consistent with the concept of the classification or is similar or closely related to another duty statement.

*Reasonable accommodations may be made to enable individuals with disabilities to perform these essential functions.*

#### Essential Duties

1. Operates street sweeping equipment on assigned routes; prevents damage to sweeper, street structures, automobiles or pedestrians; may support and complete other routes as required.
2. Inspects, starts up, operates and shuts down equipment in a manner that ensures safety of self and others, complying with Department of Transportation (DOT) Regulations; protection of equipment and property, and the efficient accomplishment of objectives during operation, and makes minor operating adjustments; adjusts brooms.
3. Reports unsafe roadway conditions and deceased animals found on route to supervisor or appropriate staff when needed.
4. Maintains vehicles and equipment daily by checking fuel, oil, grease, radiator, water tank, air cleaner and tires; checks sweeper for even wear of brooms; advises equipment maintenance personnel of need for major mechanical repair.
5. Cleans and washes equipment at end of each shift.
6. Maintains a variety of logs and reports including miles swept per day and volume collected.
7. Responds to emergency calls.
8. May perform journey-level skilled or semi-skilled construction, maintenance and repair work; may perform general construction and street maintenance repair work.
9. Maintains supplies, work records and logs.
10. Reads and interprets blueprints, specifications, maps and drawings.
11. May provide direction and training to assigned staff.

#### Other Duties:

12. Performs related duties as assigned.

### WORKING CONDITIONS

- Primarily outdoor work with daily exposure to traffic, noise, dust, fumes, weather conditions, and moving machinery.
- Early morning shift work required.
- Occasional indoor office/shop environment for data entry and reporting.

- Subject to emergency call-outs.

#### **PHYSICAL DEMANDS**

- Extended periods of sitting while operating heavy equipment.
- Standing, walking, bending, kneeling, climbing to enter/exit vehicle.
- Lifting and carrying items such as DEF fluid containers (approximately 10 pounds).
- Requires hand-eye-foot coordination and sustained concentration while operating equipment.
- Exposure to traffic hazards and moving machinery.

#### **EMPLOYMENT STANDARDS**

##### Education/Experience

Any combination equivalent to education and experience likely to provide the required knowledge and abilities. A typical way to obtain the knowledge and abilities would be:

Education: Graduation from high school.

Experience: Two years of skilled public works, facilities or equipment maintenance or construction trades experience, including one year of street sweeping experience.

##### Knowledge

Operation and maintenance of street sweeping equipment; methods, practices, materials and equipment used for general or street construction and maintenance; basic traffic laws as they pertain to the operation of assigned equipment; traffic safety when working on the streets; safe work practices and procedures.

##### Ability

Ability to operate heavy trucks, specialized vehicular equipment, and other related tools and equipment safely and in accordance with traffic laws and regulations; perform technically sophisticated and highly complex maintenance related work; read and interpret blueprints, maps and drawings; maintain accurate records; communicate effectively; establish and maintain effective working relationships with employees and the general public; work independently; provide lead direction and training to subordinate employees; learn City streets and assigned routes.

##### Special Requirements

Willingness and ability to work early morning shift; willingness and ability to respond to after-hours emergency calls as required.

##### Other Requirements

Possession of a valid California Driver's License and satisfactory driving record as a condition of initial and continued employment.

Possession of a valid Class B State of California driver's license with tanker and air brake endorsements. Subject to provisions of the Department of Transportation's drug and alcohol testing program.
