Purchaser agrees that this Purchase Order is an expression of intent of the parties to transact, and the transaction described herein is not binding until (1) accepted by Supplier, (2) Purchaser completes the purchase of the vehicle(s) by executing the standard Rivian Commercial Vehicle Purchase Agreement for each vehicle ("**Agreement**"), and 3) final transaction payment details are provided by Supplier (which may include additional/updated tax, license, documentation, and destination fees as applicable).

This Purchase Order shall be subject to cancellation by Supplier unless and until finalization and execution of the Agreement between the parties.
