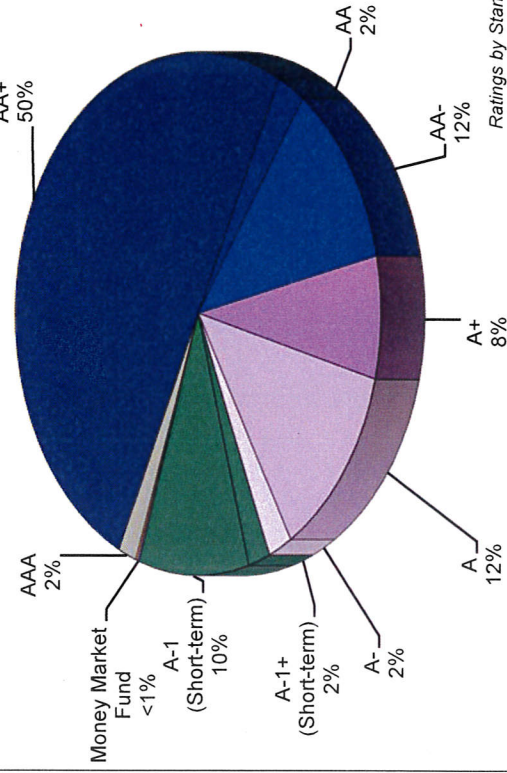

Credit Quality Distribution

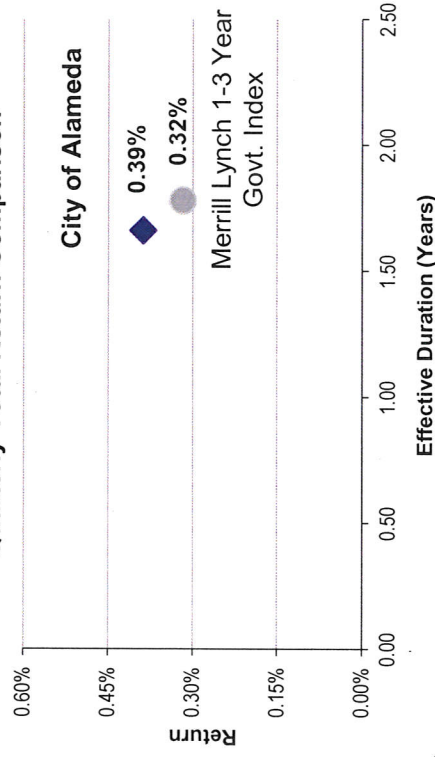

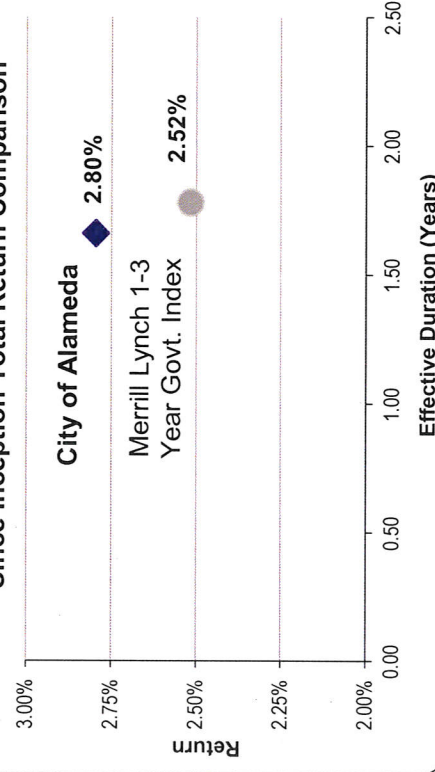

Quarterly Total Return Comparison



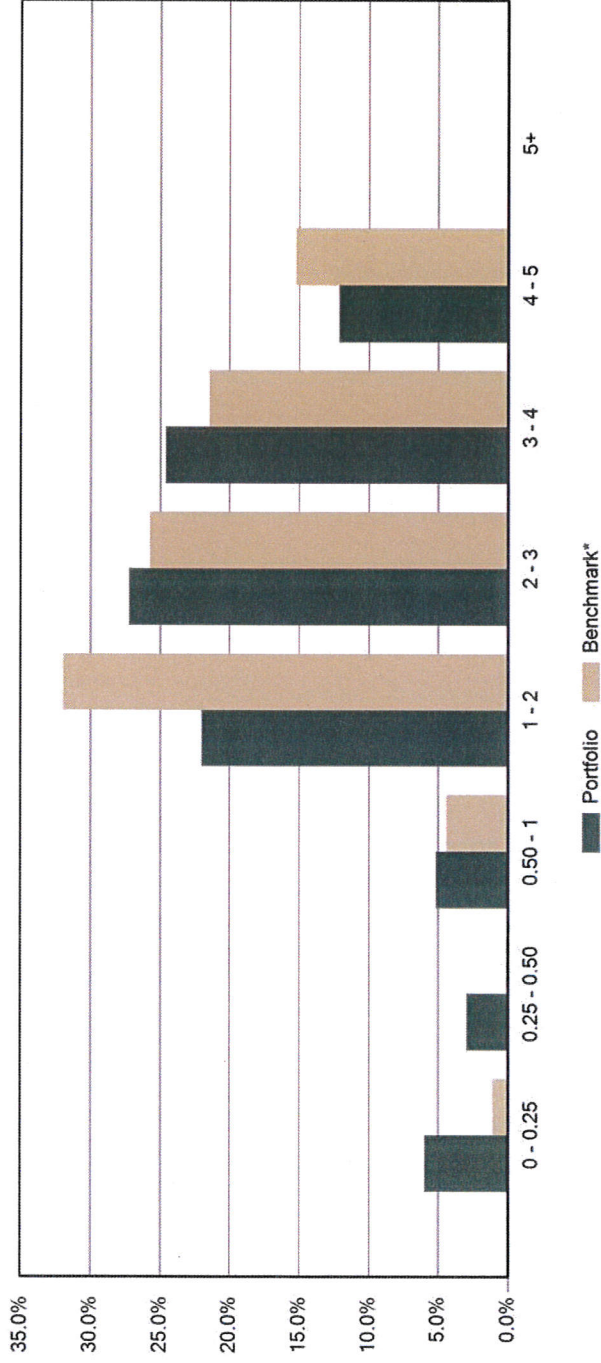

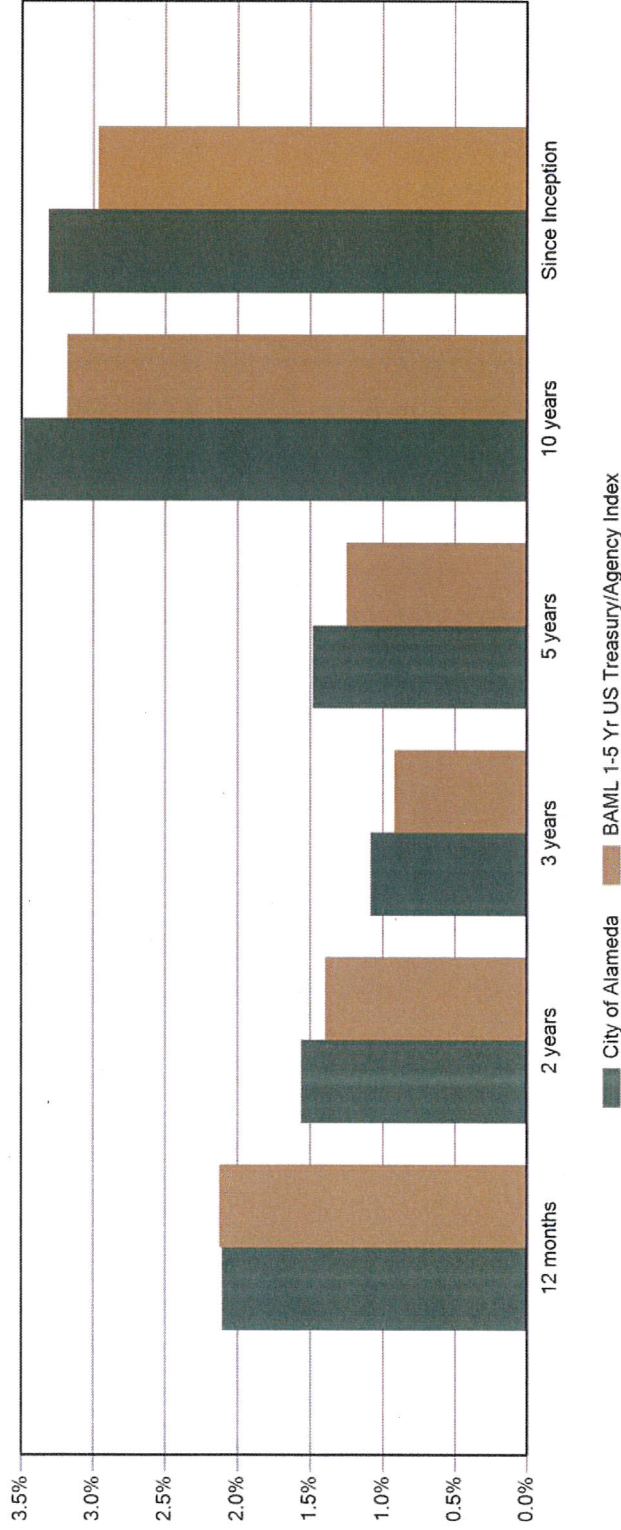
