Dear Ruben,

Thanks for following up, and for your continued participation! Here's what we expect for parking impacts:

- **Gibbons/Northwood/Southwood roundabout:** 5 on-street parking spaces removed to accommodate the roundabout, in addition to marking red curb at 8 spaces that are already no-parking zones per State daylighting law.
- **Southwood/Bayo Vista/Fairview roundabout:** 3 on-street parking spaces removed to accommodate the roundabout, in addition to marking red curb at 6 spaces that are already no-parking zones per

State daylighting law.

The State daylighting law is in effect, and it applies to intersections even without red curb or marked crosswalks.

Hope that helps! We will forward this information to Councilmembers and include it in the presentation.
