- 4A**      [2026-5733](#)      PLN24-0145 - Certificate of Approval - Radium Theatre Performing Arts Center Project - 2151 Ferry Point Way - Applicant: Scott Ward on behalf of Radium Presents, Inc. Public Hearing to consider a Certificate of Approval to construct an approximately 600-seat performing arts center and landscaped plaza on an approximately two-acre site of the Seaplane Lagoon Taxiway on the west side of Pan Am Way between the Naval Air Museum and the Seaplane Lagoon Promenade within the NAS Alameda Historic District. A separate public notice will be issued for the Development Plan and Design Review decisions when they are scheduled. General Plan: Mixed Use. Zoning: AP-WTC, Alameda Point - Waterfront Town Center District. CEQA Determination: This project is exempt from further environmental review as a Class 1 categorical exemption pursuant to CEQA Guidelines Section 15301(l)(1) - Existing facilities - demolition and removal of individual small structures including one single-family residence, and on a separate and independent basis, as a Class 3 categorical exemption pursuant to CEQA Guidelines Section 15303(a) - New Construction or Conversion of Small Structures - construction and location of a limited number of new, small facilities or structures including one single-family residence in a residential zone. None of the exceptions to the exemptions apply. (THIS ITEM WILL BE CONTINUED TO THE MARCH 5, 2026, MEETING OF THE HISTORICAL ADVISORY BOARD.)
- 4B**      [2026-5734](#)      PLN26-0008 - Certificate of Approval - Lincoln Avenue/Marshall Way/Pacific Avenue Corridor Improvement Project - Applicant: City of Alameda. Public hearing to consider a Certificate of Approval to allow the relocation / replacement of historic streetlights as part of the Lincoln Avenue/Marshall Way/Pacific Avenue Corridor Improvement Project. This project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15301(c) Existing Facilities (Minor alterations to existing facilities including bicycle facilities) and Section 15304(h) Minor Alterations to Land and the creation of bicycle lanes on existing public rights-of-way. None of the exceptions to the categorical exemptions apply. This CEQA determination confirms and accords with the environmental findings in City Council actions taken on the Project on April 18, 2023, September 17, 2024, February 4, 2025 and September 16, 2025.
