Words That Made the Difference is a powerful play, whose purpose is to shed light on the accurate history of our nation and the courage of the people who stood up for justice. We mission is to share this information through the arts with as many people as possible.

Please provide a brief organization history:

The project is the theatrical production, Words That Made the Difference: Brown v. Board of Education. It began as a desire to help students understand the legacy of desegregated education in the United States, to help students and adults understand the underpinned legacy of desegregated places and opportunities for people of color. When Cindy Acker began the research for the project, the granddaughter of the late Chief Justice Earl Warren heard of the play that she was writing, and approached her, offering her grandfather's memoirs to have a deeper understanding of Warren's work and rationale for the unanimous Brown decision. From that, she wrote a play that has been touring in many cities in the United States, including Alameda, Novato, Palo Alto, Sausalito, St. Petersburg, Florida, and livestreamed across eight countries. It was also requested by the Barbara Lee/Elihu Harris Speaker Series and was performed for a packed audience in Oakland. Surprisingly, Sausalito was the last and most recent U.S. city to fully desegregate (as of 2019). The cast was specifically invited to assist the healing of the community with this play about the courageous work that has been done to bring about a just nation.

As an Alamedan, educator, and playwright, Dr. Acker has wanted this work to be performed for residents, students and teachers in Alameda, to help them learn the history and give them a safe place to begin discussions about how their lived experiences may be shared and compared. We hope they will have words that make a difference in our community and in their lives.

As such, the play, Words That Made the Difference, lifts up her expertise, to create an honest historical work that involves the exact words of the court cases, bringing them to light and enlightening their powerful message. The background work of all of the court cases was done by Dr. Acker and Sarah McArthur LeValley, former executive of Disney and Pixar.

The playwright and several actors are based in the city of Alameda, and Dr. Acker is head of school of The Child Unique Montessori School in Alameda. According to USA Data, the city of Alameda is comprised of this racial demographic: White (Non-Hispanic) (41.3%), Asian (Non-Hispanic) (31.1%), Two+ (Non-Hispanic) (6.88%), Black or African American (Non-Hispanic) (6.76%), and Two+ (Hispanic) (4.98%). Dr. Acker's schools have a range of ethnic and socio-economic backgrounds. When WORDS has been performed in Alameda before, the audience encompassed many older, White Alamedans and several Asian and biracial individuals. The play, Words That Made the Difference: Brown v Board of Education, is the focus of a multi-faceted program with a dual objective. Via the arts, students will learn history of the landmark case of desegregation and how the reversal of Separate but Equal changed the nation.

In the article, Integrated Schools: Segregated Curriculum, Walsemann and Bell (2011) posit that in-school segregation still exists on many levels; hence, segregation still affects teens. Presenting the cases of Brown and the continued effects of differing types of segregation opens an avenue of discussion for students who experience separation and segregation, leading to isolation, loneliness, and other mental health issues.

Why is this so important now? The present administration is no longer requiring an explicit prohibition of segregated facilities in new government contracts. The rollback of segregation protections threatens progress, making education vital to recognize inequities, challenge discrimination, and build an inclusive Alameda. At a time when the ban on segregation is being questioned, it is a crucial time to examine the importance of the history of justice, including the changing demographics of people in our nation, our state, our community, our very own city.

#### **GOALS**

GOAL 1: Use the Arts to Provide Accurate Historical Information Objective: Provide historical education on equity in public education and the courage of those who paved the way for integrated schools. Students and residents will learn how segregation shaped Alameda's schools, housing, and opportunities, with lasting effects today. Outreach to schools, senior centers, and community groups will foster dialogue and inspire a more inclusive Alameda.

Alfred Spielmann (Chief Justice Earl Warren) was born in the Bronx, New York in the 1960s. He graduated from University of California School of Law, San Francisco and worked for 25 years as a criminal defense trial lawyer.

Rebecca Pingree, was born and raised in Alameda, and is a well-known actor.

Brionna Robinsons, was raised and lives in Alameda, and is a well-known actor, having won awards at Alameda High School.

Is there an intended audience for this project? If yes, how will you engage them?

Segregation in California schools affected many communities, including African Americans, Mexican Americans, Japanese Americans, and Native Americans. Until Méndez v. Westminster (1947) and Brown v. Board of Education (1954), many students of color were denied equal education through legal and local policies. Those born before 1942—now 83 years or older—may have attended segregated schools in California, experiencing firsthand the challenges of racial exclusion in education. To honor these lived experiences and educate the broader community, we will engage in extensive outreach. This includes partnering with Mastick Senior Center, senior citizen homes, and local religious centers to connect with elders who experienced segregation. We will collaborate with Alameda Community College, K-12 schools, and local law schools to provide historical context and spark discussions on civil rights and education. Community engagement efforts will also include panel discussions, post-play dialogues, and visits to historical and cultural institutions to ensure a diverse audience gains insight into the impact of segregation. By bridging generations through these connections, we aim to foster a deeper understanding of history and inspire ongoing efforts toward equity in education.
