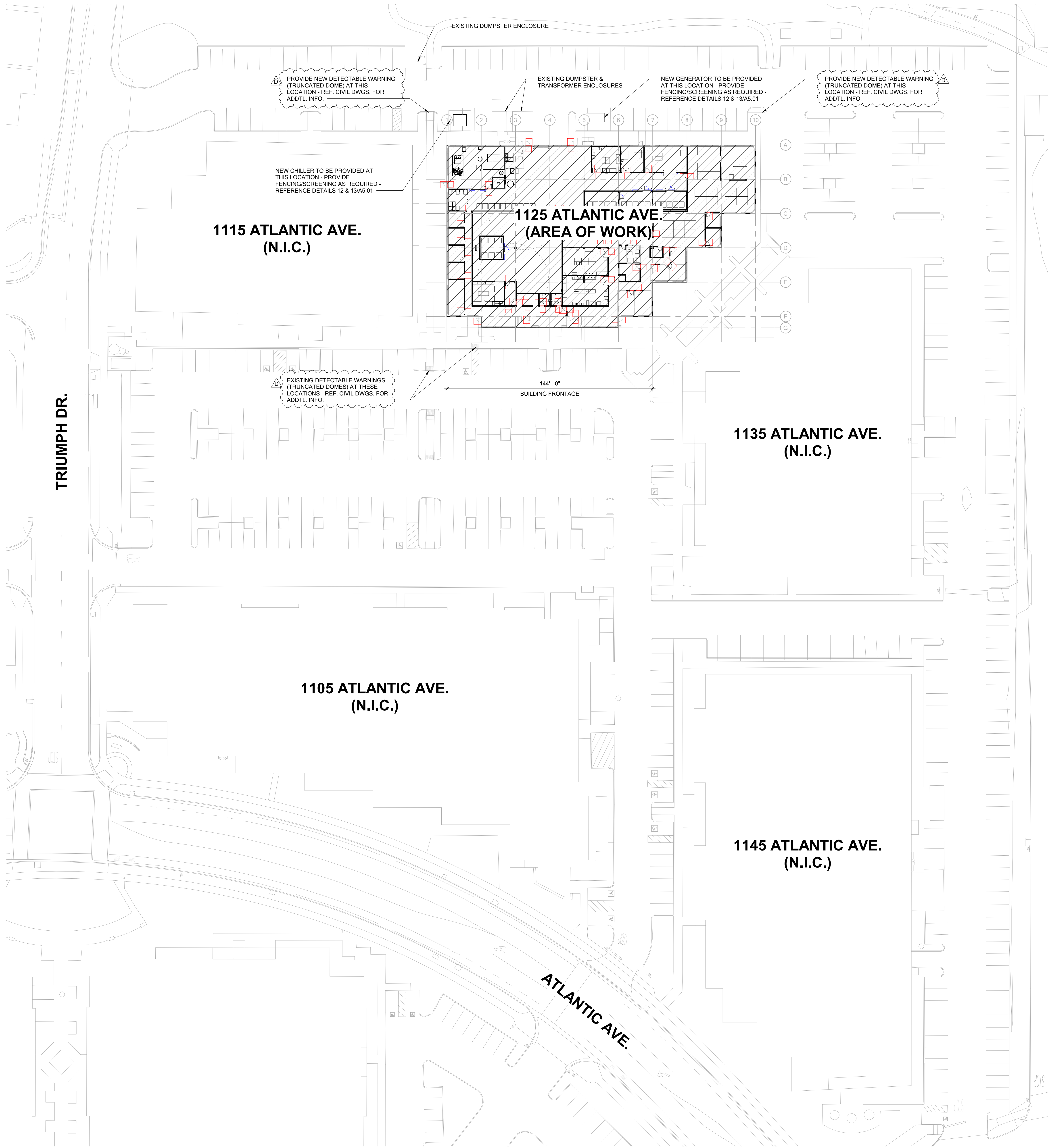

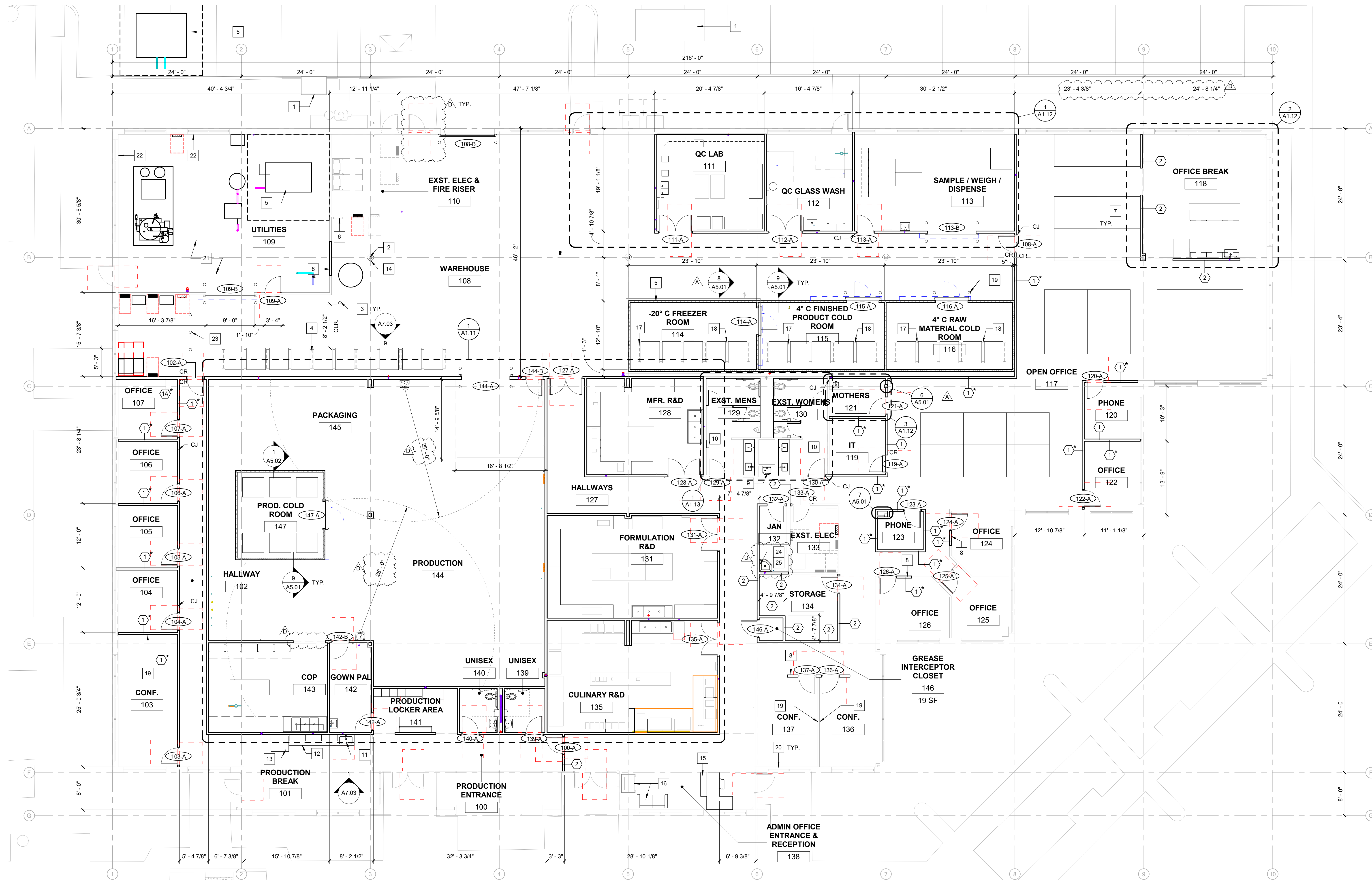

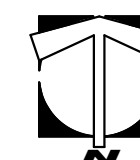

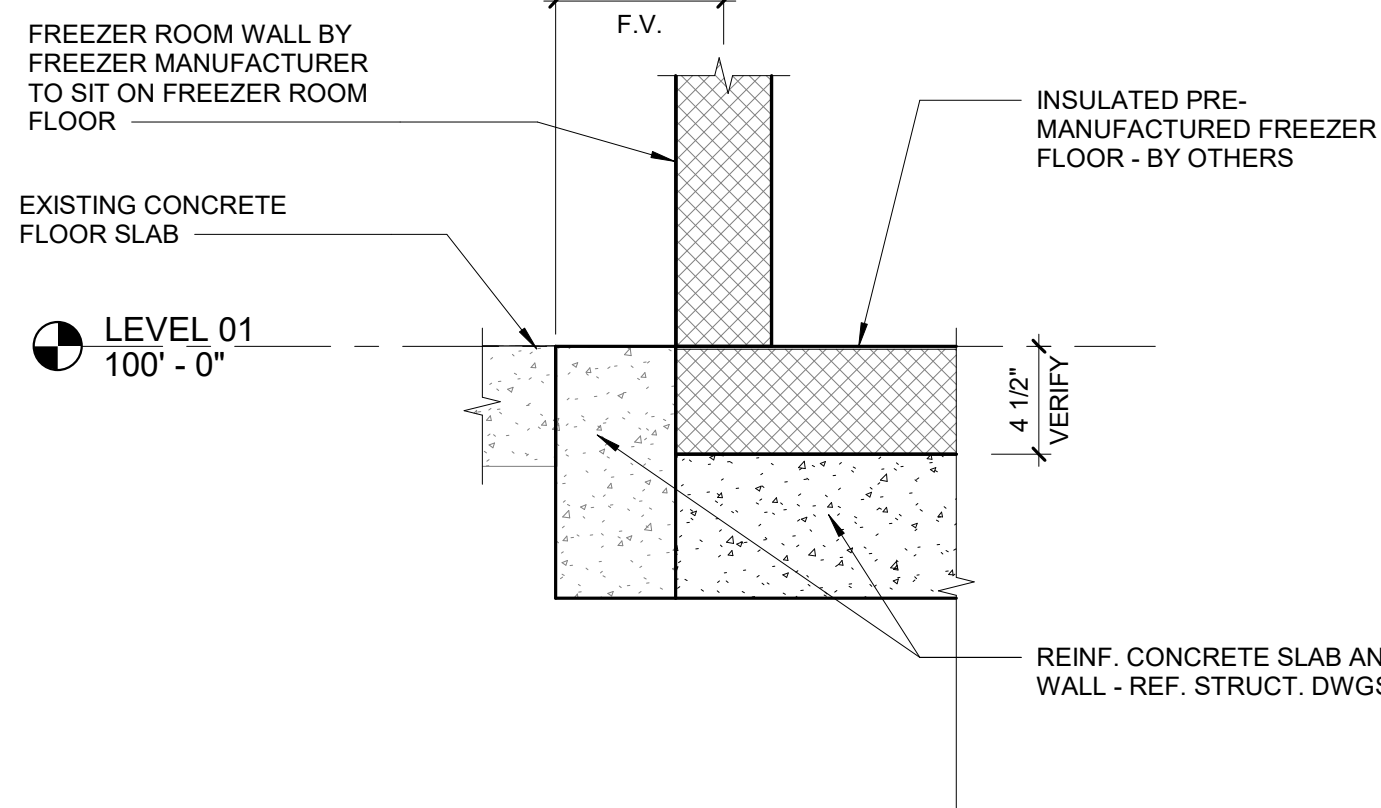

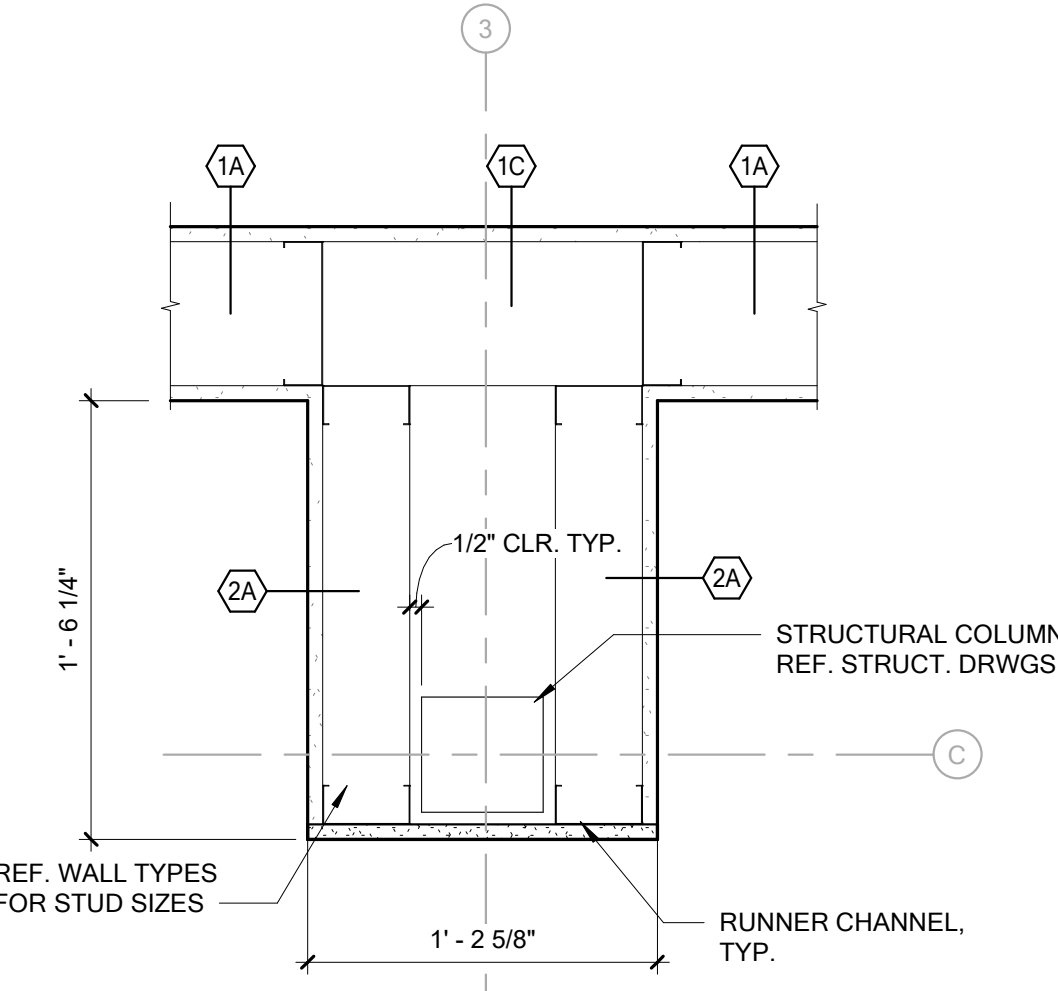

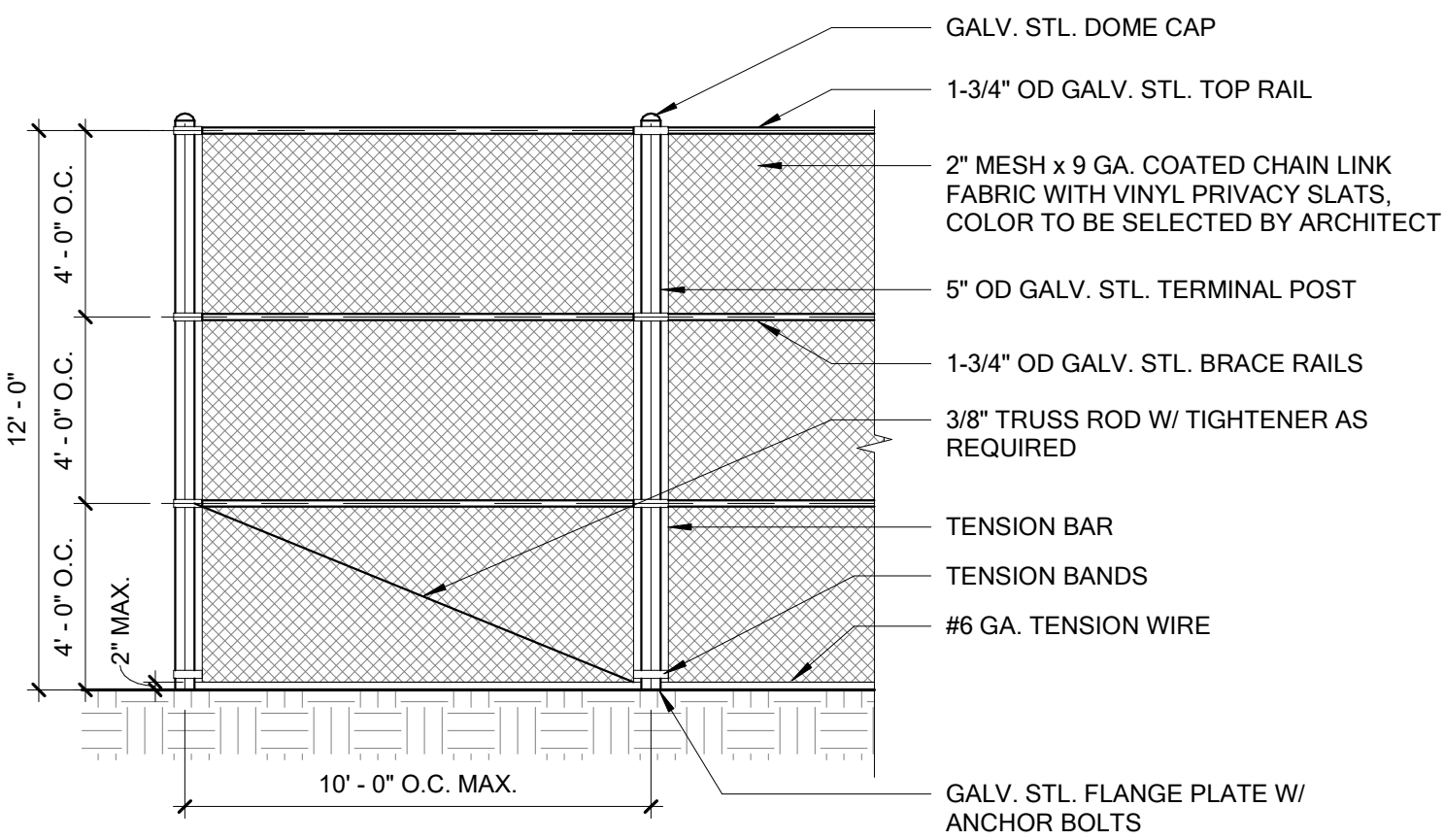

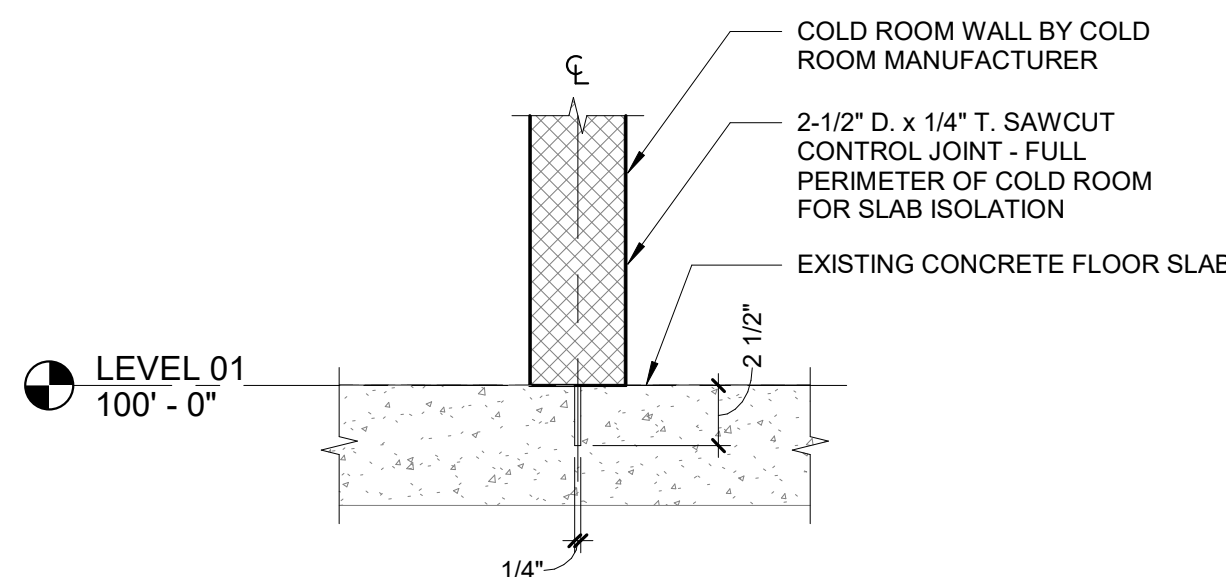

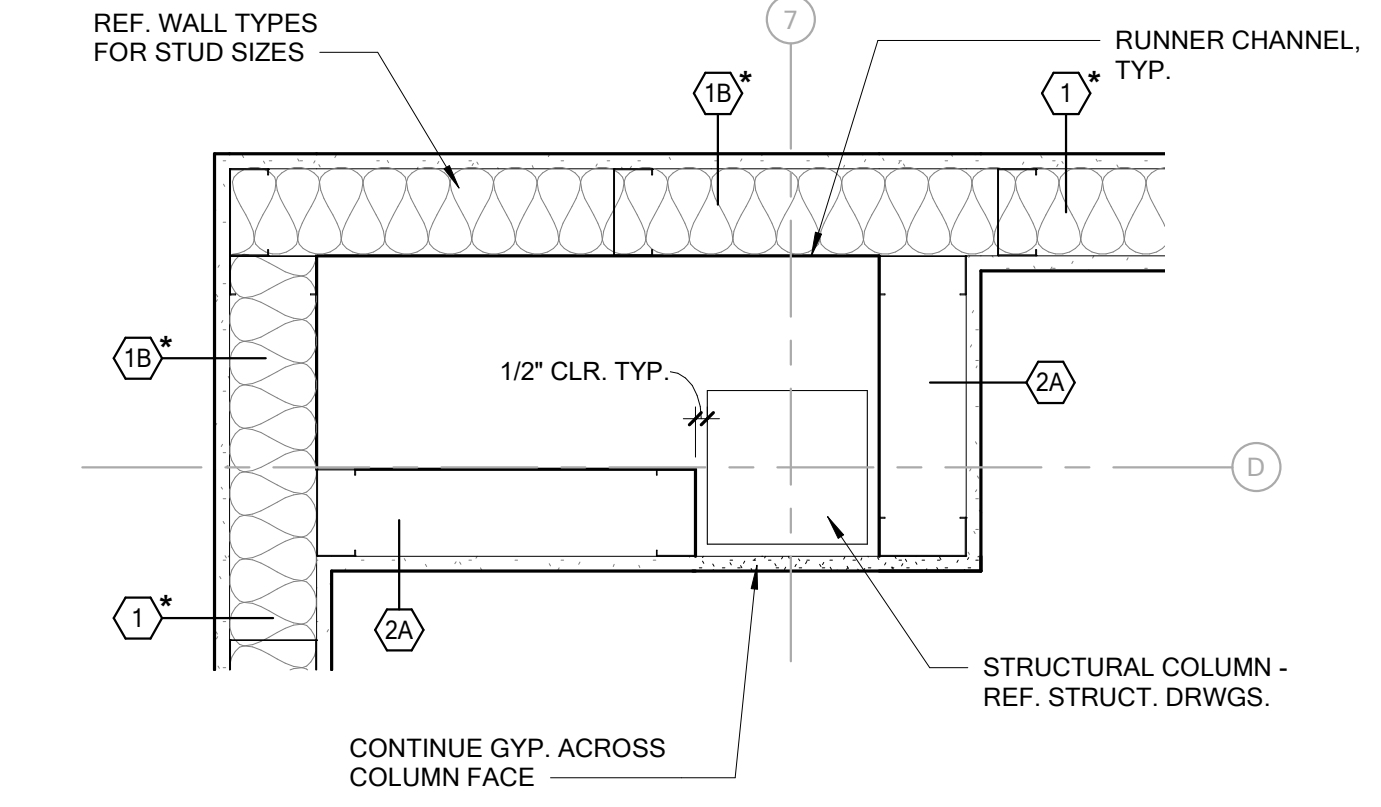

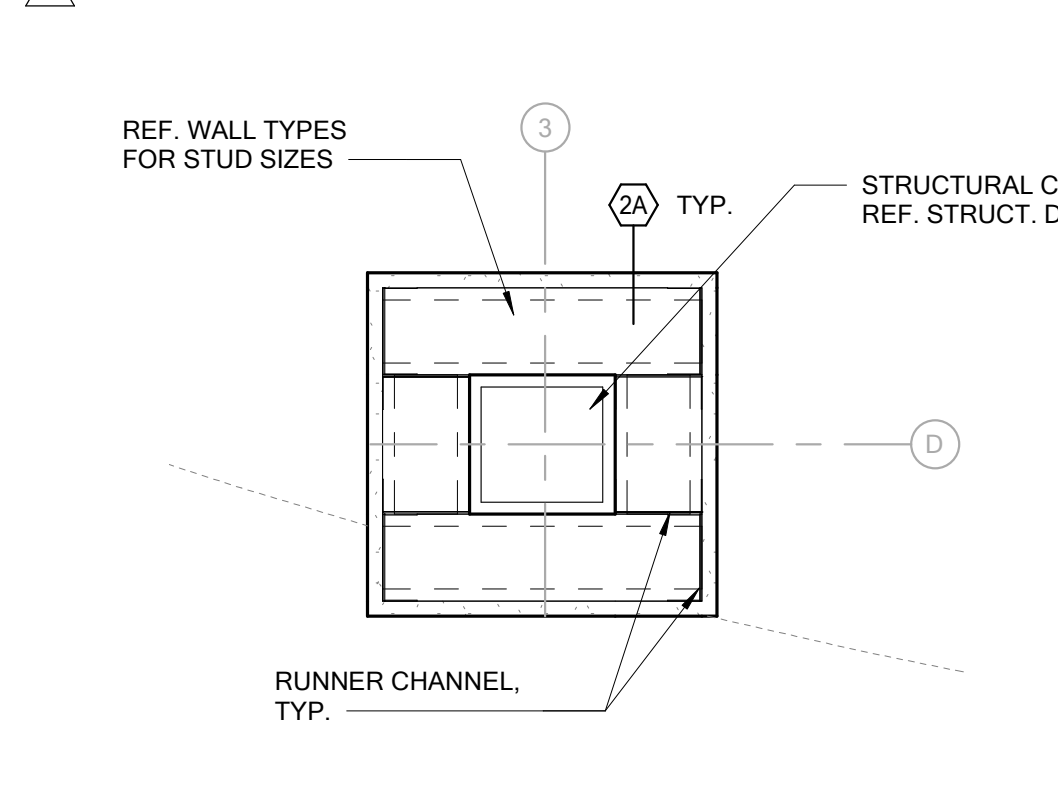

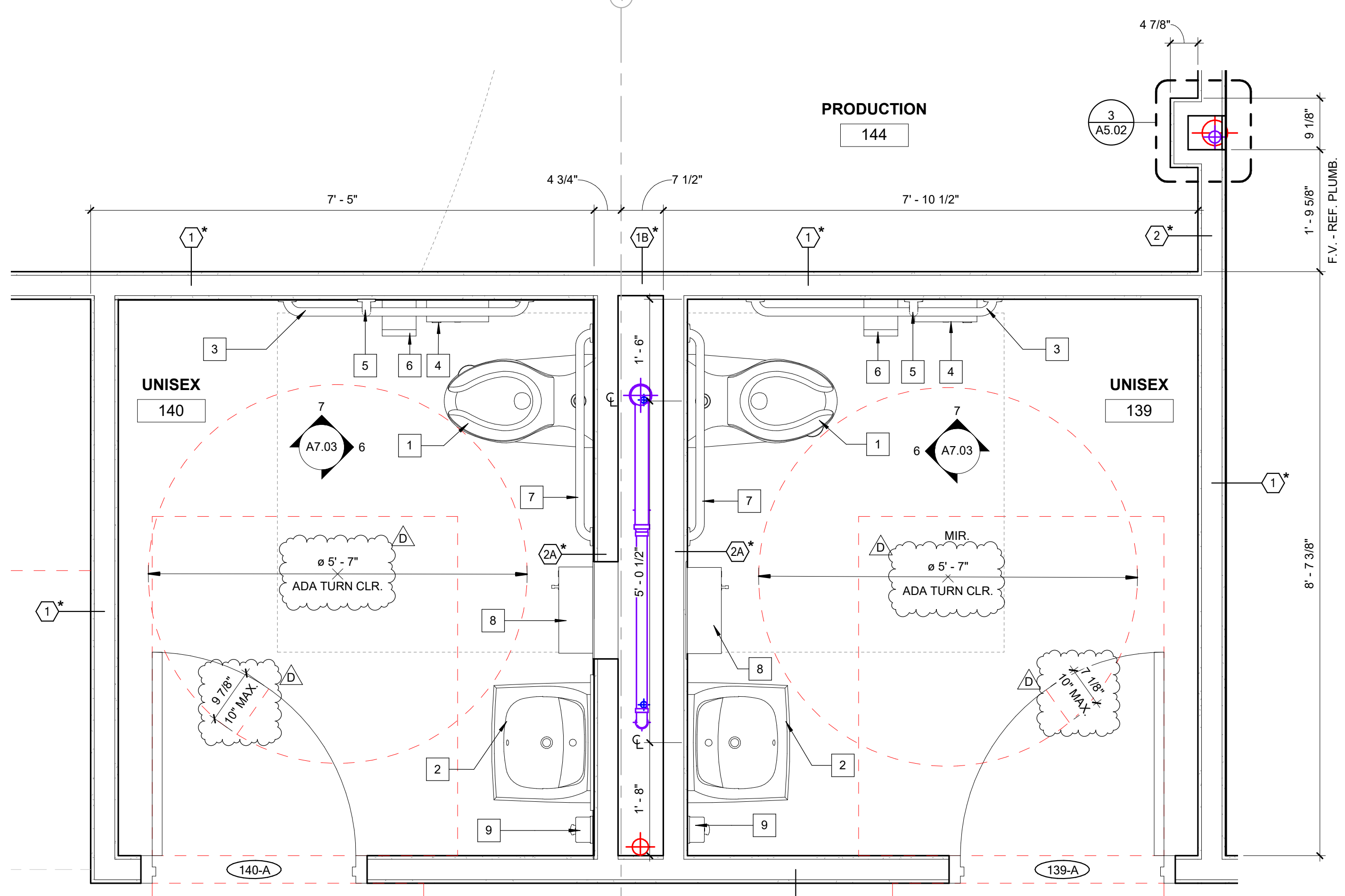

**ENLARGED BATHROOM PLAN**

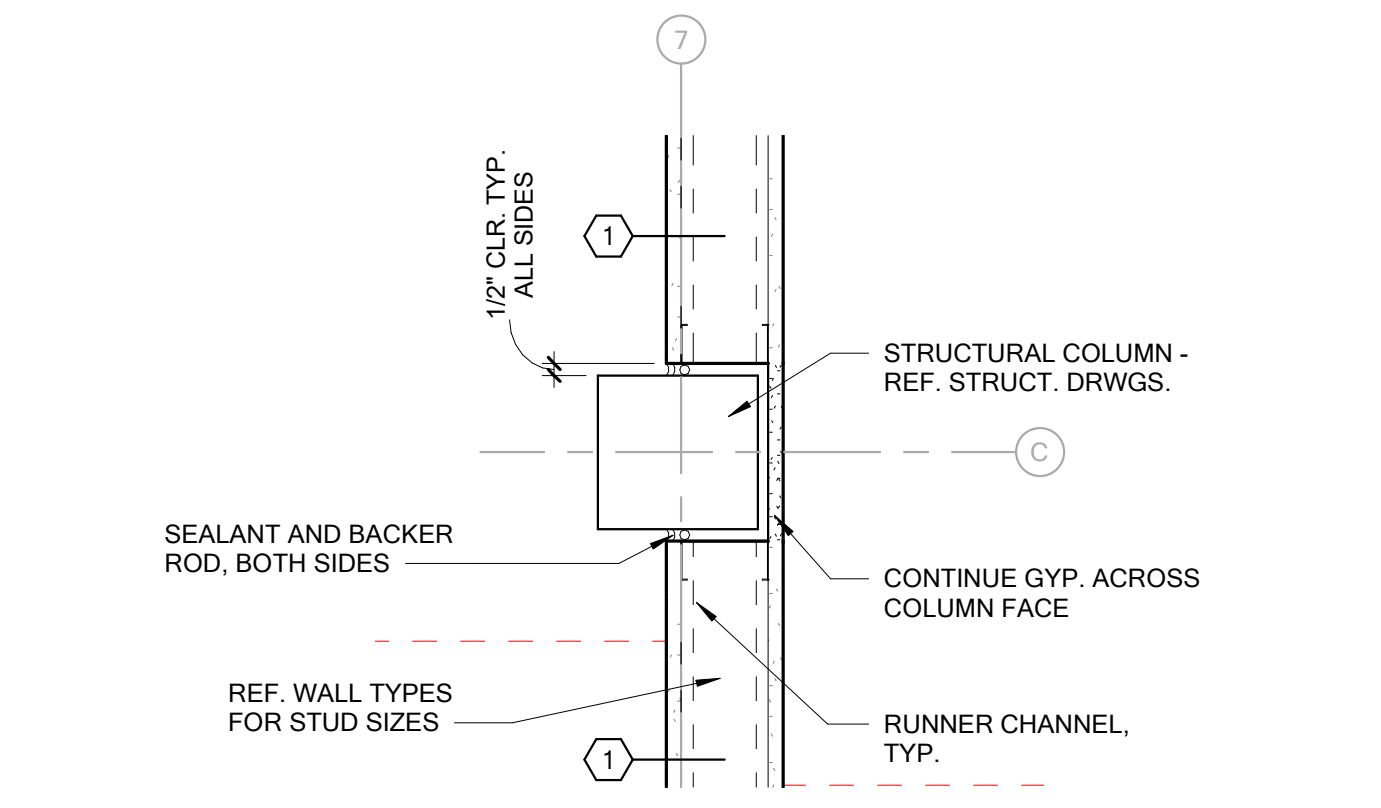
