Public hearing to consider Design Review to construct a 10,000 square foot pre-engineered metal warehouse attached to an existing building, which is a Non-Contributing building within the NAS Alameda Historic District. The project will provide new on-site landscaping, including a landscape buffer between the public sidewalk and redesigned parking lot and planters with shade trees in the parking lot.
