



## ALAMEDA RECREATION AND PARK COMMISSION MINUTES FOR REGULAR MEETING

The following are action minutes in keeping with the Sunshine Ordinance 2-91.17.

### 1. ROLL CALL

Present: Chair Alexander, Vice Chair Swartz, Commissioner Burney, Commissioner Radez and Commissioner Robbins

Absent: None

Staff: Alameda Recreation and Park Department (ARPD) Director Justin Long, ARPD Office Assistant Donna Conde

Chair Alexander asked if anyone in the audience would like to speak for three minutes regarding a matter that is not on the agenda. There was no non-agenda public comment.

### 2. NON-AGENDA PUBLIC COMMENT

- None

### 3. STAFF COMMUNICATIONS

Recreation and Park Director Justin Long gave the Director Report. See Exhibit 1.

### 4. COMMISSIONER COMMUNICATION

- Commissioner Burney: Shared that he recently completed a triathlon and had been resting instead of training in the parks. Thanked Director Long and ARPD Staff for the hard work put into the Aquatic Center referring to the Recreation and Park Commission meeting held on September 12, 2024.
- Commissioner Radez: Asked Director Long how community members submit maintenance requests and if he monitors the "See Click Fix" system. Director Long responded that maintenance staff actively monitor the system, receive email notifications, and assign tasks accordingly. Commissioner Radez shared that he had spent most of his time coaching Little League Baseball since the last meeting. He recognized adults, volunteers, and city staff for helping kids learn life lessons through recreation. He volunteered for a coastal clean-up on September 21, 2024.
- Commissioner Robbins: Asked about land expansion at City View Skate Park. Director Long replied that there is an adjacent paved parking lot and room to grow, determined by the budget and community input. Commissioner Robbins, on behalf of the Recreation and Park Commission, attended the Alameda Municipal Power meeting on September 16, 2024, the City Council meeting on September 17, 2024, the Alameda Education Foundation Fundraiser at The Rake, the Blues, Brews & BBQ event on September 22, 2024 and Alameda Pride at Chochenyo

Park on October 5, 2024. He urged the community to go to the Annual Holiday Boutique, November 2 and 3, 2024 at Albert H. DeWitt Officers' Club, as partial proceeds go towards the ARPD Scholarship Fund.

- Vice Chair Swartz: Asked if a vendor has been chosen for the ARPD work order system. Director Long shared that ARPD is researching Cartegraph, a system that is user-friendly for field staff. Vice Chair Swartz participated in the Alameda Friends of the Parks Family Fun Ride on September 14, 2024 and thanked organizers for a great event. Thanked ARPD Aquatic Staff for working during the unusually hot weather.
- Chair Alexander: Congratulated Commissioner Burney on completing his triathlon. Thanked Vice Chair Swartz for leading the September Recreation and Park Commission meeting. She stated that as she had been traveling and not able to attend, she felt it was not appropriate for her to disclose her vote and make her final decision known regarding the Aquatic Center until all public comment and communication had been heard. She went to the City of Alameda Employee Appreciation Event at Jean Sweeney Open Space Park on September 12, 2024 and was proud to represent the Recreation and Park Commission in honoring and celebrating Pat Russi and his 40 year anniversary with ARPD. She acknowledged him single-handedly reviving the Fourth of July Parade after the pandemic. She thanked ARPD Staff for a great summer and acknowledged the work being put into the Winter Spring 2025 Activity Guide.

## **5. MINUTES**

Vice Chair Swartz moved to accept the minutes of the September 12, 2024 Regular Meeting as presented.

M/S Vice Chair Swartz / Commissioner Robbins. All who were present at the September 12, 2024 meeting were in favor with four ayes via roll call vote.

## **6. REGULAR AGENDA ITEMS**

**6-A** Recommendation to modify and update existing Tennis and Pickleball policies (Exhibit 2) and make the trial pickleball courts at Leydecker Park permanent.

ARPD Director Justin Long presented on the Tennis and Pickleball Policy Update, Tennis Rule Modifications, Pickleball Rule Modifications, and Signage Updates.

### **Public Comments**

- Speaker Carter Chapman: Thanked Director Long for his hard work in expanding pickleball in Alameda. Addressed tennis courts being restricted to "Tennis Only". Believes that broader needs of community, inclusivity, and benefits of multi-use recreational spaces are overlooked. Mentioned courts as a space for children to learn to bicycle ride if they do not have a driveway, sidewalk, or street. Spoke of unnecessary conflicts among community members instead of focus on cooperation and connection in shared outdoor spaces.
- Speaker Rod Harris: Alameda resident. Commented that pickleball expansion at Leydecker Park has been a success and is glad its permanency is being considered. Encouraged as much public access to parks that is practical and possible.

- Speaker Ann Haslup: Thanked Director Long for great work. Stated that there is a definitive change and less conflict with regards to the “Tennis Only” signage. Believes tennis and pickleball can coexist but sports require different nets and court lines. Mentioned possibility of using defunct courts throughout Alameda, such as those at Ballena Bay.
- Speaker Ken Fagel: Alameda resident and homeowner. Stated that Washington Park Tennis Courts are a longstanding location for tennis players, they are busy enough and pickleball players need to find their own courts. Agreed that added pickleball courts at Leydecker Park were helpful.
- Speaker Charlie DeWett: Captain of USTA Teams. Thanked Director Long and ARPD Staff for hard work and signage at Washington Park. Shared that he had been involved in police reports regarding pickleball and tennis conflict. Said there have been no issues since signage has been posted. Stated that pickleball play next to tennis is extremely loud, distracting and disruptive, it is a good sport but needs to be played in an isolated space with its own facilities.
- Speaker Brian Tremper (online): Thanked the Recreation and Park Commission and ARPD Staff for their hard work and opening up Leydecker Pickleball Courts. Commented that it has been helpful in improving the wait times at Lincoln Park and requested that all courts be open later, if possible. Encouraged building more courts at Alameda Point.
- Speaker Richard Thomas (online): Stated that he does not understand need for bifurcation and questioned enforcement of rules. Believes access to resources should be shared between pickleball and tennis.
- Speaker Teri Rose (online): Registered under Joseph Bagliari because her computer was not working. Thanked Director Long for his hard work, listening, allocating the space at Leydecker Park, and extending court hours through the winter. Commented on him being level-headed, inclusive and an exceptional pleasure to work with. Grateful for added court space, however, not pleased with exclusivity of Washington Park and felt blind-sighted by “Tennis Only” signage.

### **Commissioner Comments**

- Commissioner Burney: Asked if a practice wall will become available for pickleball players. Director Long replied that there is a pickleball practice wall at Lincoln Park. Commissioner Burney emphasized using common sense and consideration regarding court use. Director Long clarified that all court rules are enforced equally for everyone. He encouraged using other non-vehicular park spaces such as Seaplane Lagoon and Bohol Immigrant Circle Park to practice bicycle riding.
- Commissioner Radez: None.
- Commissioner Robbins: Asked about the practice wall at Washington Park. Director Long responded that City Council gave the directive that Washington Park is established as a “Tennis Only” facility, this includes the practice wall. Asked about the tennis court rental process and if 14 days can be shortened when obtaining a rental permit. Director Long stated that he and ARPD Staff will look into modifying the number of days to obtain a rental permit. Commissioner

Robbins inquired who to contact when disagreements occur regarding court use. Director Long responded that users contact the ARPD main line 510-747-7529 during business hours and the number listed on our website after hours. He recommended calling the non-emergency police line for escalated events and 911 for emergencies. He explained that there is a weekend park ambassador that checks for permits and rentals, reducing any potential conflicts. The tennis court signs have QR codes which can be scanned to verify court rentals. Commissioner Robbins shared that he is a USTA Captain and president of the Gay and Lesbian Tennis Federation which play in Alameda and Oakland. The only time there are court issues are on the weekends when certain organizations take three allocated courts and three courts for practice and refuse to share. They rotate amongst other players within their group and do not leave the courts. He is hopeful the signage will deter misuse of the courts. He suggested that the after hours phone number be posted on signage. Reiterated that the Recreation and Park Commission can help channel any issues, but City Council makes final decisions. Emphasized that if the community wants to make changes to sports facilities, then funding and raising taxes is required.

- Vice Chair Swartz: Recapped that there are no court rules being changed, only clarification of the court rules. Emphasized the message of the signage is the prioritization of designated courts for specific use. Agreed with the speaker who encouraged comraderie between not just pickleball and tennis players but all community members.
- Chair Alexander: Asked about the time clock rules at the tennis courts. Director Long responded that it is required to use the time clocks. Chair Alexander shared her concern about enforcement of the court rules. Made reference to public comment and stated that changes could be made to courts, such as those at Ballena Bay, if funding was available. Asked Commissioner Robbins how often he encountered pickleball players trying to play at Washington Park. He replied “never”. She asked Director Long for clarification regarding court use for tennis groups and the public. He responded that 50% of court space available is the maximum allocation for any group. Washington Park has six tennis courts available in which three of those courts are allocated to USTA at any given time for practices and matches. Currently, there is an exception for Alameda High School to use all six courts due to the school’s tennis courts closure. Chair Alexander requested clarification on the signage, and Director Long responded that City Council had made the decision stating that the Washington Park Tennis Courts are for “Tennis Only”. All other rule modifications are for the Recreation and Park Commission to approve for ARPD.

## **MOTION**

Commissioner Radez motioned to approve the modification updating the existing Tennis and Pickleball policies and make the trial pickleball courts at Leydecker Park permanent.

Commissioner Robbins made the amendment to include the after hours phone number at the tennis courts.

## **6-B Nominate and Vote on Recreation and Park Commission Chair and Vice Chair**

## Commissioner Comments

- Commissioner Burney: Asked Commissioner Radez and Vice Chair Swartz if either of them wish to be Chair, and both replied that they would step forward if needed.
- Commissioner Radez: Appreciated Chair Alexander for being an excellent example during her tenure. Offered himself to become the Chair of the Recreation and Park Commission and shared that his personal and professional experiences would contribute to the role. He is passionate about recreation and facilities in the civic life of our community and the assurance that programs are widely accessible, broadly programmed, and affordable for the public. He would see his role as Chair as ensuring that the Recreation and Park Commission is a sounding board for ARPD and a vehicle to hear community voices and concerns. He stated that he would be happy to step forward as Chair should the need exist or support a different Chair if that is the outcome.
- Commissioner Robbins: Recommended Vice Chair Swartz for the Chair position and Commissioner Radez for the Vice Chair position. Thought it to be a natural progression. Commented that Chair Alexander had done a phenomenal job of staying impartial and helping lead discussion. Shared that commissioners must listen, and it is inappropriate to promote own values, discuss information from their individual perspective, or sway public opinion too much. Chair Alexander thanked Commissioner Robbins for the compliments and said it is okay to have strong opinions but listen to the public, the staff report, and what is best for the community.
- Vice Chair Swartz: Thanked Commissioner Robbins for the recommendation to become the Recreation and Park Commission Chair. Thanked Chair Alexander for her knowledge and leadership. Stated that, as current Vice Chair, he feels well-prepared to step into the role as Chair. Glad to support fellow commissioners interested in the Chair position as there will be future opportunities.
- Chair Alexander: Shared that she took the position as Chair when there was a change of leadership at ARPD. Director Long thanked Chair Alexander for all her years of service and staying on an additional year. He spoke of the importance of the role to help guide the Recreation and Park Commission to prepare and develop our park system in a responsible way. Chair Alexander expressed that the role takes time and effort. She met and had discussion with the ARPD Director prior to each meeting. She attended as many ARPD events as possible as the job entails being out and listening to the public. She made recommendation that Commissioner Radez be the Recreation and Park Commission Chair and Vice Chair Swartz remain Vice Chair.

## MOTION

Chair Alexander motioned to recommend that Commissioner Radez be Chair and Vice Chair Swartz be Vice Chair for a year, then follow with the Vice Chair becoming Chair.
