3-A 2019-7492 CONFERENCE WITH LEGAL COUNSEL - LIABILITY CLAIMS

CLAIMANT: James Howley

This matter involves a claim filed by Mr. James Howley against the City of Alameda and its police department alleging 1) false arrest, 2) excessive force, and 3) unreasonable search and seizure. The claims generally relate to APD officers' efforts to protect Mr. Howley and prevent him from committing suicide on February 18, 2018. The City maintains that APD Officers acted in accordance with all applicable laws and policies. Nonetheless, in order to avoid the expense and uncertainty of litigation, the City Council authorizes the City Attorney to settle this matter with Mr. Howley in an amount not to exceed \$50,000.
