The property is located within the C-C (Community Commercial) zoning district where athletic clubs and business operations occurring between 10:00 p.m. and 7:00 a.m. require use permit approval. This project is categorically exempt from the California Environmental Quality Act (CEQA) per Section 15301 permitting use of existing structures that involves negligible expansion of existing use.
