PLN18-0277 - 651 West Tower Avenue (Alameda Point, Building 91) - Applicant: Almanac Beer Company, LLC. A public hearing to consider an amendment to Use Permit No. PLN16-0115 to allow the expansion of an existing 1,200-square-foot outdoor seating area by approximately 2,400-square-feet. The project also includes operation of a food truck as part of the outdoor patio area. The property is located within the AP-AR, Alameda Point - Adaptive Reuse Zoning District. The property is a contributing structure within the Naval Air Station Historic District. The Alameda Point Final EIR (State Clearinghouse No. 201312043) evaluated the environmental impacts of redevelopment and reuse of the lands at Alameda Point.
