- 3-A** [2019-7023](#) PLN19-0117 - Design Review & Variance for Accessory Structure - 2701 Washington Street - Applicant: Angie Klein. Public hearing to consider Design Review and Variance to allow the construction of an approximately 180-square-foot accessory building located in the rear-yard of an existing single-family home. The variance is requested to allow the accessory building to have a 69-foot setback from the front property line where a 75-foot setback is required. The variance is also to allow a 42-percent main-building coverage where 40-percent is the maximum main-building coverage for the property under the R-1 zoning district. The Design Review application also includes replacement of an existing garage door with wood carriage house doors as part of relocating an existing parking space to the rear-yard.
