What is the Point in Time (PIT) Count?

- A count and survey of sheltered and unsheltered people experiencing homelessness on a single night in January
- Required by HUD; informs funding that the county will receive for homeless services
- This year will be on **Tuesday January 25, 2022**



How was the PIT Count Previously Done?

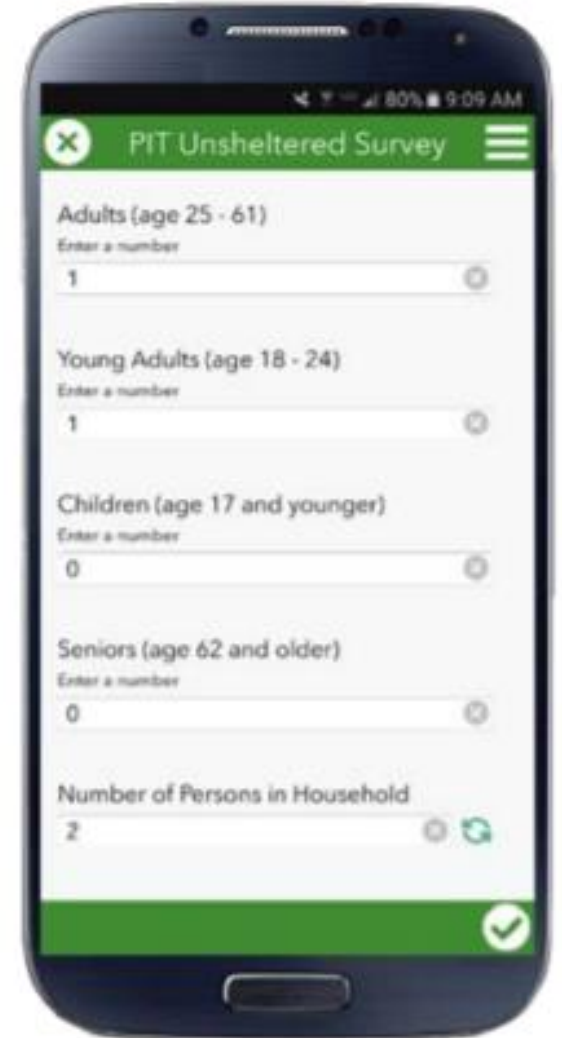


- Teams walked/drove through and observed every census tract in Alameda County to count those that are unsheltered
- Guides that are currently homeless or recently homeless partnered with community volunteers to ensure EveryOne Counts!

Considerations for the 2022 PIT Count



- Careful considerations related to **COVID 19** safety protocols are being developed by all planning partners
- New technology will be utilized this year including a **phone app** to collect data



Considerations for the 2022 PIT Count

- **Outreach teams and guides** will cover as many census tracts as possible in areas they are most familiar and that have higher concentrations of those experiencing homelessness
- **Guides** (those currently experiencing homelessness or recently homeless) will be paired with staff they know
 - Recruitment will begin in January
 - Guides are paid for their work and training
- **City and regional coordinators** are working closely with the planning team and outreach programs

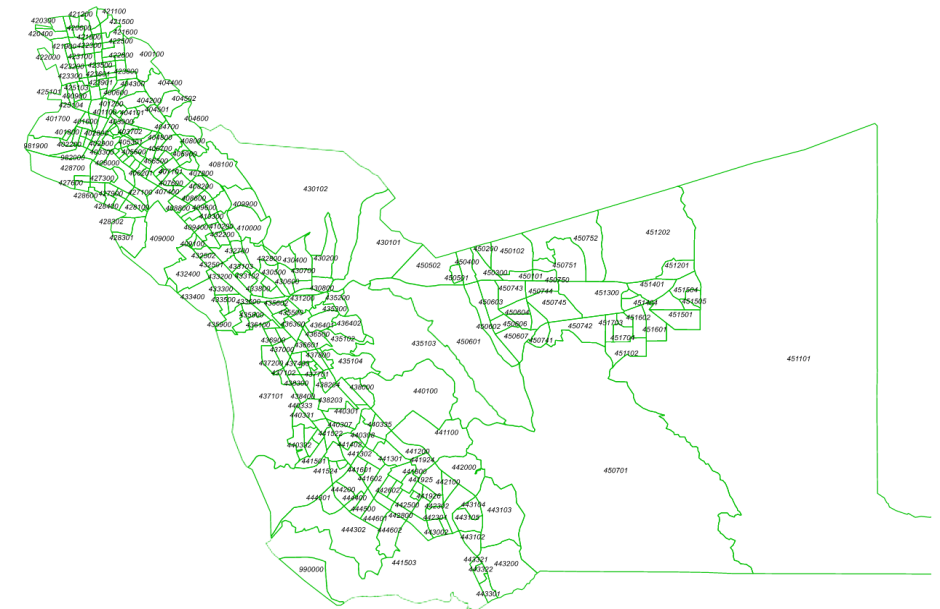


COVID 19 Considerations

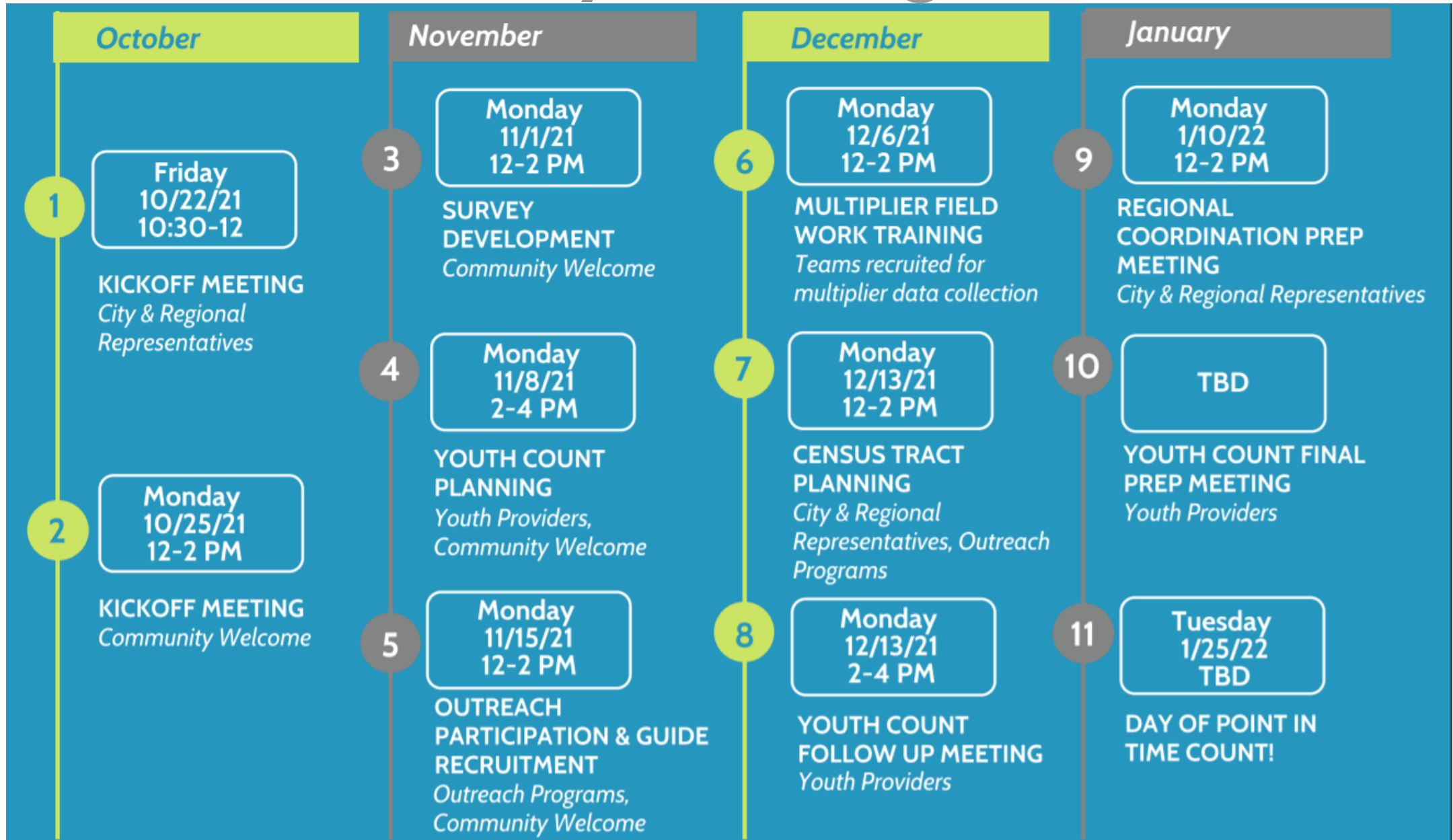
- The Planning Team continues to monitor COVID trends and is finalizing the COVID policy for the count with the Alameda County Health Department.
- Adjustments to increase safety and comfort include:
 - Virtual deployment
 - Volunteers signing up in “pods” and preselection of census tract
 - Guides working only with those they know and are comfortable with for the count

Community Volunteers

- Community volunteers will identify the remaining census tracts of their preference online and will be asked to **sign up in teams or “pods”**
- Official link to sign up will go live in **December.**
- Deployment will happen **“virtually”** in order to prevent large gatherings of individuals

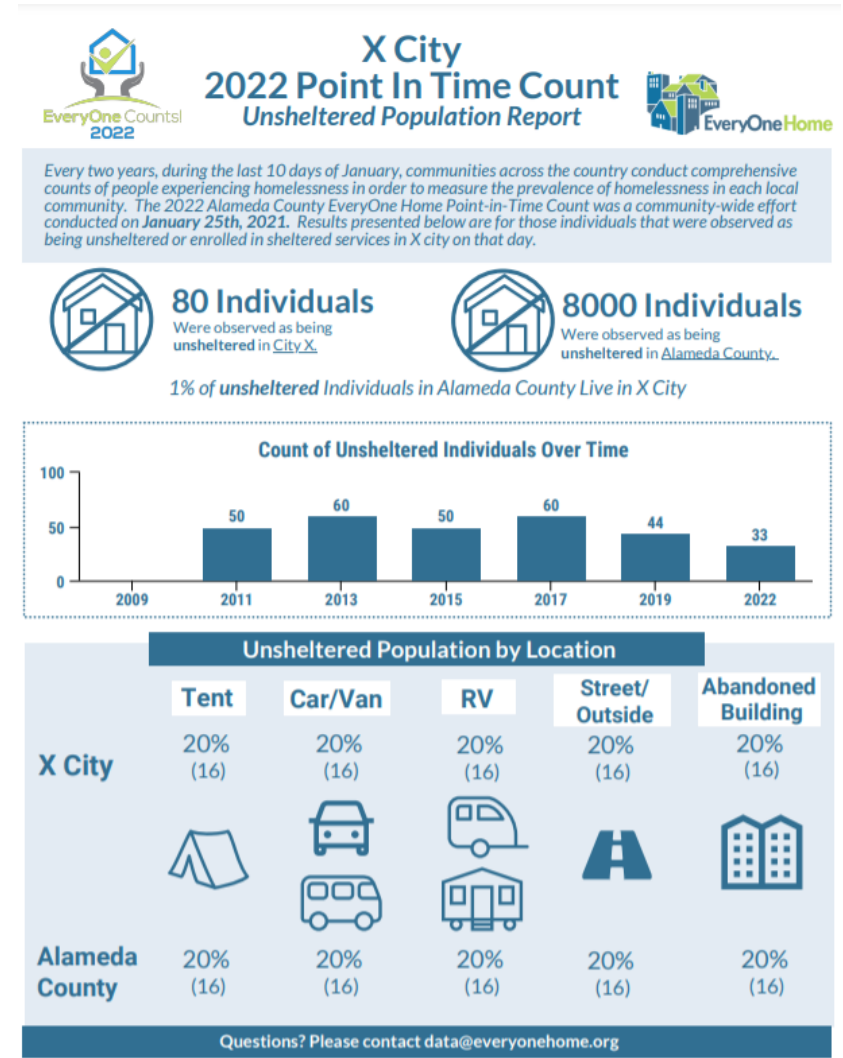


Community Meeting Timeline



PIT Count Report Options

- EveryOne Home will be providing to all cities/jurisdictions a simple infographic report of the unsheltered and sheltered count (if the city/jurisdiction has shelter programs) free of charge
- ASR is offering a range of other reports for purchase depending on preferred report type



X City 2022 Point In Time Count Unsheltered & Sheltered Report

Every two years, during the last 10 days of January, communities across the country conduct comprehensive counts of people experiencing homelessness in order to measure the prevalence of homelessness in each local community. The 2022 Alameda County EveryOne Home Point-in-Time Count was a community-wide effort conducted on **January 25th, 2021**. Results presented below are for those individuals that were observed as being unsheltered or enrolled in sheltered services in X city on that day.



80 Individuals

Were observed as being unsheltered in X City.

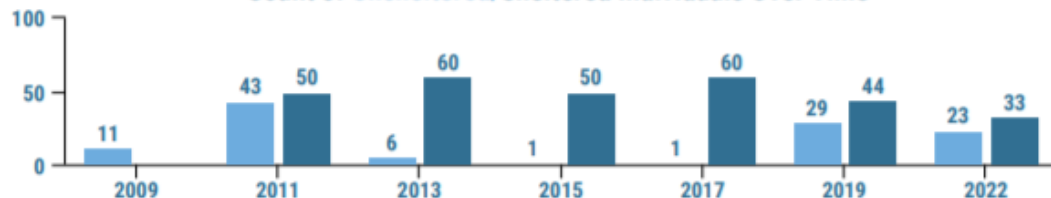


8000 Individuals

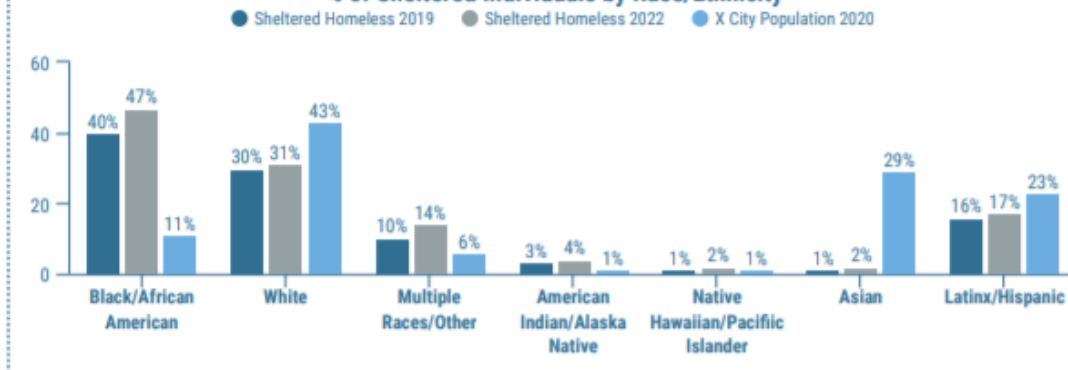

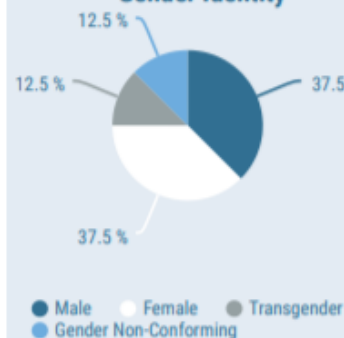
Were Enrolled in Sheltered Services in Alameda County.

% of Sheltered Individuals by Race/Ethnicity



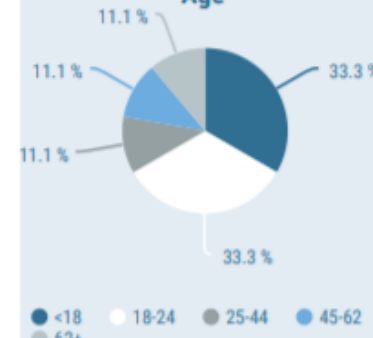
