Hi Amy,

Thank you for sending this update. I wanted to share a concern about this location as I am both a dog owner who is supportive of a new dog park as well as a basketball player who plays on the Leydecker basketball court frequently. I am concerned about the location of this dog park being too close to the basketball court. The basketball court is highly utilized by community members, and with the proximity of the dog park to the basketball court, the dogs will be overstimulated from the basketball action and the dog activity/barking will in turn distract the basketball players.

If the height of the fence of this dog park will be similar to the height of the fence at the Washington dog park, there will be high chances that the basketball will accidentally get thrown into the dog park and injure dogs. The basketball often gets accidentally thrown into or bounces off the backboard into that lawn location without a dog park there today.

Furthermore, as a small dog owner, I am concerned about there not being separate dog parks for small and large dogs. I am concerned that community members will not respect separate days for different dog sizes.

I would like to propose the location of the old children's park next to the other side of the library as the location for the dog park if we are opening one up at Leydecker.

Additionally, instead of another dog park at Tilden way, are we still considering Towata park? Towata is an underutilized park (versus a very utilized location at the basketball court at Leydecker).

If you would let your board know that my board is still opposed to the dog parks being located at Leydecker, it would be helpful, and you won't need me to come and talk and slow down your meeting.

The CHBIOA Board believes it is premature to transition Leydecker to dog parks. A decision to transition should not be considered in a vacuum, but instead with the city's new housing element and upcoming general plan. The Board further believes that once the housing units are built the park, as it is, will be needed since most developments are required to provide green belts and parks. Lastly, they believe the park should be left as is until after it is determined exactly how many housing units will be placed within the shopping center.

Hi Amy,

Thank you for your update on the dog park. I believe this is the first public update since the meeting in January, so I wanted to share a few thoughts I had. As someone that both uses the Leydecker basketball courts and has a dog, I have some concerns in both regards.

As a user of the basketball court, I believe this court is probably the second most popular in alameda after Washington, so I am concerned about how placing a dog park only feet away from the court would impact the experience of using the court. I can say confidently that, if my dog were in the park, he would run along the fence barking and chasing the basketball only feet away from the players, which would be quite a nuisance. This would have a major impact on the usability of the court, not to mention that a high fence (at least 8-10ft) would be an absolute must.

As a dog owner, I am most concerned about the idea that this would be a shared park, with certain days designated for different size dogs. I am quite confident that this rule would be entirely ignored, forcing many small dog owners like myself to basically accept that it is a mixed use park or we just don't use it altogether.

I read the staff report in your email and I wanted to offer some brief thoughts on the previously discussed locations. At Leydecker, I understand the concerns of the church, synagogue, etc. with respect to noise. To alleviate both their concerns and what I have expressed above, I am wondering if an alternate location along McCartney between the street, baseball field, and playground has been considered. As for Towata, I think the concern over a lack of bathroom is irrelevant personally. Dog owners should be in the park watching their dog the entire time, not using the restroom. And since this will be a smaller neighborhood park for short term use, most users would likely live nearby and not have a need for bathrooms anyways. The Washington dog park will still be the destination dog park, where bathrooms are more important. And lastly, I appreciate the respect for the Towata family's original intent for the park, but I live near there now and it is far from what is described in the staff report. There really aren't any flowers to speak of and the park is entirely underutilized and underdeveloped currently.

Most importantly, thank you very much for your time! I recognize that it is impossible to please everyone in this, so I just wanted to say I appreciate your effort regardless.

Thanks so much for the update. I have to share my extraordinary disappointment and frustration that after more than a year of surveys, meetings, etc... ARPD has landed on a small location on Bay Farm that doesn't serve the primary purpose of the East End Dog Park community, namely, an East End location. Selecting a small location on Bay Farm (that may not even be available every day to all dogs) in lieu of locations such as Krusi park, which was heavily favored in the surveys, seems almost comical.

I understand that all of the East End locations required some element of compromise, and that there is a broader opportunity on Tilden, but that is many years away. In the meantime, we are left without off leash Dog facilities in the area that needed it most.

I sincerely hope that the commission reconsiders this approach and I look forward to the conversation on Thursday.

I am emailing you to share my thoughts against the proposed plans to add a dog park to leydecker park.

Leydecker park is the only nice, regulation size basketball court we have on the east end of Alameda. Even on weekdays you can find adults and children enjoying the courts, on weekends there are typically full 5 vs 5 games being played. Which is the only court on this end of the city that gets that amount of basketball players. Putting a dog a dog park next to it will diminish the quality of the park drastically. All other dog parks in alameda are dirty, smell and become very dry. What happens when a child's ball bounces into the dog park? What happens when dog poop is left all over the place (like the other dog parks) a long with the urine and that lead to a cleanliness issue when the ball goes over the fence and lands directly in it.

However my main concern is safety of the players enjoying the basketball court. Basketball courts need to be clean and have lots of grip in order to prevent injury. All the dog parks in Alameda are a dirt pit that gets dried out. That kind of environment next to a basketball court could cause major injury risk for our youth and adult basketball players. Any wind (which there's a lot of on bayfarm) will push the dry dirt onto the court and make a slick and unstable court. Which will definitely lead to injury and an environment that will make that court nearly unplayable for the avid basket player. Then the only courts our island will have that are nice will be at Washington park, which is a journey most of our youth will not make. Which will make the investment under armour and Stephen curry made into that court worthless.

If you value the cleanliness of leydecker park and value the safety of the youth in our community you will not put a dog park at the leydecker location.

Towata park on the other hand seems like a perfect location. It is a a park with no amenities that has lots of space. The dog park will attract more people to that beautiful location, without ruining any park amenities that are already there.

I just wanted to say thank you for continuing the efforts with the dog park. I unfortunately can't attend tonight's meeting due to personal circumstances, but wanted to let you know that (so far) 16 people have signed the petition in support of the Leydecker location on [eastenddogpark.com](http://eastenddogpark.com). Hopefully a number have also written to you directly.

I also wanted to send my own note for public comment:

"As one of the organizers of the East End Dog Park community group, with over 500 members who publicly support a dog park on the East End / Bay Farm side of Alameda, thank you for your continued efforts and consideration of this issue. I realize that in a space-constrained community like Alameda, there are many complexities when it comes to projects like this. I support the Leydecker location, as it will provide some much needed space for neighbors on Bay Farm who currently have no outlet for their dogs close to home. However, I also urge the Commission to continue to seek an additional location closer to the East End area of need. In the survey we conducted of our members, the strong preference was for locations that are walkable from the local neighborhood. Results indicated that residents located in 94501 (which comprise 62% of the group) would be very unlikely to utilize the Leydecker location, given that a car is still required and Main Street dog park is equidistant. The new Tilden location is hopeful, but potentially years away, leaving East Enders without a near-term solution. It also is not centrally located to the East End and would likely require driving for most folks, though in this case, there are other amenities (including Pet Food Express) that could make this requirement more appealing.

Again, thank you for all your efforts. The 500+ strong East End Dog Park group is ready to help advance this project in a way that can serve all members of the community.

Dear Director Wooldridge-

I am really looking forward to hearing the details tomorrow about the proposed dog parks, especially a potential (future) location off Tilden way! I am a dog owner, parks industry professional, and a regular commuter to Fruitvale BART, and I have frequently dreamt about that area becoming a park.

It was mentioned that this project might be part of a transportation initiative, so I wanted to pose the idea of an improved commuter corridor for pedestrians and bikes. Since I don't know what the city/county's plans are, it's possible these options or similar ones have already been considered. In any case, I wanted to share these ideas early in the process.

1) In addition to the potential for a dog park, the area adjacent to the shopping center would make an ideal linear pedestrian park, with linkages to the existing waterfront zone of the Nob Hill commercial plaza and the Fruitvale bridge.

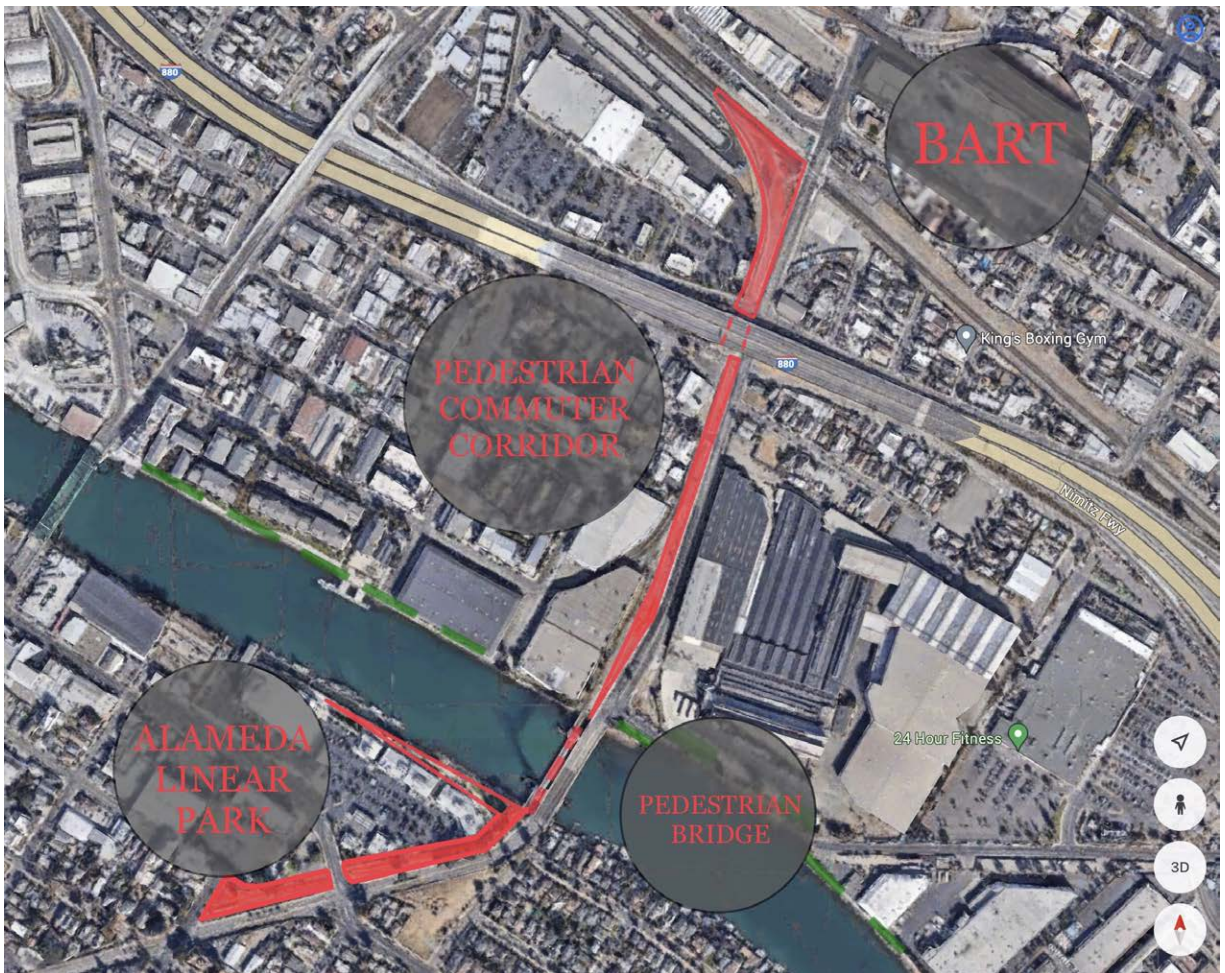
2) The park could be extended further west down Tilden to take advantage of the vacant area behind the mortuary and around what appears to be an old railway terminus.

3) On the north side, the old rail bridge could be converted to a pedestrian bridge which could also be of historical interest/value and link to the Oakland side of the corridor.



In the long run, a regional project to extend the corridor all the way to BART would yield real value to Alameda residents and commuters. Since this is an old rail line, the organization Rails to Trails may have some funding sources or other suggestions to offer.





I know how busy you must be and I really appreciate you having read this email. If the dog park or any other part of this project moves ahead, I'm happy to help in any way I can.
