I'd like to share some concerns about item 7-B on tonight's council meeting agenda. Voting to undo a unanimous council decision barely two years after it was made, with the same council in place, is really concerning. How can the public possibly trust you if, this evening, you vote for this suggestion from APD?

Due to staff inactivity and your failure to follow up, there has been no activity on oversight of APD since the council approved the subcommittees' recommendations back in March 2021. Just one month later, APD officers murdered Mario Gonzalez, a tragedy that one would think would spur serious inquiry and action on oversight measures! Still, nothing.

The single place you all have influence over operations at the police department is through this practice of policy change review. APD is totally unchecked otherwise. Let's be honest, Eric or Gerry, wasn't doing it (and no offence Nancy, but I doubt you are either). You five, as representatives of the residents of Alameda, are the last stop before unchecked power wielded by the police in our community. You made a responsible decision when you voted to have police policy changes come before you. In absence of any oversight body, civilian or otherwise, this practice must stay in place.

Please stay the course, avoid total hypocrisy, show commitment to good governance, and keep your promises to the values of our community so that we in turn can have confidence in your representation of us.

Dear Mayor, Vice Mayor, and Councilmembers,

I am disappointed to read in Item 7-B on your Sept. 20 agenda that APD is requesting the ability to update its policy manual on an ongoing basis without City Council approval.

Some of these policies may be minor ones. There may be administrative overhead in the process of having changes be considered by both APD staff and by City Council. However, there is value in bringing visibility and deliberation to these policing policies, both the minor policies and the potentially significant policies.

It's also all the more important for Alameda to have some public input from our elected officials given that these policies are produced by a company named Lexipol. It makes sense that the city isn't paying its own staff to write from scratch the policies. However, it would be a mistake to "automatically import and update" these policies from Lexipol without review and discussion by electeds or a board of community members that you designate.

Please read this Bloomberg article headlined "**Police Policy for Sale: Lexipol, a private for-profit company, has quietly become one of the most powerful voices in law enforcement policymaking in the country**" at <https://www.bloomberg.com/news/articles/2019-02-13/the-private-company-reshaping-american-police-policy>

And please take to mind the Alameda Police Reform and Racial Equity steering committee recommendation to (emphasis added at the end):

The City should hire a professional consultant to bring our Police Department's policies and procedures in line with contemporary best practices that are informed by the values of our community and include procedural justice. Professional engagement should focus on the following elements, (1) APD should require mental health and de-escalation training on an annual or semi-annual basis, (2) consideration of an Alameda Police Department Code of Conduct, and (3) *create a Police Policies and Procedures Review Board*.

If APD needs more staff resources or outside consultants to deal with the administrative burden of managing policies and taking updates through a public process, then please consider how to best address those constraints directly. Having thoughtfully crafted and updated policies for Alameda's police department is in the interest of everyone.
