I would once again like to reiterate that the streets of Alameda belong to everyone, not just the people who live on any particular street - no matter who their neighbors are or how much their house costs. During the last city council meeting on this item it was mentioned that protected bike lanes don't increase safety - they just slow down traffic. I would like to refer you to this article posted by the City of Pasadena that cites a Science Daily article in which it was confirmed that protected bike lanes not only make those streets safer for cyclists, but they make them safer for drivers and pedestrians as well due to the traffic calming effect.

From the article:

Fatalities fell by over 38% in Chicago, 40% in Denver, nearly 50% in San Francisco, 60% in Seattle, and a whopping 75% in Portland, OR. What these cities had in common were protected bike lanes. The researchers concluded that:

"...building safe facilities for cyclists is one of the biggest factors in road safety for everyone. Bicycling infrastructure -- specifically, separated and protected bike lanes -- leads to fewer fatalities and better road-safety outcomes for all road users."

I am certain tonight's meeting will include a lot of empassioned yet biased, uninformed, and frankly dangerous comments. The people complaining about slowing down traffic are the exact people we should be taking into consideration when we think about engineering safe streets for all users.

For the people complaining about the effectiveness and value of protected bike lanes (side note that a bike/ped safety focused city helps raise all our home values), the articles above are just a sliver of what's available to help you make the right decision if for some reason you are on the fence.

My family is counting on you to continue your great efforts to make Alameda a better place for everyone.

RE: Item 7B regarding proposed modification of Grand Street

Honorable Mayor and Councilmembers,

I am writing to suggest an alternative to the proposed modification of Grand Street currently under consideration.

The plan proposed for the modification of Grand Street appears to have been largely, though probably not exclusively, a result of cyclists advocating for enhancing their feeling of safety when travelling along this street. Unfortunately, the Staff's knee-jerk and in-the-box response has been to recommend and advocate for modifying the bike lanes and throttle the flow of motor vehicle traffic. This is unfortunate as the simpler and less disruptive solution would be to encourage cyclists to use the parallel streets - Union and/or Paru. There's no need to encourage the continued use of Grand. And switching to one of the parallel streets would be even safer than modifying Grand.

One or both of the parallel streets could be to designated as quiet streets. Afterall, isn't the enhancement of safety for cyclists and pedestrians the original argument put forward by Staff for imposing this designation on seemingly randomly selected streets in the first place?

There, of course, would have to be the incorporation of safety features such as flashing lights at selected intersections and crosswalks, optimizing signage, and, possibly the incorporation of traffic flow and/or pushbutton triggered traffic lights at selected intersections.

These are details that, for the most part, can be fairly easily worked out. In the event that this alternative plan turns out to be less costly than the current plan under consideration, the found funds might be used for the construction of a traffic circle at Otis and Grand.

The proposed alternative approach of using parallel streets for bike traffic is used in many cities, including Berkeley as one example. The alternative plan presented here would result in safer bike routes while at the same time allowing for the continued use of Grand Street as an avenue for crosstown motor vehicle traffic. This latter consideration becomes even more significant when we consider the limited routes available to us for crosstown evacuation in the event of one or more of the natural hazards that Alamedans may one day have to confront.

I would encourage Staff and the Council to think outside your usual box and stop using sledgehammers to drive finishing nails.

The last time Grand Street was on the Council agenda was June 21. BV was only hired as the consultant on July 5, well after that council meeting. As far as I know, no further outreach was done for the primary stakeholders of this project, which are of course, the actual residents of Grand Street who will be losing their curbside parking.

We are 20+ year residents of Grand Street, homeowners, pedestrians, cyclists, drivers, and parents of children who attended Franklin and Wood schools. We travel along and across Grand Street every day and we are writing to urge you to vote **NO** on the proposed plan for Grand Street. There are some positive aspects of the plan, but the overall concept will not achieve the goals of making Grand Street safer for all.

Currently, bike lane striping of any sort is virtually non-existent on Grand from Otis to Encinal; this proposal veers wildly in the opposite direction. A more balanced approach is needed here, one that boosts pedestrian and cyclist safety and also includes a robust plan for traffic enforcement other than simply narrowing traffic lanes & hoping drivers will slow down. Safety is a huge concern for everyone - people who oppose this plan and those who support it alike - and it centers on driver behavior. The City's Vision Zero and Active Transportations Plans promote safety for pedestrians and cyclists, but those goals will not be achieved without addressing motorist behavior.

As a reminder, this project was presented as a repaving and restriping project at the first town hall in December 2021. It then ballooned into a bike lane project for the second town hall in May 2022. Now, in the draft Active Transportation Plan we see that **all** of Grand Street is designated to have separated bike lanes. Have the residents of Grand between Encinal and the estuary been consulted/ advised about this? (Probably not.) There are more apartments and multi-family homes on that part of Grand, many with limited on-site parking. Residents in that area will be severely impacted if this plan is adopted, and will have less input on bike lane design if it's already in place between Otis and Encinal. This is a terrible procedural failure, and should be enough to halt this project as proposed.

In May, approximately 100 neighborhood residents signed a petition to express their opposition to this plan when it was presented to the Transportation Commission. Those concerns and objections are still valid

and should be taken into consideration when making your decision.

Thank you, Nuala Creedon & Matthew Anderson 924 Grand Street My name is Karen Miller and I do not live on Grand St so I am not directly impacted by this reconfiguration but I think it is poorly designed and does not take into account the impact on the residents that do live there. The proposed reconfiguration is based on an assumption that is incorrect and I believe to be dangerous. The original designers of the project show how great the site lines are getting out of the driveways all facing forward but anyone who lives on Grand parks headfirst into their driveway. When backing out of a driveway you do not have the same site lines. I do not see any modification in the final design that takes that into consideration. I'm wondering if these are the same designers who put the concrete lump at the new intersection at Sherman and Clement that continues to get hit everyday.

My bigger concern is the ADA component. The added accommodation of ADA parking spots is inadequate and unusable. Per the County Assessor's map, each of the blocks from Otis to Encinal are the distance of approximately 360' which is the same as an NFL football field. The proposed design has 5 ADA parking spaces all on side streets that could be a ½ a football field away from a residence with an additional 10' from the corner with the mandatory daylighting of each intersection with others being across the street adding another 40 feet. Anyone with a disability whether permanent or even temporary will have trouble navigating this distance to get to their car or a paratransit van. I can't imagine that a lawsuit won't be filed against the City if this plan is adopted. The average lot on Grand St has a frontage of 50' which can accommodate 2 cars parked in front of each home. With the average block having 10 homes, counting on both sides of the street, there is parking for 20 cars on a block. No one is objecting to losing some parking but the reduction from 20 to 3 is unreasonable. If you look at the current proposal on Grand between Dayton and Clinton the parking spaces go down to 1 on the East side and 2 on the West side of Grand. The next block between Clinton and San Jose has one on the West side and 1 or 2 on the East side. The only one on the West side happens to be next door to Mayor Ashcraft's home which is why I am asking that she recuse herself from this vote. I know that she had no part in this, but the optics are not good. The Council is in receipt of a letter signed by more than 100 residents of Grand expressing their support for a more traditional restriping of the existing lanes and adding more safety options for pedestrians which you seemed to discount at the first meeting. That is more than 100 votes against this plan. If you continue with the protected bike lanes up Grand, as advocated by the current Transportation plan, you will run into even more problems with the lack of parking as the homes have smaller frontages and many homes have no off-street parking. If it is not continued and goes to the striped lanes instead of the protected ones above Encinal, you will have created a protected road solely for the "Gold Coast" residents which also isn't a good look.

We all want safer streets for everyone but this plan is not it. Please go with the original plan of restriping and adding the proposed safety options at the intersections. Thank you.



If I understand correctly, there are no additional marked crosswalks nor any additional crosswalk signals. Finally, reducing the number of parking spaces will negatively impact access to homes by the elderly, home care attendants and other suppliers.

Dear Alameda City Council Members and Mayor Ashcraft:

Our family resides at 705 Grand Street, and I am very disappointed in the revised traffic plan. I urge you to vote NO.

I want to be clear that I am in favor of building a protected bike lane along Grand Street. That could easily be done with a bike lane painted green where the bike lane is placed now. Another option is creating a protected bike lane next to the curb with bollards and parking on the outside of the bike lane, like on Shoreline Drive.

The revised plan, is unnecessary and will create more problems than it solves.

Here are my observations about the plan and my objections to it:

- The plan does not address pedestrian safety Our biggest safety issues involve pedestrians at intersections:
 - There are no additional stop signs or speed bumps to slow traffic. Cars will be forced into two narrower lanes.
 - o The plan does not add more crosswalks beyond the four way intersections. Why not put crosswalks at both Dayton and Palmera? It is very difficult to cross Grand at those points. Many children now reside on our block, and even for an adult, crossing the street is a dangerous move. Cars often do not even slow down or stop for pedestrians.

- There is no discussion of enforcement of traffic safety by APD as part of the traffic safety solution.
- Where will delivery trucks park? They constantly stop and make deliveries along Grand Street. UPS, Fedex, and Amazon drivers will be constantly jaywalking across Grand Street

- The schematic shows a very narrow entrance to our driveway and the bike lane before crossing the sidewalk. This is unsafe. The visibility will be poor and backing out will be more of an issue than it is now.
- We will lose street parking in front of our house. Alameda is neither San Francisco or New York, and even there, zoned street parking is available for residents.
- This plan will impact the Fourth of July Parade. Almost every house on Grand Street hosts a party, and there are thousands of people walking up and down the street as well as the parade itself which utilizes the width of Grand Street.
- The addition of Handicapped Parking spots scattered on side streets is unhelpful. If we have a guest who needs a Handicapped Parking spot, they will have to somehow travel more than a block to get to our house. If there is street parking a dedicated handicapped parking spot is unnecessary

Protected bike lanes in Alameda are a great idea and can be constructed with less disruption to residents along Grand Street. Many other cities have taken similar measures with great success, and we should follow their lead.

I want the City of Alameda to seriously address pedestrian safety on Grand Street. This plan does not make pedestrian safety a priority, and does not include speed enforcement by APD.

Grand Street is a beautiful, historic residential street. Implementation of this plan as presented would be a mistake. We can do better.

I urge a NO vote on the revised plan for Grand Street.

Dear Alameda City Council Members,

I'm writing once again about the proposed changes to Grand Street. They are well intentioned, but for a variety of reasons not the best solution to address the most pressing issues on Grand Street, and not necessary to encourage increased cycling. The data shows that the biggest issues on Grand are pedestrian/auto accidents at intersections, followed by auto/auto accidents, due to speeding and driver inattention. Addressing these issues are not prioritized in the current plan. To encourage more people to walk rather than drive, pedestrian safety needs to be the top objective.

We also want to increase cycling in Alameda. This is possible without the extreme measures of the current plan. As in June, the Grand Street design question is presented as a binary choice between essentially the status quo on the one hand vs. the extreme current plan before you all on Tuesday evening.

This is a false dichotomy! There are a whole range of measures in between those two alternatives. Measures that would improve safety for pedestrians and cyclists, while not making such dramatic changes that negatively affect the usability and aesthetics of Grand Street for residents and visitors, especially those with mobility issues.

Here are the key reasons the current plan is highly problematic:

- <!--[if !supportLists]-->• <!--[endif]-->It will significantly reduce access to homes for visitors, care providers and people with disabilities.
- <!--[if !supportLists]-->• <!--[endif]-->It will result in unsafe street crossing mid-block—jaywalking—with likely increase in pedestrian incidents
- <!--[if !supportLists]-->• <!--[endif]-->It will make access and egress from driveways dramatically more difficult and unsafe to both cyclists and motorists.

There are many other measures which can provide safer and more comfortable bike lanes without limiting access and parking: we can narrow the traffic lane, widen the bike lane, and use bollards and armadillos to provide <u>protected bike lanes</u> in between the parking and traffic lanes. Other cities have taken similar measures.

No solution is perfect. Everything represents a compromise. The current plan unnecessarily over-rotates to provide separated bike lanes on part of Grand Street at the expense of usability and pedestrian safety. I ask you to redirect staff to come up with a more balanced proposal.

It's good to see how these plans have improved based on the constructive review at the last meeting. Thank you in particular to Mayor Ezzy Ashcraft and Vice Mayor Vella for useful directions, and thank you to staff who have managed revisions against what sounds like a tight schedule.

Based on my own experience traveling regularly through this area by all modes, I'm especially pleased to see that these plans include full protected bike lanes reaching Wood Middle School and Shore Line, and to also see increased pedestrian safety improvements planned for the San Jose intersection, not just the San Antonio intersection (both of which are important for students and families going to Franklin or St. Joseph's) It's also important to see that these plans have now been reviewed and improved by ADA consultants. I have lived on Grand Street for 21 years, have a son who went to Wood Middle School, and I am dismayed and perplexed at the proposals for Grand Street.

This started with Grand Street residents and Wood School parents trying to create a safer way for kids to get to school. We all signed a petition to try to make this happen. Then, all of a sudden, this issue is taken over by cyclists who want Grand Street to be a cycling path on the island.

I do not believe the current proposal addresses the issue of making Grand Street safer for kids to get to school. In fact, I believe the current plan will make it more dangerous for kids walking or biking to school. The barricades next to driveways will make it harder to pull onto Grand Street from our driveways. We won't be able to see pedestrians or bicyclists as well. The zig zag path in the proposal looks comically like an obstacle course rather than a safe road for travel. Limiting parking will make it harder to park our cars, and more difficult to merge safely into traffic. This plan raises more problems than it solves. It seems that Alameda's civil engineers were swayed by special interests without addressing what this would mean for the community as a whole. We need to ask ourselves what problem are we trying to solve for, and will this work?

As a 70 year old resident on Grand St, I am writing to plead for a more balanced plan for the Grand St reconfiguration proposal.

While safety for everyone is a concern, it appears that less expensive methods could more easily be enacted to reach that goal. Two ideas that come to mind, would be painting crosswalks across Grand between Otis and Encinal along with possibly the addition of a push button/blinking lights crosswalk at San Antonio. It would seem that an addition of a flashing speed limit sign would also help. widening the bike lane and installing bollards (not sure if that is the right word) would distinguish the area to make it more prominent or some type of raised dots (maybe colored) would make it more distinguishable.

The configuration as proposed seems to me, to be accidents waiting to happen as visibility of moving cars will be more limited as residents try to exit their driveways, across the bike path, between parked cars into a narrower lane. The same would be true trying to enter their driveways.

The presence of delivery trucks, garbage trucks, workers trucks with limited access to go around them will, I believe, be a hazard.

As for my situation, I don't have a driveway or garage, only street parking, meaning limited time/access (also dangerous) for entrance and exit into my car and I am not moving any faster as I age. Since I am often one of only a few cars on my side of the street, having my car out that far by itself, makes it a target for getting hit (already have one hit and run a few years back)

In checking police records of the last few years to find why Grand St is considered a "high injury corridor", I saw 4 vehicle incidents, 3 of which were at Otis and Grand AFTER the safety reconfiguration (plus another one last week)

Lastly, I don't see how reconfiguring 5 - 6 blocks would establish the North-South path that cyclists want, and that it will be have a distinct negative impact to all.

PLEASE reconsider options other than the proposed curb - bike lane- parked carsmoving cars arrangement for the safety of ALL

Hello All,

My name is Paolo Friedman and my wife Siam Peav and our three children live at 816 Grand St. I am hopeful that this message finds everyone in good health. Please forgive me if I have included anyone that is not part of the decision process for the changes the City is proposing for Grand St. but I am seriously concerned about the changes proposed in the "Final Concept".

Months ago, I signed a petition against the proposed bike lanes and its related removal of parking for a series or reasons. My understanding is almost every home on Grand St petitioned and yet it went unrecognized. I also reached out via email in the past but feel our voice was not loud and clear enough. I am more than certain that 100% of homeowners and renters from Shore Line to Encinal are opposed to the changes the City is planning as it drastically reduces parking and creates a daily hardship and safety risk for us as citizens of Alameda.

Just to reiterate some of my concerns: We have young children that will now have to cross streets against traffic to get to parked vehicles, which may end up blocks away given the slashing and burning of parking in the area. Last year the corner parking places were Red Zoned and reduced parking by Four (4) cars per block already. Our guests will have No convenient parking. My elderly mother and in-laws will be forced to battle traffic and parking. We will be backing out of our driveway across bike lanes and into traffic and with your plan there will be more noise and increased delays. I cannot find one positive in this plan. It is spendy, does not consider the homeowner's point of view and is inconvenient for everyone that lives on this stretch of Grand St.

I believe the City will find that the bike lanes that exist today are more than sufficient and really just need maintenance by a repaint/restriping. After that, study the improvement and if some traffic calming must be added, that is also a much less painful and far more financially sound approach than what is being proposed. The idea that the City has not even attempted to maintain what is there by repainting and instead is moving into what will be a safety risk for the actual people that live on this stretch on Grand is a misuse of tax dollars combined with direct punishment.

When we bought our house my wife and I had a few things on our wish list. Safety and parking were at the top of that list. The City's proposed plan is taking away two major reasons we moved to this house and paid not only top dollar to be here but extremely high property taxes as well. Additionally, as an incidental to the City's proposed change I contend that this will lower the desirability of our home and therefore the value.

In my experience working in public works construction throughout the Bay Area for more than three decades, the best plan is to separate motorist and bikers as much as possible and placement of bike lanes on parallel streets vs the streets that are most traveled by motorists is a standard public safety approach. Keeping both motorist and bikers safe without impacts to either. Let's remember a bike rider is treated as a hybrid vehicle/pedestrian and yet does not carry motorist insurance. Bikes weave in and out and go through red lights and are a cause of many accidents and yet the motorist is held responsible as the only one with insurance.

I am begging you not to move forward with this plan. Please reconsider re-painting the existing lane and see how it works. I know from experience that that alone will achieve a lot by clear delineation of bike and car lanes without sacrificing the reasons many of us live here.

Good morning Mayor Ezzy Ashcraft, Vice Mayor Vella, and Council Members Knox White, Daysog, and Spencer, and all the staff who have worked so hard to move this project forward.

I wanted to thank you again for endorsing the staff recommended plans for the Grand Street Improvement Project and encouraging staff to revisit the proposal to include/address the additional safety measures raised during the June 21st City Council meeting.

As we know, no project is ever perfect. But your dogged determination to bring this one as near to perfect as can be is much, much appreciated by me, my family, and the countless friends/neighbors/constituents who have spoken to me about the importance of this project's successful completion.

I am thrilled to see that staff will be returning to City Council on October 4th to present their updated plan which now includes:

- 1. Separated bike lanes between Otis Drive and Shore Line Drive (yeah!)
- 2. Appropriate access and usage by individuals with disabilities, as approved by the City's consultant (yeah!)
- 3. A public safety review, including by AFD, to ensure the final lane configuration is designed according to best practice and allows for emergency vehicle accommodations (yeah!)
- 4. Additional features to help slow speeds and improve pedestrian crossings (yeah!)

While I understand that this corridor is already in regular use, as it is the most convenient North/South passage in this part of town (or is it East/West?), I know that these added safety measures will provide a greater degree of confidence for all users, whether they be drivers, cyclists, or pedestrians, resulting in even more people (of all ages) choosing alternate modes of transportation than their car.

Approval of the staff recommended plan is a critical component for opening the door to additional street safety improvements that will create an interconnected system of projected bike lanes and help Alameda realize our Complete Streets Plan.
