AMENDING THE FISCAL YEAR 2022-23 GENERAL FUND OPERATING BUDGET TO TRANSFER \$167,000 FROM NON-DEPARTMENTAL TO THE POLICE AUDITOR DIVISION IN THE CITY ATTORNEY'S OFFICE

WHEREAS, on June 15, 2021, the City Council did adopt a budget representing the financial plan for conducting the affairs of the City of Alameda for the Fiscal Year beginning July 1, 2021 and ending June 30, 2023; and

WHEREAS, the adopted budget for fiscal year (FY) 2022-23 included an allocation of \$300,000 in General Fund – Non-Departmental for a Police Auditor function; and

WHEREAS, on November 1, 2022, City Council provided direction to establish a civilian police oversight program, through an Independent Police Auditor position reporting to the City Attorney; and

WHEREAS, staff is proposing to transfer \$167,000 from General Fund – Non-Departmental for setting up a new Police Auditor Division under the City Attorney's Office in the General Fund (ORG 10023044) in FY 2022-23, as follows:
