Pension/OPEB Reserve Policy

- The City commits half of the increase in the General Fund unassigned residual fund balance from the end of the prior fiscal year to advance pay-down of pension/OPEB obligations
- As of June 2022, half of the increase in the General Fund unassigned residual fund balance was \$2,812,896
- By policy, 75% of pension reserves, or \$2,109,672, would be paid to CaIPERS, and 25%, or \$703,224, would be contributed to a Section 115 trust for the future payment of pension expenses
