A few weeks ago early in the morning, my pick-up truck parked in front of the house was targeted by the out-of-control catalytic converter thieves. I'm still feeling angry and violated by their actions. Even worse, pickup trucks often have more than one converter installed – it turns out that my truck has 4 converters and the cost to replace them is horrendous. Plus it's not just the converters, but O2 sensors and other parts and labor came to over \$13,000, which is a pretty steep tab when it's not an expected or planned expense. To try and reduce a second occurrence, I had some additional protection installed for the new converters bringing the total to over \$15,000.

Vehicle crimes have gotten worse here. I support license plate readers in police cars to assist police in reducing the thefts of catalytic converters and other car thefts in Alameda, and to provide solid leads to help catch the criminals. This is a good opportunity to give the police effective equipment to help reduce the terribly expensive rash of thefts.
