Please find attached the following paper entitled: Pickleball Sound 103 - Mitigating Pickleball Sound - Is Pickleball Compatible with Residential Environments?

This paper was presented by Barry Wyerman and Robert Unetich (1 below), Pickleball Sound Mitigation LLC, 1811 Woodlands Circle, Pittsburgh, PA 15241 at the NOISE-CON 2023, co-located with the 2023 SAE Noise & Vibration Conference and Exposition, May 15-18, 2023

It is a very technical paper, 11 pages, so I will present its general conclusions:

"In general, pickleball courts less than 100 feet from a home will require extreme sound mitigation measures to be compatible with a residential environment.

Pickleball courts more than 100 feet from a home will require one or more sound mitigation measures to not be considered an annoyance.

At 1000 feet or more from a home, pickleball courts will not require any sound mitigation.

As the number of courts increases to meet the needs of avid pickleball players, acoustical engineers must consider these sound mitigation options for pickleball to be considered a good neighbor.

The authors gratefully acknowledge the pickleball players and the communities that have helped to evaluate and validate these strategies to achieve successful results for pickleball sound.".

This paper and its conclusions further support our position that pickleball does not belong at Krusi Park where there are 7 homes within 150 feet and 37 homes within 300 feet of the proposed multiple use pickleball courts.

Please make the right decision and take multiple use pickleball courts to Washington Park for the minimum disruption to residents..

Dear city of Alameda representative,

I would like to refer the Commissioners to acoustical expert, Lance Willis, PhD, Principal Acoustical Engineer of ,S&W Acoustics and Noise Control, Phoenix AZ who has worked on 9 pickleball projects.

He advises against changing over tennis courts to pickleball courts.

He states that pickleball courts located within 150 feet require careful abatement design to avoid complaints. InPickelball, a pickleball enthusiast magazine, he states "building a court with a setback of less than 150 feet from a residence is simply impractical, as the noise will certainly carry into homes," "Any court built within 350 feet of a house may need noise abatement."

Abatement treatments usually consist of freestanding 8 ft. walls above the playing surface.

Finally, he recommends that pickleball courts be located within 500 to 600 feet of residential properties to avoid ongoing disputes with neighbors.

This expert strongly supports our position that pickleball does not belong at Krusi Park where there are 7 homes within 150 feet and 37 homes within 300 feet of the proposed multiple use pickleball courts; and we are not aware of any noise abatement scheduled for the Krusi conversion.

The city of Alameda should follow this expert's advice and not convert the tennis courts at Krusi Park into multiple use pickleball courts. Thank you.

Dear city of Alameda representative,

Over the last two years, Nicholas Caplin, a founding partner at Lubin Pham & Caplin in Irvine, has represented members of more than 10 California residential communities with newly built or converted pickleball courts.

Caplin said that in case after case, the pickleball courts were ultimately found to have violated noise codes.

Legal claims against municipalities in California and across the country have forced similar resolutions, because volume levels associated with pickleball violate noise restriction ordinances for residential areas. The claims often result in "really ugly neighborhood drama," Caplin said, but people who live near the courts typically win out.
