AMEND THE FISCAL YEAR 2023-24 CAPITAL BUDGET BY DEFUNDING REVENUE AND APPROPRIATIONS IN THE STREET SAFETY CAPITAL IMPROVEMENT PROGRAM C61000 BY \$375,000, AND INCREASING REVENUE AND APPROPRIATIONS FOR THE TRAFFIC SIGNALS AND SYSTEMS CAPITAL IMPROVEMENT PROGRAM C13000 BY \$375,000.

WHEREAS, a total of \$2,000,000 is currently budgeted in the Street Safety Capital Improvement Project fund (CIP C61000) approved in the Fiscal Year (FY) 2022-23 Capital Budget; and

WHEREAS, to construct the Ralph Appezzato Memorial Parkway (RAMP) Intersection Modifications Project in calendar years 2023 and 2024, additional funds are needed in the Traffic Signals and Systems fund (CIP C13000); and

WHEREAS, the RAMP Intersection Modifications Project includes improvements to the signalized intersections along the Cross Alameda Trail between Wilma Chan Way and Main Street; and

WHEREAS, Resolution 15849 (Making Significant Safety Improvements to Alameda Streets in 2022 and Beyond to End Fatalities and Serious Injuries) identified the Cross Alameda Trail Safety Improvements, including improvements to the signalized intersections between Wilma Chan Way and Main Street, as a priority project to improve street safety in the City of Alameda; and

WHEREAS, the City Council appropriated a total of \$2,000,000 in General Funds currently budgeted in CIP C61000 Street Safety approved in the Fiscal Year (FY) 2022-23 Capital Budget; and

WHEREAS, staff proposes to reallocate \$375,000 from CIP C61000, Street Safety to CIP C13000, Traffic Signals and Systems, as follows:
