

City of Alameda Response to Bike Walk Alameda Correspondence

March 5, 2024

On February 13, 2024, Bike Walk Alameda provided a letter to the Mayor and City Council as part of the Mid-Year Budget Adjustment stating that some capital projects planned to begin or complete construction in 2023 had slipped. Letters referencing delayed projects were also provided to the Planning Board and Transportation Commission for their February 26 and 28 meetings, respectively. All letters included a link to a "Project Tracker" hosted on the Bike Walk Alameda website and included requests to expedite certain projects and programs in 2024.

This memo provides status updates on the projects and programs mentioned in the letters. It represents a small subset of the City's transportation work. For a status report on all transportation projects, see the Transportation Annual Report in Exhibit 1, page 65.

Status of Projects Marked "Delayed" in Bike Walk Alameda Project Tracker

The table below presents the status of each of the projects marked "delayed" by Bike Walk Alameda. All projects in Table 1 were listed in the 2023 Transportation Capital Projects Work Program map as "construction will begin or be completed in 2023."

Due to staff shortages and other constraints, these projects did not begin construction in 2023. Recent hires have allowed City staff to advance projects through to construction per the updated timelines below.

Status of Projects Bike Walk Alameda Recommended for Expediting

The Bike Walk Alameda letters to the Planning Board and Transportation Commission also included a series of recommendations for 2024 priorities. See the Transportation Annual Report in Exhibit 1, p. 65, for the full 2024 transportation work plan.

Neighborhood Greenways	Complete the conversion of all the Slow Streets slated to be Neighborhood Greenways. Staff note: this includes Pacific Ave, San Jose Ave, and Versailles Ave. (The Active Transportation Plan includes additional Neighborhood Greenways that aren't current Slow Streets and not all Slow Streets are slated to be Neighborhood Greenways.)	Design work did not begin in 2023 as planned due to staff shortages plus unanticipated staff needs, including: Estuary Water Shuttle planning, which unexpectedly required purchasing and retrofitting a boat; and the Grand St project, which required a new design, public engagement, and approval process. The 2024 Transportation Work Plan includes beginning construction to convert at least one Slow Street to a Neighborhood Greenway. This will require not only design work but community outreach. It will lay the groundwork for future Neighborhood Greenways, and if time allows, staff will pursue more than one conversion this year. However, several racks were maintained or replaced, all the City's shared-use electronic bike lockers were maintained, and planning was undertaken to add more on-street bike parking corrals along Park and Webster Streets, which will be installed in Summer 2024. While the City has approximately 2,300 bicycle parking spaces citywide, including 134 spaces in shared-use electronic bike lockers, and in six onstreet bike parking corrals, there is demand for more bike parking. Transportation Planning and Public Works staff will work in 2024 to develop a program to install at least 200 new bike parking spaces by the end of 2025. Additional racks are anticipated to be installed at City parks and with new development projects.	2025
