A few people have asked about writing to the City Council in order to support the request for the Council to direct staff to begin reviewing the six discussion points and report back to the Council as soon as practical. I have also been asked where to send the email.

When writing, please keep in mind that what we are asking for is to have the Council direct staff to:

begin reviewing the six discussion points and reporting back to the Council as soon as practical.

We are not asking them to adopt the six points, just authorize the staff to evaluate them and report back to the Council.

Here is a check list of things you might want to cover and some language you might want to use.

Points to cover:

Introduction of who you are (tenant or landlord), how long in Alameda, size of complex or management company.

Brief description of your participation in the process. I.e. attended public meetings, attended closed meetings, member of the focus group, etc.

Conceptual support for the five points and support for on going talks for point #6.

Affirmation that you wish to be *directly* involved with staff in the further development of these points.

Brief comment of support on the process that resulted in arriving at the six points including the opportunity to talk directly with tenants.

I am not looking for a compliment here, just an opinion on the process. Were people heard, many opinions considered, opportunity to talk directly with tenants, etc.

This is the language I am using in my presentation to the City Council in summarizing what we are trying to do. You are free to quote it directly.

The Community Discussion Project requests the City Council to direct staff to work on the further development of the six discussion points in order to:

• create an accurate and complete data recording process to document unreasonable rent increases, and

• provide a neutral and supportive forum where both tenants and housing providers can come together to collaborate and arrive at a mutually beneficial outcome. Please let me know if you will write a letter of support and how it will be delivered to the City.
