


Sewer System Overview

- City owns 128 miles of sewer pipelines and 34 pump stations
- Recent accomplishments
 - Replaced 13 miles of sewer pipelines in the last 5 years
 - Reduced sanitary sewer overflows
- More work required EPA Consent Decree
 - Sewer pipeline replacements (3 miles per year)
 - Pump station replacements
 - Condition assessment (cctv)
- Cleaning and repairs

Sewer Fund Finances

- Alameda's current sewer rates are low for the East Bay
- Last rate review in 2010 and issued sewer bonds in 2012
- Proposed rate increase: 3% annually for 5 years
 - Conduct sewer pipeline and pump station replacements to comply with the EPA Consent Decree
 - Keep up with inflationary cost increases
 - Long term financial stability
 - 70 cents per month increase effective July 1, 2015


